Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Allied Universal 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Allied Universal 401(k) Plan Notes to Financial Statements December 31, 2024 and 2023

1. Description of Plan

The following description of Allied Universal 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. The Plan was established effective January 1, 2000. The Plan covers eligible employees of Universal Services of America, LP and its affiliates (the "Company") who are at least 18 years of age and have completed 60 days of service. For certain matches governed by other contracts, the eligibility requirements are different or are waived. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Employees who are union members covered under a collective bargaining agreement, and are eligible to participate in a separate plan, non-resident aliens, or residents of Puerto Rico, are not eligible to participate in the Plan. Additionally, the Plan prohibits highly compensated employees, as defined for discrimination testing, from making elective contributions.

Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan document, for up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan

For administrative personnel only, the Company's matching contribution is 20 cents, 25 cents, and 50 cents for each dollar of a participants' pre-tax contributions, for participants with less than 10 years, greater than 10 but less than 19 years, and more than 19 years of service, respectively, not to exceed a total sum of 12% of the participant's compensation. For non-administrative employees, the Company offers a match if an employee meets certain requirements, such as holding certain primary jobs. Additionally, the Company, at its option, may make discretionary matching contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. There were no discretionary matching contributions for the year ended December 31, 2024.

A Prevailing Wage/SCA Contribution will be made on behalf of each Prevailing Wage/SCA Employee equal to the amount required by the prevailing wage requirements of the Service Contract Act or other governing contract or prevailing wage law. In addition, an additional retirement contribution will be made on behalf of each Prevailing Wage/SCA Employee equal to the amount required by the Service Contract Act or other governing contract.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, prevailing wage/SCA contributions and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. The standard vesting schedule is based on a 6 year schedule. In certain cases, other vesting provisions may apply (i.e. assets merged as part of an acquisition).

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. However, the amount of any new loan shall not exceed \$50,000, reduced by the highest outstanding loan balance of the participant during the preceding twelve months. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate, as determined by the Wall Street Journal on the first day of the month the loan is originated. If the loan is for the purchase of a participant's principal residence and the term is greater than 5 years, the interest rate is set at 1% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

Participants terminating employment with the Company will forfeit any non-vested employer contributions. Forfeitures will be used to pay reasonable plan expenses or reduce employer matching discretionary contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$541,619 and \$498,392, respectively. During the year ended December 31, 2024, \$275,240 of forfeitures were used to reduce employer contributions. During the year ended December 31, 2024, \$16,094 were applied to reduce plan expenses.

Investments

Each participant directs the allocation of his or her contribution, and employer matching and discretionary contributions to one or more of the investment options offered by the Plan. Participants may change their investment elections at any time as allowed by the Plan administrator.

Expense Budget Account

Pursuant to an agreement between the Plan and Massachusetts Mutual Life Insurance Company, an Expense Budget Account ("EBA") exists to capture monthly deposits of Contract Asset Charges or Investment Choice Fees. The account is used for the payment of authorized expenses. The deposits are included in the accompanying financial statements as dividends and expenses paid are included in administrative expenses. At December 31, 2024 and 2023, the EBA totaled \$256,977 and \$920,428, respectively. During the year ended December 31, 2024, \$103,200 of the EBA was used to pay administrative expenses.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are measured at quoted prices in an active market and have been certified complete and accurate by Reliance Trust Company and Empower Annuity Insurance Company of America, the custodians of the Plan. Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses incurred by the Plan are paid from the Plan's assets to the extent the expenses have not been paid by the Company. For the year ended December 31, 2024, administrative expenses of \$2,699,773 were paid for by the Plan. In addition, certain investment related expenses have been offset with net investment income and are not readily determinable.

Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through October 1, 2025, the date when the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments with respect to the Plan's investments in these funds. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fully Benefit-Responsive Investment Contract

The Plan holds an investment contract with Massachusetts Mutual Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The investment contract held by the Plan is summarized as follows:

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
- premature termination of the contract;
- Plan termination or merger;
- changes to the Plan's prohibition on competing investment options;
- bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- an uncured violation of the Plan's investment guidelines;
- a breach of material obligation under the contract;
- a material misrepresentation;
- A material amendment to the agreements without the consent of the issuer.

5. Information Certified by Custodian

No auditing procedures were performed by the independent registered public accountant, as permitted by 29 CFR 2520.103-8 of the Department of Labor's rules and regulations and disclosure under ERISA with respect to information certified as complete and accurate by the Custodian, except for comparing such information with the information reported in the financial statements. Based on the information provided and certified by the Custodian, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, for the years ended December 31, 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America, the custodian of the Plan, have certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, as well as the supplemental schedule of assets (held at end of year) as of December 31, 2024.
- Net appreciation in fair value of investments, interest income, and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

6. Party-in-Interest Transactions

Certain plan investments are managed by Massachusetts Mutual Life Insurance Company. Massachusetts Mutual Life Insurance Company is a subsidiary of Empower Annuity Insurance Company of America, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions for which a statutory exemption exists. The Plan pays administrative expenses to parties-in-interest who provide services to the Plan and for whom a statutory exemption exists. Additionally, notes receivable from participants and the related interest income are considered party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Tax Status

The plan document is a volume submitter profit sharing plan that received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designated and being operated in compliance with the applicable requirements of the IRC.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. With few exceptions, the Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. For the year ended December 31, 2024 and 2023, an investment represented a concentration of greater than 10% of the Plan's net assets available for benefits.
