Opinion

In forming our opinion on the supplementary schedule, we evaluated whether the supplementary schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following brief description of the Wilson Brown Motors, Inc. Employee Benefit Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was formed on January 1, 2019, and provides health benefits covering all eligible employees of a controlled group of companies including: Wilson Brown Motors, Inc., d/b/a Hanover Toyota, Inc.; Hanover Nissan, Inc.; Hanover Auto Team, Inc.; and Hanover Team, Inc., d/b/a Champion Mazda, which are collectively referred to as "the Company." The Plan is designed as an employee welfare benefit plan and subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended and restated on August 1, 2023.

Benefits: The Plan provides health benefits (medical, vision, dental and prescription drugs), life insurance, disability, critical illness and accidental death and dismemberment (AD&D) benefits. Benefits are provided to eligible employees, retirees, their spouses and eligible dependents. All regular full-time employees who work at least 30 hours per week are eligible to participate in the Plan after 30 days of employment. The waiting period is waived for employees transferring from a part-time position to the extent that they were already employed part-time. Only management employees are eligible to receive long-term disability benefits and must work at least 30 hours per week and complete 30 days of service to be eligible. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits: The Plan fully insures dental, life, vision, disability, critical illness and AD&D insurance benefits (basic, supplemental and dependent). The Company purchases annual insurance contracts for these insured benefits. Premiums are paid to the insurance company from the Plan.

Self-insured Benefits: Medical and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

COBRA - Consolidated Omnibus Budget Reconciliation Act: Generally effective for Plan years beginning on or after July 1, 1986, the Plan was required to offer continuation of benefits for a specified period of time to qualified employees and their dependents that would not otherwise be eligible for continued coverage because of a particular qualifying event as required by law. Each qualifying individual pays his/her premiums to COBRA Serve (a third-party administrator). COBRA Serve forwards the premiums collected the claims administrator who, in turn, forwards them to the Plan for deposit into the trust account, which are shown as participant contributions. COBRA claims and other COBRA expenses are paid from the custodial account.

Note 1. Description of the Plan (Continued)

Stop Loss Coverage: The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims in excess of the stop loss deductible, as well as its aggregate exposure for all claims). Premiums for stop loss reinsurance are paid by funds deposited in the Plan.

Contributions: The Company deposits to the Plan such amounts necessary for timely payment of all claims and reasonable administrative expenses of the Plan. The Plan is contributory with employees paying a flat rate for coverage for themselves and their dependents.

Administrative Fees: The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator. These expenses are reported on the Statement of Changes in Net Assets Available for Plan Benefits. All other administrative expenses, such as professional fees, may be paid by the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting which recognizes income as earned and expenses as incurred.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims (IBNR), claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Premiums paid by the plan are recorded as premium payments in the accompanying Statement of Changes in Net Assets Available for Plan Benefits. Claim payments are recorded when paid by the third-party claims processor.

Stop Loss: Premiums for stop loss insurance are included in premium payments to insurance carriers in the accompanying Statement of Changes in Net Assets Available for Plan Benefits. Stop loss reimbursements for 2024 totaling \$354,531 have been netted with claims expense in the accompanying Statement of Changes in Net Assets Available for Plan Benefits and Plan Benefit Obligations.

Estimated Liability for Claims Incurred but not Reported: The Plan's liabilities for claims incurred, but not reported as of December 31, 2024, were estimated by the Plan's claims processing administrator actuary. The estimate includes (1) unreported claims; (2) reported but unprocessed claims; and (3) processed but unpaid claims. Claim settlement expense liabilities are not included. A method is used that applies a factor (the reserve factor) to a credible best estimate volume measurement of paid claims. The calculation was performed for medical and prescription drug coverage. Due to the short nature of the reserve liability, time value of money was not used to discount future payments.

Note 2. Summary of Significant Accounting Policies (Continued)

Concentration of Credit Risk: The Plan maintains its deposits in one financial institution located in Pennsylvania. This deposit is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, the Plan's cash account may be in excess of the FDIC insurance limit.

Subsequent Events: In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through September 23, 2025, the date the financial statements were available to be issued.

Note 3. Cash, Interest-Bearing

Cash consists of an interest-bearing money market account with a bank that is used to fund claim payments and insurance premiums. Interest income is recorded on the accrual basis.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the remaining assets will be applied in a uniform and non-discriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or used for any other purpose other than the exclusive benefit of the Plan participants.

Note 5. Tax Status

The Plan is not exempt under any current section of the tax code. The Plan is funded through Veris Benefits Consortium, LLC Trust. The Veris Benefits Consortium, LLC Trust is included in the U.S. Income Tax Return for an S Corporation Form 1120S of the third-party administrator of the plan. Plan management believes the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Related Party Transactions and Party-in-Interest Transactions

The Plan has administrative arrangements with third party service providers. These transactions are party-in-interest transactions under ERISA.

Note 7. Risks and Uncertainties

Benefit Obligations: The Plan's estimate of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
