## INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of  
Certified Group 401(k)**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Certified Group 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

# CERTIFIED GROUP 401(K)

## *NOTES TO FINANCIAL STATEMENTS* *DECEMBER 31, 2024 AND 2023*

---

### 1. DESCRIPTION OF PLAN

The following description of Certified Group 401(k) (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was established effective January 1, 2005, and was most recently restated effective July 16, 2021 and amended as of June 28, 2024 to reflect the change in Plan trustee discussed in Note 3.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and covers all employees of Food Safety Net Services, Ltd. and its affiliated companies (collectively the “Company”), except for union employees, nonresident aliens, residents of Puerto Rico, interns, temporary employees, leased employees, and seasonal employees. Employees are eligible to participate in the Plan upon attainment of 18 years of age and the completion of 3 months of service, as defined. Employees may enter the Plan on the first day of the month coincident with or following satisfaction of the eligibility requirements.

#### **Contributions**

The Plan allows for both pre-tax and Roth salary deferrals. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. The Company makes QACA safe harbor contributions in an amount equal to 100% of the participant's elective deferrals that do not exceed 4% of the participant's compensation, as defined. For the year ended December 31, 2024, QACA safe harbor contributions totaled \$1,898,628, net of forfeitures. The Company, at its discretion, may also elect to make matching contributions and non-elective contributions to the Plan. The Company did not make any discretionary matching contributions or discretionary non-elective contributions to the Plan for the year ended December 31, 2024.

The Plan includes an automatic enrollment feature under which newly eligible employees are automatically enrolled to make pre-tax contributions into the Plan at a rate of 6% of compensation, as defined, and their accounts under the Plan are automatically invested in the Plan's Qualified Default Investment Alternative (“QDIA”), unless the employee elects otherwise. The Plan has elected the American Funds Target Date Retirement - R6 series funds as its QDIA. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's QACA safe harbor contributions, the Company's discretionary matching contributions, if any, as well as an allocation of the Company's discretionary non-elective contribution, if

any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's QACA safe harbor contributions, discretionary matching contributions and discretionary non-elective contribution portions of participant accounts is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 2	0%
2 or more	100%

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The interest rate on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants are entitled to receive in-service withdrawals upon attainment of age 59 ½ or as a hardship distribution, as defined in the plan document.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$31,187 and \$495,192 respectively. Forfeitures, if any, are used to reduce future employer contributions or pay administrative expenses of the Plan. During the year ended December 31, 2024, the Plan used \$794,715 of forfeitures to reduce employer contributions of the Plan. During the year ended December 31, 2023, the Plan used \$81,841 of forfeitures to pay administrative expenses of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investment includes the plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and employer contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

#### **3. CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value, investments at contract value, unallocated cash and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Trust Company ("TTC"), Reliance Trust Company ("RTC"), and Transamerica Financial Life Insurance Company ("TFLIC"), the trustees and insurance company of the Plan, respectively.

Effective June 28, 2024, TTC succeeded RTC as Trustee of the Plan. As such, TTC's certification covers as of December 31, 2024 and for the period June 29, 2024 through December 31, 2024. RTC's certification covers as of December 31, 2023 and for the period January 1, 2024 through June 28, 2024. TFLIC's certification covers as of December 31, 2024 and 2023 and the year ended December 31, 2024.

#### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth, by level within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

For the year ended December 31, 2024, there were no significant transfers between Level 1 and 2 and no transfers into or out of Level 3.

#### **5. GROUP ANNUITY CONTRACT WITH TRANSAMERICA FINANCIAL LIFE INSURANCE COMPANY**

Effective May 12, 2021, the Plan entered into a fully benefit-responsive guaranteed investment contract with Transamerica Financial Life Insurance Company (“TFLIC”). TFLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by TFLIC, represents contributions made under the contract, plus credited interest and transfers into the investment contract, less participant withdrawals, transfers out of the investment contract and administrative expenses, if any. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,792,436 and \$2,078,995, respectively. The crediting interest rates are reviewed on a semi-annual basis for resetting. There is no minimum guaranteed interest rate under the Contract.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan’s ability to transact at contract value with TFLIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a)

an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Either TFLIC or the Plan sponsor may terminate this Contract subject to certain conditions, as defined, upon advance written notice to the other party.

#### **6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Transamerica is the Plan's recordkeeper and therefore certain transactions qualify as party-in-interest transactions. Administrative fees of approximately \$88,500 were paid to Transamerica from the Plan during the year ended December 31, 2024.

Bank of America ("BOA") was the Plan's former investment advisor and therefore certain transactions qualify as party-in-interest transactions. Administrative fees of approximately \$14,600 were paid to BOA from the Plan during the year ended December 31, 2024.

NFP Retirement, Inc. is the Plan's investment advisor and therefore certain transactions qualify as party-in-interest transactions. Administrative fees of \$30,000 were paid to NFP Retirement, Inc. from the Plan during the year ended December 31, 2024.

Participant contributions not transmitted by the Company within the time period set forth in the Department of Labor's regulation CFR 2510.3-102 are considered nonexempt prohibited transactions under ERISA. Participant contributions remitted during the year that constitute nonexempt prohibited transactions are reported by the Plan in the accompanying supplemental schedule as required.

#### **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **8. TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

#### **10. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.
