## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
Third Dimension, Inc. 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Third Dimension, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTES TO FINANCIAL STATEMENTS**

**A. DESCRIPTION OF PLAN**

The following brief description of the Third Dimension, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering all full-time employees of Third Dimension, Inc. (the "Company"). The Plan was established effective January 1, 2014 as a profit sharing plan with a cash or deferred arrangement qualified under section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2024, the Plan was restated to comply with the Bipartisan Budget Act of 2018 and final regulations relating to hardship distributions. The restatement also separated the trust agreement from the plan document. The restated Plan is based on a pre-approved non-standardized cash or deferred profit sharing plan document provided by Siegel Actuarial Consulting, Inc. The Internal Revenue Service ruled on June 30, 2020, that the pre-approved non-standardized cash or deferred profit sharing plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Company also added the ability for participants to make after-tax Roth deferral contributions.

*Participation Requirements*

All full-time employees are immediately eligible to participate for voluntary 401(k) and employer matching provisions, and begin active participation semiannually, on either January 1 or July 1. For employer discretionary non-elective contributions, employees must have completed 1000 hours of service to receive an allocation.

*Contributions - Participant*

The Plan allows participants to make voluntary contributions to the Plan, by entering into a salary reduction agreement with the Company for up to 100% of their annual compensation, as defined, subject to the maximum permitted by the Internal Revenue Service (IRS). The Plan also allows participants who have attained age 50 before the end of the plan year to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**A. DESCRIPTION OF PLAN (Continued)**

*Contributions - Employer*

During the period from January 1, 2020 through May 14, 2020, as required by the Plan, the Company made safe harbor matching contributions in an amount equal to 100% of voluntary 401(k) contributions up to 4% of a participants' eligible compensation, as defined. Effective May 15, 2020, the Company amended the Plan to discontinue the safe harbor matching contributions and allow matching contributions on a discretionary basis in an amount equal to 100% of voluntary 401(k) contributions up to 4% of a participants' eligible compensation. Discretionary contributions were made from October 16, 2020 through December 31, 2020. Effective January 1, 2021, the Company amended the Plan to reinstate the safe harbor matching contributions up to 4% of a participants' eligible compensation, as defined. All contributions are subject to the limitations imposed under IRC Section 404(a)(3)(A). Participants direct the investment of their contributions into various investment options offered by the Plan.

*Funding Policy*

The employer shall, within the time period and manner permitted by the Internal Revenue Code, remit to the custodian an amount equal to the sum of the elective deferral contributions and the employer contributions.

*Participants' Accounts*

In accordance with the terms of the Plan, the account of each participant is maintained on a market value basis. Each participant's account consists of the contribution made on his/her behalf by the Company, his employee elective deferral contributions, his employee rollover contributions, and his share of investment income or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Investment of Contributions*

Participant contributions and employer contributions are invested by the Plan's custodian as directed by each participant, in one or more of the Plan's investment options, which are stated separately in the accompanying supplemental schedule. Earnings, interest, and dividends received from investments in each fund are allocated to participants' accounts based on the participants' account balance in relation to the entire fund balance and are reinvested in the fund.

**A. DESCRIPTION OF PLAN (Continued)**

*Vesting*

Participants in the Plan are 100% vested in their contributions, all employer safe harbor matching contributions, and any earnings thereon. For employer discretionary non-elective contributions, participants are vested at a rate of 20% per year after completing one year of service.

*Payment of Benefits*

Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum distribution. If the participant's account balance is between \$1,000 and \$5,000, the plan administrator may direct the custodian to make an automatic rollover of the account balance to a qualified individual retirement account if the participant has not designated an account. If the participant's account balance is less than \$1,000, the plan administrator may direct the custodian to make a lump sum distribution. Participants terminated for reasons other than death, disability, or retirement, are entitled to receive their benefits as soon as administratively feasible. Distributions of a participant's 401(k) account balance may be authorized at any time by the plan administrator under certain hardship conditions.

*Forfeited Accounts*

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are utilized to pay administrative expenses, reduce future employer contributions, or to increase supplemental employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,380 and \$2,979, respectively. No forfeitures were utilized during the years ended December 31, 2024 and 2023.

*Investment Elections*

Each participant may direct their salary reduction contributions and Company contributions to be invested in one or more of the various investment fund options offered under the Plan. The custodian of the Plan is the Capital Bank and Trust Company. The Plan currently offers mutual funds as options for participants.

*Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant would have a non-forfeitable right to his or her total account balance as of the date of termination.

**B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

*Basis of Accounting*

The accompanying financial statements and supplemental schedules are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Investments*

All of the Plan's assets were held in trust by the Plan custodian, Capital Bank and Trust Company. Mutual funds are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year-end. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation or depreciation in the fair market value of its investments which consists of any realized gains or losses and any unrealized appreciation or depreciation on those investments.

*Administrative Expenses*

Certain expenses incurred in connection with the Plan are paid by the Plan and are recorded in the accompanying Statement of Changes in Net Assets Available for Benefits. Certain administrative expenses not paid by the Plan are paid by the Company and are not reflected in the accompanying financial statements.

*Risks and Uncertainties*

The Plan's investments include investments in mutual funds with varying degrees of risk, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the dates of the financial statements and the reported amounts of changes in net assets available for plan benefits during the reporting periods. Accordingly, actual results may differ from those estimates.

*Benefit Distributions*

Benefit distributions are recorded when paid to participants.

**C INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedules has been certified to the Plan administrator by the Plan's custodian: Statement of Net Assets Available for Benefits – Investments at fair value; Statement of Changes in Net Assets Available for Benefits – Net appreciation in fair value of investments and Interest and dividends; and Schedule H, Line 4i - Schedule of Assets Held at December 31, 2024 – all information. As directed by the Plan administrator, no auditing procedures have been performed on this information except to compare such information to the information included in the accompanying financial statements and the supplemental schedules.

**B. FAIR VALUE MEASUREMENTS**

ASC Topic 820 provides a definition of fair value which focuses on an exit price rather than an entry price, establishes a framework for measuring fair value which emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and requires expanded disclosures about fair value measurements. In accordance with FASB ASC 820-10, the Plan may use valuation techniques consistent with the market, income, and cost approaches to measure fair value. As a basis for considering market participant assumptions in fair value measurements, ASC Topic 820 establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair values. The hierarchy gives the highest priority to Level I measurements and the lowest priority to Level III measurements. The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level I: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level II: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- Level III: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**D. FAIR VALUE MEASUREMENTS (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial instruments are defined as cash, evidence of ownership interest in an entity, or a contract which creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the estimated fair value would be calculated based upon the market price per trading unit of the instrument.

Investments in mutual funds would be considered financial instruments. At December 31, 2024 and 2023, the carrying amounts of these financial instruments approximate fair value.

**E. TAX STATUS**

Effective January 1, 2024, the Plan is based on a prototype non-standardized document provided by Siegel Actuarial Consulting, Inc. The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the prototype non-standardized document is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**F. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts in the Statements of Net Assets Available for Benefits.

**G. PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are mutual funds in which Capital Bank and Trust Company is the advisor of the funds and custodian to the Plan. Transactions in these investments are allowable party-in-interest transactions under Section 408 of ERISA.

**H. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available to be issued.
