NOTES TO FINANCIAL STATEMENTS**

Note 1 - Plan Description

The following description of the SESCO Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information.

General

SESCO Lighting, Inc. (the Company) established the Plan, effective as of January 1, 1996, and restated the Plan effective January 1, 2018. The Plan operates as a non-leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7), and the regulations thereunder, of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by Carpenter Morse Group as of December 31, 2024 and 2023. The trustees of the Plan are three individuals appointed by the Board of Directors of the Company. The Plan holds 100 percent of the Company's common stock at December 31, 2024 and 2023.

Eligibility

Employees of the Company are eligible to participate in the Plan once they have completed one year of service in 12 consecutive months (represented by completing not less than 1,000 hours of service). Participants who do not have at least 1,000 hours of service during a Plan year or are not employed on the last working day of a Plan year, unless for reasons of death, disability, or retirement, are generally not eligible for an allocation of Company contributions for such year. Employees covered by a collective bargaining agreement, leased employees, and non-resident aliens without United States income are not eligible to participate in the Plan.

Employer Contributions

Employer contributions may be paid in cash or shares of Company stock and are determined annually at the discretion of the Company's Board of Directors. The Company makes contributions necessary to pay related distributions and Plan expenses. Contributions are subject to limitations as set forth in the IRC.

Payment of Benefits

Benefits can be paid with either cash or employer securities. Payment of benefits upon termination of service, retirement, disability, or death where a participant has an account balance exceeding \$200,000 will be made in equal annual installments over a period of three years. Participants with account balances of \$120,000 to \$200,000 will receive distribution of benefits in equal annual installments over a period of two years. Participants with account balances less than \$120,000 will receive distribution of benefits in a single lump-sum payment. Distributions due to retirement, disability, or death will commence as soon as administratively feasible following separation of service beginning no later than one year after the close of the Plan year in which the event occurred. Distributions due to termination from service for other reasons will commence as soon as administratively feasible following the year in which employment is terminated.

Administrative Expenses

The Company pays all expenses in connection with the design, establishment, and termination of the Plan. The Plan pays all other costs of administering the Plan unless such expenses are paid by the Company. Expenses that are paid by the Company are excluded from the financial statements. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

Plan Termination

The Company reserves the right to terminate the Plan at any time subject to Plan provisions. In the event the Plan is terminated, incurs a partial termination, or upon complete discontinuance of contributions under the Plan by the Company, the rights of each participant to his or her account on the date of such termination or discontinuance will become non-forfeitable and the interest of each participant in the trust fund will be distributed to such participant, or his or her beneficiary, at the time prescribed by the Plan terms and the IRC.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of the Company's contributions and an allocation of forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company, as of the last day of the Plan year, will receive an allocation. Plan earnings are allocated to each participant's account based on account balances. Allocations of contributions, forfeitures and expenses are based on a participant's eligible compensation, relative to total eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Upon attainment of normal retirement age, disability, or death, participants will be 100 percent vested in the amounts in their accounts. For any reason other than the aforementioned, participants will vest in their account balances based on total years of service with the Company as follows:

Voting Rights

The trustees of the Plan hold the voting rights on all Company stock held by the Plan. However, participants are entitled to direct the trustees of the Plan to vote those shares allocated to the participant's account on such matters as approval or disapproval of corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions prescribed by regulation. The trustees are permitted to vote any unallocated shares held by the Plan as well as any allocated shares for which a participant has failed to give timely voting instructions.

Put Option

Under federal income tax regulations, employer stock held by the Plan and its participants that is not readily tradable on an established market or is subject to trading limitations must include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to a participant during a 60-day period, as defined, or, if the put is not exercised within such 60-day period, it will be exercisable for an additional 60-day period in the next Plan year. The Company can pay for the

purchase of the stock in either a single payment or five equal annual installments with interest set at a reasonable rate, as determined by the Company's Board of Directors. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash for shares owned.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. The shares of the Company stock elected to be diversified by the participant will be either distributed directly to the participant or invested in one or more of at least three alternative investment options available under the Plan, as directed by the participant.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024, totaled approximately 90 shares for \$22,372.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash Concentration

Cash is maintained in a bank deposit account and, at times, may exceed federally insured limits. The Plan places its funds with a high credit quality financial institution and does not believe it is exposed to any significant credit risk on cash.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion and disclosure related to fair value measurements.

Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends, if any, are recorded on the ex-dividend date.

Payments of Benefits

Benefit payments are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, which is the date the financial statements were available to be issued. No material events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.

Note 3 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated March 22, 2017, stating that the Plan is qualified, under the IRC and, therefore, the related trust is exempt from taxation. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, as of December 31, 2024, there are no audits for any tax periods in progress.

At December 31, 2024 and 2023, all of the shares of common stock held by the Plan have been allocated to participant accounts.

Note 5 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

■ **SESCO Lighting, Inc. Common Stock**

The fair value of the SESCO Lighting, Inc. common stock held by the Plan is determined based upon an independent appraisal. This value of the stock is based upon a combination of the asset, market and income valuation techniques and includes a discount for lack of marketability consistent with prior years. The appraiser considered historical and projected cash flows and net income, return on assets, return on equity, market comparables, and the estimated fair value of Company assets and liabilities. This data was compiled from the Company's financial statements and management's projections as well as other industry and economic data. The fair value of the Company's stock at December 31, 2024 and 2023, was \$248.33 and \$243.87 per share, respectively.

The appraisal policies and procedure are reassessed at least annually to determine if the current valuation techniques remain appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the Company's common stock could result in a different fair value measurement at the reporting date.

Note 6 - Related-Party and Party-in-Interest Transactions

The Plan’s investments consist entirely of common stock of the Company, a related-party. During the year ended December 31, 2024, total fees of \$50,404 were incurred by the Plan for services provided by the Plan’s administrator, independent appraiser, and independent auditor, which qualify as party-in-interest transactions.

Note 7 - Risks and Uncertainties

The Plan’s investment consists of the Company’s common stock, which is exposed to various risks, such as interest rate, credit, and overall market volatility, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the Company’s common stock and to uncertainties inherent in estimates and assumptions, it is reasonably possible that changes in the value of the Company’s common stock will occur in the near-term and that such changes could materially affect the participant account balances and the amounts reported in the statements of net assets available for benefits.


