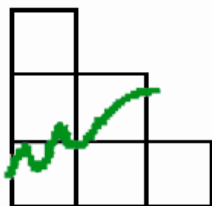

## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the CWR Industries, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of CWR Industries, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of CWR Industries, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of CWR Industries, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CWR Industries, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

• **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the CWR Industries, Inc. 401(k) “Plan” provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- 1) *General*: The Plan is a defined contribution plan adopted January 1, 1999, covering all full-time employees of CWR Industries, Inc. (“Company”) who have six months of service and are 18 years or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee oversees governance of the Plan.
- 2) *Contributions*: Each year, participants may contribute up to \$23,000 in 2024 (thereafter as adjusted by the Secretary of Treasury) as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and an insurance investment contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation. Contributions are automatically invested in a balanced fund until changed by the participant. The Company contributes 100% of the first 6% of base compensation that a participant contributes to the Plan. Contributions are subject to certain statutory limitations. The matching Company contribution is directed by the participants on the same basis as their own contributions.
- 3) *Participant Accounts*: Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and (b) Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- 4) *Vesting*: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after two years of credited service through May 31, 2017. As of June 1, 2017, all new eligible employees are 100 percent vested after four years of credited service.
- 5) *Note Receivable from Participants*: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The notes are secured by the balance in the participant’s account and bear interest rates ranging from 5% to 10%, which commensurate with local

prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

- 6) *Funding Policy*: It is the policy of CWR Industries, Inc. 401(k) Plan to fully fund all participant accounts as required by ERISA. Participant contributions and employer matching contributions are funded as soon as possible at the end of each pay period.
- 7) *Payment of Benefits*: On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may elect a systematic withdrawal plan (installment plan).
- 8) *Forfeitures Accounts*: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$68,743 and \$16,929, respectively. These accounts will be used to reduce further employer contributions. Also, in 2024, employer contributions were reduced by \$16,928 from forfeited nonvested accounts.
- 9) *Administration Costs*: Administration costs are currently being paid by the Plan from their forfeiture account.
- 10) *Plan Termination*: Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

- 1) *Basis of Accounting*: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

- 2) *Investment Valuation and Income Recognition:* Investments are reported at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

- 3) *Use of Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan & administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes there in and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.
- 4) *Payment of Benefits:* Benefits are recorded when paid.
- 5) *Date of Management's Review:* Subsequent events were evaluated through September 22, 2025, which is the date the financial statements were available to be issued.
- 6) *Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.
- 7) *Expenses:* Certain expenses of maintaining the Plan are paid by the Company and therefore are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.
- 8) *Excess Contribution Payable:* Amounts payable to participants totaling \$12,012 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2024 participant contributions. The Plan did not distribute the 2024 excess contributions prior to March 15, 2025. The Company has paid the excise tax that was imposed for not distributing the excess contributions in a timely manner. The excess contributions for the year ended December 31, 2023 were \$5,791.

**NOTE 3 – CERTIFIED INVESTMENTS**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained from management and agreed to or derived from information certified as complete and accurate by Talcott Resolution Life Insurance Company (the trustee of the Plan).

**NOTE 4 - TAX STATUS**

The Plan participated under the Great-West Trust Company, LLC Defined Contribution Pre-Approved Plan. The Internal Revenue Service (IRS) has determined and informed the Great-West Trust Company, LLC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - CONCENTRATION OF CREDIT RISK ARISING FROM INVESTMENTS IN UNINSURED ACCOUNTS**

The Plan's investments are currently held with Talcott Resolution Life Insurance Company. These funds are uninsured and are not guaranteed. The value is based on current market value that varies daily. The availability of funds is based on the financial strength of the pooled separate accounts and insurance company. Uninsured balances total \$12,622,978 and \$10,989,282 at December 31, 2024 and 2023.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques

based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented and there are no changes in the methods used to measure fair value at December 31, 2024 and 2023.

*Level 2 Fair Value Measurement*

The fair value of pooled separate accounts is valued daily using inputs that are derived principally or corroborated market data by correlation or other means. The fair value of the pooled separate accounts is based on the market value of its underlying investments, which have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers of investments between and into and out of Level 3 as of the dates of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers into or out of Level 3.

**NOTE 7 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Fees paid by the Plan for investment management services to Empower Annuity Insurance Company were \$3,961 for direct services for the year ended December 31, 2024. Owner/employees and management participate fully in the plan within plan limitations due to high compensation. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 8 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

On December 1, 2022, the Plan entered into a benefit-responsive investment contract with Talcott Resolution Life Insurance Company (Talcott Resolution). Talcott Resolution maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Talcott Resolution, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,181,203 and \$1,270,939, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Talcott Resolution. Such events include the following: (a) amendments to the plan documents (including

complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (c) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuers consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associates with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
