#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Visual Data Media Services, LLC 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits [and of accumulated plan benefits] as of **December 31, 2024 and 2023**, and the related statement of changes in net assets available for benefits [and of changes in accumulated plan benefits] for the year ended **December 31, 2024**, and the related notes to the financial statements.



**1. DESCRIPTION OF PLAN**

The following description of the **Visual Data Media Services, LLC (the Company) 401(k) Plan (the Plan)** provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan to provide a retirement savings program for the eligible employees of the Company. The Plan was established on February 1, 2012, and has been restated or amended several times, the latest being in January 2020, to make certain changes and enhancements to the Plan.

The Plan is intended to be qualified under Section 401(a) of the Internal Revenue Code of 1986 (the Code), as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Trustees and Administrator of the Plan**

The Plan's investments are held by Ascensus Trust Company (parent company Ascensus, Inc.), the trustee/custodian, and Ascensus, LLC provides Plan administration and recordkeeping services for the Plan.

The Plan is administered by the Company, Visual Data Media Services, LLC, with compliance and other advisory services are performed by a third-party administration firm. The officers of the Company oversee governance of the Plan.

**Eligibility**

The Plan is a defined contribution plan covering all employees of the Company who are aged 18 or older. There is no service requirement. Upon meeting the eligibility requirements, employees are eligible to enter the Plan on the first of the month after completing the respective eligibility requirements.

**Plan Contributions**

Contributions to the Plan are made through employee contributions, including catch-up contributions, Company contributions, and participant roll over contributions.

- *Employee Contributions* - Each pay-period eligible employees may elect to contribute a percentage or dollar amount of their eligible contributions on a pre-tax basis, after-tax basis (ROTH) or a combination of both to the Plan subject to the limits of the Internal Revenue Service.
- *Employee Rollover Contributions* - Participants eligible for a withdrawal from another eligible retirement plan or traditional IRA may roll over all or part of that amount into the Plan.
- *Employer Matching Contributions* - The Company matches 50% for every 1% of employee contributions, up to 6% of eligible compensation deferred to the Plan. The maximum Company employer match contribution is 3% of eligible compensation. Participants must complete 1 year of service and work a minimum of 1,000 hours to be eligible to receive any employer matching contributions. The matching contributions made to the Plan for the year ended December 31, 2024 totaled \$182,801.

**Plan Contributions (contributions)**

- *Employer Profit Sharing Contributions* - At the discretion of the Board of Directors, the Company can make profit-sharing contributions, which are also participant directed. Participants must complete at least 1,000 hours and 12 months of service during the Plan year and be employed as of the last day of the Plan year, to be eligible to receive any profit-sharing contributions. There were no profit-sharing contributions for the year ended December 31, 2024.

**Investments**

Participants can direct the investment of their accounts (including employee and Company contributions) among various investment options offered by the Plan. The Plan offers a selection of mutual funds and common collective trusts offered by Vanguard, as administered by Ascensus Trust Company, as investments options for the participants.

**Participant's Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings are charged with an allocation of plan fund administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. A participant is also 100% vested upon normal retirement age, death, or disability.

**Notes Receivable from Participants**

Participants can borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 reduced by the highest outstanding loan balance during the prior twelve months or 50% of their vested account balance, whichever is less. The Plan does not allow for loans to be taken against ROTH deferrals and only one outstanding loan is permitted at a time. Loan terms generally may not exceed 5 years, and the administrator will compute the interest rate using the prime rate (as specified in the Wall Street Journal) plus 0% and are secured by their account balance. Fees associated with the origination of the loan are paid directly by the Plan participants. Interest rates range from 3.50% to 8.50% annually. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination, death, disability, or retirement, a participant's account will be distributed in accordance with the provisions in the Plan Document. A participant's account is distributed in a single lump-sum payment if the balance is less than \$1,000. If the account balance is greater than \$1,000 but less than \$5,000 and the employee makes a timely election, the balance can be distributed in a lump-sum payment, rolled-over into an individual retirement account (IRA) or the qualified plan of a new employer; however, should the participant not timely return the election forms, the Plan Administrator will transfer the vested account balance to an IRA established in the participant's name. If the account balance is over \$5,000 the participant must consent to the distribution and may choose from several different payments of benefit options (some of which may require a spousal consent), such a distribution in cash or Direct Rollover. In the case of death, the distribution shall be made to the participant's beneficiary.

**Forfeited Accounts**

Forfeitures of non-vested employer contributions, if any, shall be used to reduce employer contributions or to pay the Plan's administrative expenses for the plan year in which they occurred or thereafter. As of December 31, 2024 and 2023, there was \$21,075 and \$40,811, respectively, in forfeited non-vested accounts. Forfeitures in the amount of \$11,915 and \$14,344, respectively, were used by the Company to pay administration expenses and reduce employer contributions during December 31, 2024 and 2023.

**SECURE 2.0 ACT**

The Setting Every Community Up for Retirement Enhancement 2.0 Act (SECURE 2.0 Act) of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of mandatory and optional provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. Amendments to the Plan, if applicable, to reflect provisions of the SECURE 2.0 Act will be adopted in accordance with applicable law and IRS guidance.

**2. SUMMARY OF ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**Basis of Presentation**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) and the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the Plan's common collective trusts funds is at Net Asset Value (NAV), which is calculated by the fund balance based on net assets. The NAV is used as the practical expedient to estimate fair value. The fair value of the Plan's mutual funds is based on quoted prices held by the Plan. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant loan receivable is recorded as a benefit payment based on the terms of the Plan document.

**Excess Contributions Payable**

Amounts payable to participants in excess of the amount allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions for the years ended December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses for maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation of the fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and are charged directly to the participant's account.

**3. INFORMATION PREPARED AND CERTIFIED BY QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly Ascensus Trust Company and Newport Trust Company, LLC, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental schedule, Schedule of Assets Held for Investment (End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**4. FAIR VALUE MEASUREMENTS**

The Plan's valuation methodologies were applied to the Plan's investments carried at fair value. Fair value is based upon quoted market prices, where available. If listed prices or quotes are not available, fair value is based upon models that primarily use, as inputs, market-based or independently sourced market parameters. See Note (2) for details and procedures used to value investments in common collective trust funds measured at NAV, which is used as the practical expedient to estimate fair value.

Fair value calculations may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Valuation Hierarchy**

FASB Accounting Standards Codification, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level One - Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.
- Level Two - Inputs are observable inputs other than quoted (Level 1) prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable to can be corroborated by observable market data for substantially the full term of the assets of liabilities.
- Level Three - Unobservable inputs that are supported by little, or no, market activity and that are significant to the fair value of the assets or liabilities.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

**4. FAIR VALUE MEASUREMENTS (continued)**

The following is a description of the valuation methodologies used for the investments measured at fair value; there have been no significant changes in the methodologies used at December 31, 2024 and 2023:

- **Mutual Funds:** These funds are valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Collective Trusts:** These funds are valued using the Net Asset Value (NAV) as a practical expedient and are not categorized in the fair value hierarchy. NAV is provided by the fund's issuer and is based on the fair value of the underlying investments held by the fund less its liabilities. In the event the Plan was to initiate a full redemption of a common collective trust, the fund's issuer reserves the right to temporarily delay withdrawal from the common collective trust to ensure that securities liquidations will be carried out in an orderly business manner. The common collective trusts have no unfunded commitments, other redemption restrictions, or redemption notice periods. The underlying portfolios of the common collective trusts are comprised of a mix of stocks, bonds, commodities, and cash.

**5. RELATED-PARTY TRANSACTIONS**

The Company, the participants, and the Trustee/Custodian have all been identified as parties-in-interest. Ascensus Trust Company is the trustee and custodian of the Plan for all plan assets; therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Participant loans also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Certain administrative expenses of the Plan are paid by the Company and qualify as party-in-interest.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**7. TAX STATUS**

The Plan was established effective February 1, 2012. The Plan has been amended from time to time, including an amendment adopted and effective January 1, 2020.

The Plan has received an opinion letter from the Internal Revenue Service dated March 31, 2014, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the Code), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualifications. The plan administrator is not aware of any course of action or series of events that it believes would adversely affect the Plan's qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not would be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provisions or liability for income taxes have been included in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefit.

**9. SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued, and there were no subsequent events requiring adjustments to, or disclosure in, the Plan's financial statements.
