INDEPENDENT AUDITORS' REPORT

TO THE 401(k) MANAGEMENT COMMITTEE OF ENVIRONMENTAL SCIENCE ASSOCIATES 401(k) PLAN

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of ENVIRONMENTAL SCIENCE ASSOCIATES 401(k) PLAN (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Environmental Science Associates 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was established on October 1, 1989 by Environmental Science Associates (the “Company”), to provide retirement benefits for its employees.

The Plan is a defined contribution plan available to all eligible employees who have completed three months of service and have reached at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”).

The Plan provides for a plan administrator who is responsible for keeping accurate and complete records of the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and to government regulations, and providing participants with any reports and documents required by law. The 401(k) Management Committee is responsible for the oversight and administration of the Plan as well as determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

In April 2022, Ascensus closed a merger agreement with Newport Group. On June 23, 2023, the Plan migrated to the Ascensus recordkeeping and administrative services platform as a result of the merger. Effective June 23, 2023, all agreements the Plan has with Newport Group, Inc. and Newport Trust Company are assumed by Ascensus, LLC and Ascensus Trust Company, respectively.

Participant Contributions – Participant contributions can be made in any combination of pre-tax or post-tax (Roth) elective salary deductions. Each contribution type is maintained in separate accounts in the Plan. A participant may elect to contribute up to a maximum of \$23,000 for the year ended December 31, 2024 in accordance with the IRC. Additionally, participants age 50 and over at the end of the Plan year may make additional catch-up contributions up to \$7,500 for the year ended December 31, 2024. A participant may increase or decrease the amount of contributions as of each payroll period, as defined by the Plan agreement. Participants may also make rollover contributions from other qualified defined benefit or defined contribution plans.

The Plan features an automatic enrollment provision whereby all eligible employees hired after January 1, 2008 are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation, unless the employee affirmatively elects otherwise. Participants may contribute up to 100% of their annual eligible compensation, as defined by the Plan in the form of pre-tax or post-tax (Roth) deferrals, subject to annual limits specified by the IRC.

Employer Contributions – The Company may make discretionary matching contributions to each participant eligible to receive such contribution equal to 50% of the participant’s elective deferrals. However, the Company shall not make a contribution on any participant’s elective deferral that exceeds 75% of the participant’s compensation. The maximum Company matching contribution for any individual shall be the lower of \$2,000 or 37.5% of the participant’s compensation. Compensation is defined as base salary and certain incentive payments. In order to be eligible for the employer match, a participant must be credited with at least 500 hours of service and be employed on the last day of the Plan year. The Company may also make discretionary profit sharing contributions to the Plan. The Company made no discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts – The Plan maintains an account for each participant which is credited with the participant’s contributions, the related Company matching contributions, and Plan investment earnings. Participant accounts are charged with investment losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances or specific participant transactions, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that may be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contributions and related earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service as follows:

Investment Options – A participant may direct the investment of his or her account balance into various funds offered by the Plan. Participants may also invest their account balances in self-directed accounts.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants – Participants may borrow from their vested account balances provided they meet the Plan’s eligibility requirements. The minimum loan amount is \$1,000 and the maximum loan amount is equal to the lesser of one-half of the participant’s vested account balance or \$50,000. The term of the loan is not to exceed five years, except for loans used to finance the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear fixed interest at rates commensurate with local prevailing rates as determined by the plan administrator at the initiation of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions and loans are due immediately upon termination of employment.

Payment of Benefits – Upon termination of service due to death, disability, financial hardship or retirement, a participant may receive either a lump-sum distribution, installment distribution, or a direct rollover distribution into a qualified plan. Normal retirement age is 65 years. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may also elect to receive a pre-retirement distribution if the participant is 100% vested in the amount being distributed, and has reached 59½ years of age. Benefit payments to the participant generally must begin in the later of the year after the participant attains age 73 or the year in which the participant terminates employment.

In accordance with SECURE 2.0 Act, effective January 1, 2024, if a terminated participant’s account balance is between \$1,000 and \$7,000, and no instructions have been received from such participant, the amount will be rolled over to an individual retirement account as designated by the plan administrator. In 2023, the upper limit was \$5,000. Accounts of terminated participants with balances of less than \$1,000 will be distributed directly to the participant in the form of a lump-sum payment.

Forfeited Accounts – The non-vested portion of a participant’s balance is forfeited upon termination of employment. Forfeitures may be used to reduce employer discretionary contributions or pay any Plan administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$1,855 and \$9,584, respectively. During the year ended December 31, 2024, \$31,269 of forfeitures were used to reduce employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan’s financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the valuation policies utilizing information provided by the Plan’s investment advisors and trustee. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Contributions – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when they are incurred. Delinquent participant loans are reported as distributions of benefit payments based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Funds: Accounts consist of mutual funds and shares of common stock. The mutual funds are valued as described above and the shares of common stock are valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEES OF THE PLAN

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As mentioned at Note 1, on June 23, 2023, the Plan migrated to the Ascensus recordkeeping and administrative services platform. Effective June 23, 2023, Ascensus Trust Company (“Ascensus”) replaced Newport Trust Company (“Newport”) as the trustee of the Plan. Accordingly, Ascensus held the Plan’s investment assets and executed investment transactions beginning June 23, 2023. Ascensus, LLC as an authorized representative of Ascensus and Newport has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental Schedule H, line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE 5 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Ascensus and its affiliates provide certain administrative services to the Plan pursuant to a service agreement between the Plan, Ascensus and its affiliates. Ascensus and its affiliates receive revenue from mutual fund service providers for services Ascensus and its affiliates provide to the funds. This revenue is maintained by Ascensus and its affiliates to offset charges for administrative services to the Plan. Because these expenses are paid through this revenue sharing arrangement, they are included in net appreciation (depreciation) in fair value of investments.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination among the funds sponsored by the Plan. Additionally, the Plan offers a self-directed brokerage account option that allows participants to invest in securities not included in the Plan's investment options. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in investment value in the near term would materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 10 – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, there were unintentional delays by the Plan Sponsor in remitting participant contributions and loan repayments to Ascensus, amounting to \$268,756, within the period prescribed by the Department of Labor's regulations.

During the year ended December 31, 2024, participant contributions and loan repayments amounting to \$268,756 were not remitted to the Plan within the time frame prescribed by the Department of Labor's regulations, which generally require that such amounts be remitted as soon as they can reasonably be segregated from the employer's assets. The unintentional delay was due to an error in accepting participant contributions and loan repayments by Ascensus.

On September 17, 2025, the Company remitted total lost earnings of \$444 for the above delinquent participant contributions and loan repayments fully correcting these matters.

NOTE 11 – OPERATIONAL ISSUE

During the year ended December 31, 2023, management of the Plan discovered that certain newly eligible employees were not automatically enrolled into the Plan in a timely manner during the second half of the plan year. The impacted employees were enrolled into the Plan during January 2024. On September 5, 2024, the plan sponsor made corrective matching contributions to those impacted employees who would have been eligible for discretionary employer match contributions in the 2023 plan year.

NOTE 12 – SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.
