### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Catania-Spagna Profit Sharing & 401(k) Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**



**NOTE 1 DESCRIPTION OF PLAN**

The following description of Catania-Spagna Profit Sharing & 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on July 1, 1982 and is administered on the basis of the Plan year, which is the 12-month period commencing each January 1 and ending on December 31, covering all eligible employees of Catania-Spagna Corporation (the Plan Sponsor). The Plan is administered by the Plan Sponsor and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC).

The Plan is intended to qualify as a tax-exempt profit-sharing plan and trust under Code Sections 401(a) and 501(a), respectively, and the cash-or-deferred arrangement forming part of the Plan is intended to qualify under Code Section 401(k).

**Eligibility**

All employees having attained the age of 18, as defined, are eligible for participation. Exempt employees are immediately eligible for participation, whereas nonexempt employees must also complete one month of service in order to be eligible to participate.

**Contributions**

A participant may contribute an amount of up to 100% of his/her compensation, pre-tax to a traditional 401(k) or post-tax to a Roth 401(k), as defined in the Plan and subject to maximums in accordance with federal regulations. Regarding the definition of compensation, all dollars are eligible for 401(k) except bonuses. A participant may subsequently elect to increase or decrease the rate of contributions as of each payroll period. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Plan Sponsor is currently automatically matching up to 100% of the first 4%, and 50% of the next 2%, of an eligible employee's compensation contributed to the Plan. Safe-harbor matching contributions are subject to certain limitations as defined in the Plan documents and in accordance with applicable regulations. For the year ended December 31, 2024, the Plan Sponsor made safe-harbor matching contributions to the Plan in the amount of \$701,667.

The Plan Sponsor may decide to make discretionary matching contributions to the Plan in an amount and allocation formula as determined by the Plan Sponsor (not to exceed 4% of compensation), although the Plan Sponsor is not required to do so. For the year ended December 31, 2024, the Plan Sponsor did not make discretionary matching contributions to the Plan.

**Contributions (Continued)**

The Plan Sponsor may also, in its sole discretion, make a profit-sharing contribution to the Plan on behalf of certain participants. Profit-sharing contributions will be allocated to the participant's accounts in the same proportion that their compensation bears to the total compensation (integrated "permitted disparity" allocation). For the year ended December 31, 2024, the Plan Sponsor made profit-sharing contributions to the Plan in the amount of \$377,824.

**Rollovers**

With the approval of the Plan Sponsor, a participant may rollover or transfer any amounts held under other qualified plans, regardless if he/she has become a participant in the Plan, provided that such receipt does not adversely affect the qualified tax status of the Plan. A participant is 100% vested in their rollover contributions at all times and may withdraw these funds from the Plan at any time.

**Participants' Accounts**

Each participant's account is credited with the participant's contributions and Plan Sponsor contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Plan Sponsor contributions, investment income and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Vesting of Contributions**

A participant's contributions, safe-harbor match and earnings thereon are fully vested at all times. Under normal vesting circumstances, the employer discretionary matching contributions and earnings thereon are 33% vested after one year of service, and an additional 33% vested each subsequent year until 100% vested after three years of service, as defined in the Plan.

Vesting of profit-sharing contributions and related earnings thereon is achieved after three years of service; participants are 0% vested until then. Any participant automatically becomes fully vested upon death, disability, or attainment of age 65.

**Forfeited Accounts**

Contributions made by the Plan Sponsor which are not vested at the time employees cease to be participants in the Plan shall be used to pay plan expenses or reduce future contributions by the Plan Sponsor. Forfeited nonvested discretionary matching and profit-sharing accounts were \$39 at December 31, 2024. Forfeited nonvested discretionary matching and profit-sharing accounts were \$214 at December 31, 2023. Forfeited nonvested discretionary matching and profit-sharing accounts of \$6,544 were used to pay administrative fees during the year ended December 31, 2024.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000. Loan terms range from 1 to 5 years, except for loans to purchase a primary residence, which may be offered over a term of up to 10 years. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The notes currently bear interest at rates ranging from 5.25% to 10.5%. Participants may only have one loan outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service due to retirement or disability, a participant will receive either a lump-sum distribution or installment payments equal to the value of his/her account, or to defer receipt of his/her account balance, provided a distribution is made or commences no later than April 1 following the end of the calendar year in which the participant attains age 70 ½.

In the event of death, a participant's entire account balance will be distributed to his/her beneficiary.

Distributions to participants who otherwise terminate employment will be deferred until the age of 65, unless the participant elects immediate payment or the distribution is less than \$5,000. In such cases, the participant will receive a lump-sum distribution equal to the nonforfeitable value of his/her account.

**Withdrawals**

Withdrawals are not permitted except for a severe financial hardship, such as the purchase of a primary residence, educational expenses, uninsured medical expenses, or the prevention of eviction from or foreclosure on a primary residence. Hardship guidelines adhere to the final 401(k) regulations of the IRC. Participants over the age of 59 ½ have more flexibility and can withdraw their vested balances for nonhardship reasons.

**Revenue Sharing**

At times, the Plan holds assets in a Plan cash account which receives deposits as a result of a revenue sharing arrangement with Fidelity Personal Trust Company. During 2024, deposits to the account totaled \$6,254, which are included in other income on the statement of changes in net assets available for benefits. Funds in the account are used to pay qualified Plan expenses. During 2024, these revenue sharing credits were used to pay Plan expenses.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following is a summary of significant accounting policies which are in conformity with accounting principles generally accepted in the United States of America, consistently followed by the Plan in the preparation of its financial statements.

**Basis of Accounting**

The financial statements of the Plan have been prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of sources and applications of net assets during the reporting period. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation or depreciation in fair value of investments represents dividends earned, realized gains and losses, and the change in unrealized appreciation or depreciation during the year. Dividend income earned on investments is reinvested in the respective investment.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**Payments of Benefits**

Benefits to participants are recorded when paid.

**Risks and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Management has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued, and no subsequent events have been noted which would require adjustment to or discussion in the financial statements.

**NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE**

Information presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024 for investments, cash, and investment income, from information certified to be complete and accurate by Fidelity Personal Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Money Market and Mutual Funds* – Money market and mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year-end.

*Common and Collective Trusts* – The common and collective trusts are composed primarily of fully benefit-responsive investment contracts and are valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by affiliates of Fidelity Personal Trust Company (Fidelity). Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, notes receivable from participants are party-in-interest transactions.

**NOTE 6 INCOME TAX STATUS**

The Plan has adopted a nonstandardized prototype plan that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
