Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Robert McCabe Company Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") have been prepared on the accrual basis.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Expenses

Certain expenses of the Plan were paid by the Robert McCabe Company Inc. (the "Company") and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation in fair value of investments.

Related-Party Transactions

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Subsequent Events

The Company has evaluated events subsequent to the balance sheet date of December 31, 2024 through September 8, 2025, which is the date these financial statements were available to be issued. No subsequent events were noted.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Robert McCabe Company Inc. 401(k) Profit Sharing Plan and Trust agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with an original effective date of January 1, 2000. The Plan was amended and restated on August 9, 2023. All employees of the Company who have at least one year of service (defined as at least 1,000 hours worked over a calendar year), are age 21 or older, are eligible to participate in employee elective contributions and to receive employer matching contributions. Employees are eligible to enter the plan on January 1st and July 1st of each plan year. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Company maintains required employment and payroll records for all participants and appoints trustees to administer the Plan.

Contributions

Participants may contribute up to 50% of their pre-tax annual compensation or after-tax compensation, as defined by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for the year ended December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500 annually. Participants may designate their elective deferrals as a traditional (pre-tax) contribution or Roth (after-tax) contribution. The Plan provides for an employer matching contribution equal to a 50% match up to 4% of eligible compensation. The Company made employer matching contributions of \$113,509 for the year ended December 31, 2024. The Plan also allows for discretionary profit-sharing contributions. The profit-sharing contribution is allocated to all eligible participants based on eligible compensation. The Company did not make a profit-sharing contribution for the year ended December 31, 2024.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based upon each participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions. Vesting in the Company's employer match and profit-sharing portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants are not vested for their first two years of service but become fully vested after three years of service. Forfeited balances of terminated participants' non-vested accounts may first be used to reduce employer contributions and then pay administrative expenses of the Plan. The balance of unallocated forfeitures was \$-0- at December 31, 2024 and 2023. The Company used \$-0- of forfeitures to offset 2024 employer contributions that were contributed during 2024 and used \$-0- to offset administrative expenses.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. If the participant's vested interest is greater than \$5,000, the participant may choose to have the distribution paid directly to an eligible retirement plan or to receive the benefit in the form of cash or periodic installments. If the vested interest is less than \$5,000 but greater than \$1,000, the participant may elect to have the distribution paid directly to an eligible retirement plan or to receive the distribution directly in the form of cash. Should such an election not be made by the participant, the distribution will be in the form of a direct rollover to an individual retirement plan designated by the Plan administrator. If the vested interest is \$1,000 or less, the payment will be in the form of a lump sum payment.

In-service distributions are permissible from the Plan for participants that have attained the age of 59.5.

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Notes Receivable from Participants

Participant loans are available on amounts in the participant's account. The maximum loan amount is the lesser of one-half of a participant's vested account balance or \$50,000. The vested participant account balance will be used as collateral for any loan. All loans shall bear a reasonable rate of interest as determined by the Plan administrator. All loans must be repaid within five years except in the case of a loan for the purpose of acquiring a home.

NOTE 3 TAX STATUS

The Plan Sponsor has received a determination letter from the Internal Revenue Service dated August 31, 2020, which states the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Company has evaluated events subsequent to the balance sheet date of December 31, 2024 through September 8, 2025, which is the date these financial statements were available to be issued. No subsequent events were noted.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Robert McCabe Company Inc. 401(k) Profit Sharing Plan and Trust agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with an original effective date of January 1, 2000. The Plan was amended and restated on August 9, 2023. All employees of the Company who have at least one year of service (defined as at least 1,000 hours worked over a calendar year), are age 21 or older, are eligible to participate in employee elective contributions and to receive employer matching contributions. Employees are eligible to enter the plan on January 1st and July 1st of each plan year. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Company maintains required employment and payroll records for all participants and appoints trustees to administer the Plan.

Contributions

Participants may contribute up to 50% of their pre-tax annual compensation or after-tax compensation, as defined by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for the year ended December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500 annually. Participants may designate their elective deferrals as a traditional (pre-tax) contribution or Roth (after-tax) contribution. The Plan provides for an employer matching contribution equal to a 50% match up to 4% of eligible compensation. The Company made employer matching contributions of \$113,509 for the year ended December 31, 2024. The Plan also allows for discretionary profit-sharing contributions. The profit-sharing contribution is allocated to all eligible participants based on eligible compensation. The Company did not make a profit-sharing contribution for the year ended December 31, 2024.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based upon each participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions. Vesting in the Company's employer match and profit-sharing portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants are not vested for their first two years of service but become fully vested after three years of service. Forfeited balances of terminated participants' non-vested accounts may first be used to reduce employer contributions and then pay administrative expenses of the Plan. The balance of unallocated forfeitures was \$-0- at December 31, 2024 and 2023. The Company used \$-0- of forfeitures to offset 2024 employer contributions that were contributed during 2024 and used \$-0- to offset administrative expenses.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. If the participant's vested interest is greater than \$5,000, the participant may choose to have the distribution paid directly to an eligible retirement plan or to receive the benefit in the form of cash or periodic installments. If the vested interest is less than \$5,000 but greater than \$1,000, the participant may elect to have the distribution paid directly to an eligible retirement plan or to receive the distribution directly in the form of cash. Should such an election not be made by the participant, the distribution will be in the form of a direct rollover to an individual retirement plan designated by the Plan administrator. If the vested interest is \$1,000 or less, the payment will be in the form of a lump sum payment.

In-service distributions are permissible from the Plan for participants that have attained the age of 59.5.

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Notes Receivable from Participants

Participant loans are available on amounts in the participant's account. The maximum loan amount is the lesser of one-half of a participant's vested account balance or \$50,000. The vested participant account balance will be used as collateral for any loan. All loans shall bear a reasonable rate of interest as determined by the Plan administrator. All loans must be repaid within five years except in the case of a loan for the purpose of acquiring a home.

NOTE 3 TAX STATUS

The Plan Sponsor has received a determination letter from the Internal Revenue Service dated August 31, 2020, which states the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money-market fund: Valued at the net asset value of shares held by the plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
