1. Plan Description

The following brief description of the Medical Solutions 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees at Medical Solutions, LLC, 360 Healthcare Staffing, LLC, Aureus Healthcare One, LLC, Aureus Medical Management Services, LLC, Aureus Nursing, LLC, Aureus Radiology, LLC, Professional Placement Resources, LLC, C&A Industries, LLC, Host Healthcare, LLC, Matchwell, LLC, and WorldWide HealthStaff Solutions Ltd (the Company).

Employees are eligible to make pre-tax and after-tax Roth salary deferral contributions after attaining age 18. Employees are eligible to receive safe harbor matching contributions after attaining age 18 and completing six months of service with a minimum of 500 hours of service. Eligible employees become participants on the first payroll period following the date on which eligibility requirements were met.

Participants who have at least 500 hours of service during the Plan year and are employed on the last day of the Plan year are also eligible for employer discretionary profit-sharing contributions.

Contributions

Participants may make salary deferral contributions up to 75% of pre-tax annual compensation as defined by the Plan, up to the maximum dollar limits allowable by law. The Plan also allows participants to designate a portion or all of their elective contributions as designated after-tax Roth contributions. Participants are automatically enrolled with an initial 4% salary deferral contribution. At any time, these participants can elect not to contribute or may increase or decrease their deferral rate to any rate allowed under the Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company also has a safe harbor matching contribution. Company safe harbor matching contributions are made in amounts equal to 100% of the participants deferral of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation.

The Company may elect to make discretionary profit-sharing contributions. No discretionary profit sharing were made for the years ended December 31, 2024 and 2023.

Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to elect to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's safe harbor matching contributions and discretionary profit-sharing contributions and b) Plan earnings or losses. The Company's safe harbor matching contributions are allocated based on each participant's elected salary deferral. The Company's discretionary profit-sharing contribution is allocated among participants based upon eligible compensation of eligible participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity).

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also 100% vested in the Company's safe harbor matching contributions. Vesting in the Company's discretionary profit-sharing contributions credited to participants' accounts is based on years of continuous service. Participants vest 50% after one year of credited service, and vesting increases 25% per year until a participant is 100% vested after three years of credited service. A participant becomes 100% vested in Company contributions at normal retirement age, death, or disability. Participants from the Professional Placement Resources, LLC 401(k) Plan who transferred into the Plan are 100% vested in all prior and future discretionary profit-sharing contributions. Participants from the C&A Industries, LLC 401(k) Profit Sharing Plan who transferred into the Plan are 100% vested in all prior and future discretionary profit-sharing contributions.

Notes Receivable from Participants

The Plan does not allow for new participant notes. The Plan accepted notes receivable from participants transferred in from merged qualified retirement plans. The notes are secured by the balance in the participant's account. Principal, interest, and note fees are paid through payroll deductions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump sum payment equal to the value of the vested funds allocated to the participant's account. Participants or beneficiaries may also elect to receive installment payments or partial withdrawals of vested funds.

The Plan requires mandatory distribution of payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses or reduce future Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$86,000 and \$106,000, respectively. During the years ended December 31, 2024 and 2023, Company contributions were reduced by approximately \$494,000 and \$356,000 from forfeited non-vested accounts, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Other

Investment management expenses, recordkeeping expenses, and audit fees are paid by the Company and are excluded from these financial statements. Fees related to the administration of distributions, administrative expenses, and other investment related expenses are paid by the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 30, 2025, noting no items requiring disclosure.

3. Information Certified by Fidelity

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. The participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis. There are no unfunded commitments at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

7. Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity acts as the custodian of the Plan, and therefore, transactions related to these investments qualify as party-in-interest transactions.

8. Plan Mergers

Effective December 29, 2023, Host Healthcare 401(k) Plan transferred \$5,951,128 of plan assets to the Plan. Effective January 14, 2024, Host Healthcare 401(k) Plan transferred the remaining plan assets to the Plan. The Plan received the assets of \$11,295,685 on January 2, 2024, which includes the prior year receivable of \$11,000,707, loans of \$166,127, and held mutual funds of \$128,851. The blackout period associated with this transfer, in which participants could not make changes to their 401(k) account, began on December 22, 2023, and concluded on January 14, 2024.

Effective January 21, 2024, WorldWide HealthStaff Solutions 401(k) Plan transferred all of the plan's assets to the Plan. The Plan received the assets of \$809,153 on January 8, 2024. The blackout period associated with this transfer, in which participants could not make changes to their 401(k) account, began on December 29, 2023, and concluded on January 21, 2024.

Effective January 28, 2024, Matchwell Inc. 401(k) Plan transferred all of the plan's assets to the Plan. The Plan received the assets of \$480,038 on January 19, 2024. There was no blackout period associated with this transfer.
