### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Pennsylvania Medical Society 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis for Opinion***

### (1) Description of Plan

The following description of the Pennsylvania Medical Society (the Society) 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Participating employers under the Plan are the Society, its wholly-owned subsidiary, PennMed Member Services Company, and its affiliate, the Foundation of the Pennsylvania Medical Society.

#### **General**

The Plan is a defined contribution plan. Substantially all employees of the Society, except college interns, are eligible to become participants in the Plan on their commencement date, provided they are estimated to work 1,000 hours or more annually or work 500 hours over two consecutive years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The 401(k) Retirement Savings Plan's Administrative Committee is responsible for oversight of the Plan. The Plan Trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Society, the Plan Sponsor.

#### **Contributions**

Participants may contribute up to 85% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies and money market funds as investment options for participants. The Society's contribution percentage is determined in accordance with the regulations governing adoption of safe harbor compliance with the average contribution percentage test. The Society matches 100 percent of each participant's contribution up to 5 percent of compensation. Contributions are subject to certain limitations.

The Plan also provides that the employer may make a discretionary profit-sharing contribution. A participant needs to complete 1,000 hours of service during the current plan year to be credited with a service year. Eligibility for the discretionary profit sharing contribution requires one hour of service during the allocation period. For the year ended December 31, 2023, the discretionary profit sharing contribution was equal to 5% of each eligible participant's annual compensation and amounted to \$291,121. For the year ended December 31, 2024, the discretionary profit-sharing contribution was equal to 4% of each eligible participant's annual compensation amounting to \$429,019, which was funded by the unallocated suspense account, see Note 6.

### (1) Description of Plan, Continued

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of the Society's contributions and plan earnings, and charged with an allocation of administrative expenses paid by the plan. Participant account expenses are transaction fees related to loans or distributions assessed to the borrower or distributee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Society's discretionary profit sharing contribution is based on years of service. A participant is 100 percent vested after three years of credited service.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years or longer for a loan used to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest ranging from 4.25 to 9.50 percent, which is commensurate with the prime rate at the date of loan issuance plus 1 percent as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant or survivor may request to receive a lump-sum amount equal to the value of the participant's interest in his or her account. Retired or terminated employees may receive partial lump-sum distributions in excess of \$1,000.

#### *Forfeited Accounts*

Forfeited nonvested accounts are used to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$21,128 and \$11,184, respectively, from forfeited nonvested accounts. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts.

### (2) Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Contributions***

Contributions from the plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Society and are excluded from these financial statements. Fees related to the administration of notes received from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### *Subsequent Events*

The Plan has evaluated subsequent events through June 26, 2025, the date the financial statements were available to be issued.

### (3) Financial Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### (4) Fair Value Measurements, Continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Shares of registered investment companies and money market funds:* Valued at the daily closing prices as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily market values and to transact at that price. The funds held by the Plan are deemed to be actively traded.

### (5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments include shares of a money market fund managed by Charles Schwab Investment Management, Inc. Charles Schwab Trust Bank is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The Society pays directly any other fees related to the Plan's operations.

#### (6) Transfers From Affiliated Plan and Unallocated Assets

The Plan Sponsor maintained the Pension Plan of the Pennsylvania Medical Society (Pension Plan), which was terminated effective December 31, 2022. In connection with the Pension Plan termination, excess assets of \$2,526,182 were transferred to the Plan during 2023. At December 31, 2023 these funds were invested in the Vanguard Life Strategies Moderate Growth Fund in a suspense subaccount, unallocated to participant accounts. These funds are allocated to participant accounts at the discretion of the Society in accordance with limits imposed by IRS Code section 415. Once allocated to the participant accounts, the deposits are invested in various investment options as directed by the participants' elections.

#### (7) Plan Termination

Although it has not expressed any intent to do so, the Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

#### (8) Tax Status

The Plan uses a pre-approved plan document sponsored by Conrad M. Siegel, Inc. The Internal Revenue Service (IRS) has determined and informed Conrad M. Siegel, Inc. by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks.
