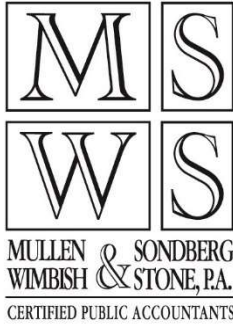

## INDEPENDENT AUDITOR'S REPORT

Note 1 - Description of Plan

The following description of the WeAchieve, Inc. 401(k) Plan (the Plan), (formerly known as CHI Centers, Inc. 401(k) Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established on January 31, 1978 and restated on November 1, 2001. The Plan was amended on April 3, 2024 to change the name of the Plan from CHI Centers 401(k) to WeAchieve, Inc. 401(k) Plan. The Plan is a defined contribution plan including a tax deferred contribution arrangement as permitted under the Internal Revenue Code (IRC). Employees of WeAchieve, Inc. and Inwood House Development Corporation (IHDC), an affiliated entity (collectively, the Plan Sponsor or Company), whose regularly scheduled service is 1,000 hours or more are eligible to participate in the Plan after having completed 90 days of service. Eligible participants may elect to enroll in the Plan on a quarterly basis after having met the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may contribute up to 25% of pre-tax annual compensation, as defined by the Plan, and contribute up to 10% of post-tax annual compensation. These participant contributions are subject to maximum amounts allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company may make discretionary matching contributions to the Plan, which allows the employers to determine, in their sole discretion, how much, if any, they will make as a matching contribution each year. Such amounts can be determined either as a uniform percentage of deferrals or as a flat dollar amount for each participant. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary matching contributions to the Plan. The Company may also make discretionary profit sharing contributions; however during the years ended December 31, 2024 and 2023, the Company did not make a discretionary profit sharing contribution.

Participant Accounts: Each participant's account is credited with the participant's contribution and Company's discretionary matching contributions, as well as allocations of (a) the Company's discretionary profit sharing contributions, if any, (b) Plan earnings and (c) administrative expenses. Allocations are based on participant compensation, participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant with a vested balance of less than \$5,000 will receive a lump sum distribution. Participants or their beneficiaries who have a balance greater than \$5,000 may elect to receive the total vested balance in a lump sum distribution or installment payments. Participants may withdraw voluntary contributions from their accounts by reason of financial hardship under specific guidelines set forth in the Plan. In-service withdrawals are also allowed for participants who are at least 59 ½ years old.

Vesting: Participants are immediately vested in their voluntary contributions, plus earnings allocated thereon. Vesting in company discretionary contributions is based on years of continuous service as shown in the table below.

Less than two years	0%
Two years	20%
Three years	40%
Four years	70%
Five years and thereafter	100%

A participant is 100% vested upon death, disability, termination of the Plan, reaching 65 years of age, or the completion of five years of continuous service.

Investment Options: Contributions to the Plan are invested by the Plan's Trustee in various investment funds, according to participant instructions.

Forfeitures: The amounts of forfeitures available were \$64,308 and \$62,731 at December 31, 2024 and 2023, respectively. These accounts represent uncashed participant checks and will be drawn upon when participants come forward.

Notes Receivable from Participants: Participant notes are not permitted under this plan.

Administrative Expenses: The administrative expenses related to the Plan's Trustee are paid by the Plan. The Company pays all other administrative expenses of the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Accounting Policies (Cont.)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the investment contract with the insurance company, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Statements of Changes in Net Assets Available for Benefits are prepared on a contract value basis for the fully benefit-responsive investment contract.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS or plan document are recorded as a liability with a corresponding reduction to contributions.

Uncashed Checks Payable

Amounts payable to participants for funds that had originally been distributed, but not cashed by participants. These funds are within investments until participants come forward.

Contributions and Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation amounts paid to participants. The Company matching contributions and the Company discretionary contributions are recorded in the year in which the Company designated the contributions. All participant and employer contributions are participant-directed.

Management of the Plan evaluates contribution receivables periodically for potential collectible amounts based on the likelihood of collection. As of December 31, 2024 and 2023, there were no contribution receivables, and therefore an allowance for credit loss has not been established.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to participants for the years ended December 31, 2024 and December 31, 2023 amounted to \$437,201 and \$458,436, respectively.

Note 3 - Fair Value Measurements

*ASC 820-10 Fair Value Measurements* establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820*, the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

Note 3 - Fair Value Measurements (Cont.)

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

*Pooled separate account:* The unit value of the pooled separate account is calculated based on the observable net asset value (NAV) of the underlying investment. The pooled separate account is invested in underlying mutual funds which are valued at the daily closing price as reported by the funds. Mutual funds held by the pooled separate account are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy.

The table below sets forth additional disclosures for investments for which fair value is estimated using net asset per share (or its equivalent) as of December 31:

Note 4 - Guaranteed Investment Contract with Insurance Company - Contract Value

The Plan entered into a fully benefit-responsive investment contract with Empower Retirement, LLC. Empower Retirement, LLC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract is included in the financial statements at contract value as reported to the Plan by Empower Retirement, LLC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed in the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value at December 31, 2024 and 2023, amounted to \$2,136,570 and \$2,342,628, respectively.

Note 4 - Guaranteed Investment Contract with Insurance Company - Contract Value (Cont.)

Because the contract is an insurance contract, the Plan may transact according to the terms defined in the contract at any time. If the Plan wishes to terminate its interest in the contract, it would be paid the value of its interest. The issuer of the contract has the right to no longer receive deposits. Termination of the contract would occur when the deposit arrangement no longer exists and there are no guaranteed interest funds with a value greater than zero remaining under the contract. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

Note 5 - Data Obtained from the Trustee

Investment Data

Empower Retirement, LLC is the sole administrator of the Plan. Empower Retirement, LLC refers to products and services offered by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Trust Company, LLC was the Trustee of the Plan as of December 31, 2024 and 2023.

The Plan utilizes an insurance product from Mass Mutual and the summary plan report and applicable certifications as of December 31, 2024 and 2023 is provided under Mass Mutual using a power of attorney granted to Empower Trust Company, LLC.

All data contained in the statements of net assets available for benefits, statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and Schedule H, Line 4i - Schedule of assets (held at year end) for the year ended December 31, 2024, was summarized from information supplied and certified as complete and accurate by Empower Trust Company, LLC, the Trustee of the Plan.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, Line 4i - Schedule of assets (held at year end) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 6 - Reportable Transactions

A reportable transaction is a transaction or series of transactions exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan years ended December 31, 2024 and 2023, there were no reportable transactions.

Note 7 - Transactions with Parties-in-Interest

Certain Plan investments are shares of pooled separate accounts and a guaranteed investment contract managed by the Trustee. These investments qualify as party-in-interest investments/transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than direct payments. Fees paid by the Plan for administrative services amounted to \$554 and \$747 for the years ended December 31, 2024 and 2023, respectively.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their account.

Note 9 - Tax Status

Effective November 1, 2021, the Plan was amended and restated, and the Plan adopted a non-standardized pre-approved defined contribution form of a prototype plan sponsored by Empower Retirement, LLC. The prototype plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since this determination letter has been received. However, the plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11 - Prohibited Transactions

The accompanying Schedule H, Line 4a - schedule of delinquent participant contributions reflects participant contributions that were not remitted timely to the Trustee. The effect to the financial statements was an understatement of earnings. The amount is deemed immaterial and has not been recorded in the financial statements.

Note 12 - Reconciliation to IRS Form 5500
