Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Oneida Airport Hotel Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 26, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the period from January 1, 2024 to December 26, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Oneida Airport Hotel Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 26, 2024 and December 31, 2023, and for the period from January 1, 2024 to December 26, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oneida Airport Hotel Corporation 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 and Note 7 to the financial statements, the Board of Directors of Oneida Airport Hotel Corporation approved a plan of liquidation of the Oneida Airport Hotel Corporation 401(k) Plan on December 27, 2023, and management determined liquidation is imminent. As a result, the Oneida Airport Hotel Corporation 401(k) Plan changed its basis of accounting from the going concern basis to the liquidation basis of accounting in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Oneida Airport Hotel Corporation 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Notes to Financial Statements

Note 1: Plan Description

The following description of Oneida Airport Hotel 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Termination

On December 27, 2023, the Board of Directors of Oneida Airport Hotel Corporation (the "Company") approved a plan to dissolve the Company, including the termination of the Plan. Subsequent to December 31, 2023, the Company communicated to all participants its intent to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), with a termination date of February 5, 2024. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan changed its basis of accounting to value plan assets on the liquidation basis for the year ended December 31, 2023. This change had no effect on the reported net assets available for benefits. See further disclosures relating to the Plan's termination in Note 7.

General

The Plan is a defined contribution plan available to eligible employees of the Company. Full-time employees become eligible for employee contributions, as well as the Company discretionary matching contributions, upon attainment of age 18 and six months of service. Part-time, seasonal, minimal/on-call, and temporary employees become eligible upon attainment of age 18 and 1,000 hours of service during a year or effective January 1, 2024, completion of three consecutive years of services where the employee completes at least 500 hours of service to become eligible to participate in the plan. Eligible employees enter the Plan on January 1, April 1, July 1, and October 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Participants are allowed to contribute to the Plan up to 50% of pre-tax eligible compensation, as defined by the plan document, subject to limitations established by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions and may defer up to 75% of pre-tax eligible compensation, as defined by the plan document, subject to limitations established by the IRS. The Plan allows participants to roll over distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution. In 2024, the Company made a discretionary matching contribution of 50% of participants' elective deferrals up to 6% but not exceeding 3% of their compensation. Rollover contributions are not matched.

Note 1: Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of (a) plan earnings or losses and (b) forfeited nonvested accounts. Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's discretionary matching contributions plus actual earnings thereon become 20% vested after one year of credited service. The vesting percentage increases an additional 20% each year thereafter, with 100% vesting after five years of credited service. In addition, participants become fully vested upon death or disability. Upon termination of the Plan on February 5, 2024, all participants will become fully vested in the Company's discretionary matching contributions, and actual earnings thereon.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest. Note terms range from one to five years, but may extend up to 15 years for the purchase of a primary residence. Participants may only have one note outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at a rate charged for similar notes by lending institutions as determined by the plan administrator. The notes are secured by the balance in the participant's account and bear interest at 2% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, death, or termination of employment with vested interest. Benefits are payable in the form of lump-sum distributions or installments. The Plan allows for in-service distributions upon attaining age 59 1/2, upon disability, or for financial hardship, if certain criteria are met. Participants may withdraw their rollover contributions at any time.

Note 1: Plan Description (Continued)

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Company before becoming 100% vested in the Company's contributions. Forfeited nonvested accounts totaled \$0 as of December 26, 2024 and December 31, 2023. Forfeitures can be used to pay administrative expenses, be allocated to participants accounts, or reduce Company discretionary matching contributions at the Company's discretion. No forfeitures were used to pay administrative expenses during 2024 and no amounts were allocated to participants during 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with GAAP. The 2024 and 2023 financial statements are presented on the liquidation basis.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 26, 2024 and December 31, 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to the plan participants based on their respective account balances and are included in net investment income on the accompanying statement of changes in net assets available for benefits. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through September 23, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023.

Stable value collective trust fund: A stable value fund that is comprised primarily of fully benefit-responsive investment contracts that are valued at the net asset value ("NAV") of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments, notes receivable from participants, non-interest-bearing cash, and amounts due to broker at December 26, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from the period from January 1, 2024 to December 26, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A. ("Alerus"), the Trustee of the Plan.

Note 5: Party-in-Interest Transactions

Alerus is the Trustee, as defined by the plan document and, therefore, transactions with Alerus qualify as party-in-interest transactions. Fees paid by the Plan to Alerus for investment management services totaled \$15,320 for the period from January 1, 2024 to December 26, 2024. Fees paid by the Plan to Alerus for administrative expenses totaled \$195 for the period from January 1, 2024 to December 26, 2024.

Notes receivable from participants qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Company has adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

On December 27, 2023, the Company's Board of Directors approved a plan to terminate the Company, including the termination of the Plan. Subsequent to December 31, 2023, the Company communicated to all participants its intent to terminate the Plan, subject to the provisions of ERISA, with a termination date of February 5, 2024. In order to terminate the Plan, the Company requested approval from the IRS. This approval has not yet been received. The final benefit payments and distributions occurred during 2024. The benefits of the participants in the Plan are 100% vested, and the termination did not affect the amount of benefit the participants were entitled to or the forms of payment available under the provisions for the Plan.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
