### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Collectors Universe, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Collectors Universe, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on July 1, 1992, in accordance with Section 401(k) of the Internal Revenue Code (IRC). It is a defined contribution plan for the benefit of all employees of Collectors Universe, Inc. (the Company) who have completed one month of service. Only union employees and non-resident aliens are excluded from the Plan. The Plan's administrative committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. Effective March 1, 2022, Goldin Auctions LLC 401(k) & Profit Sharing Plan merged into the Plan. Effective April 1, 2024, SGC LLC was added to the Plan as a participating employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Although it has not expressed the intention to do so, the Company has the right under terms of the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA provisions. In the event of Plan termination, participants would become 100% vested in their contributions.

**Contributions**

Employee contributions to the Plan (referred to as voluntary contributions) are deferrals of the employee's compensation made through a direct reduction of compensation in each payroll period. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The maximum tax deferred contribution may not exceed the Internal Revenue Service (IRS) limit. The Company may elect to provide a discretionary matching contribution. All eligible employees during the Plan year are eligible to receive the Company's contribution. The Company made a discretionary match of 50% of deferrals up to 6% of compensation in 2024. During the year ended December 31, 2024, there were \$2,253,872 of Company contributions, net of forfeitures used.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution and (b) Plan earnings and losses, net of investment management fees, and administrative expenses. Allocations are based on participant earnings and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Each participant's interest in voluntary contributions is vested immediately. Company contributions are vested in accordance with the Plan's vesting schedule as follows:

<u>Years of Service</u>	<u>Vesting Percentages</u>
Less than One	0%
One but Less than Two	25%
Two but Less than Three	50%
Three but Less than Four	75%
Four or More	100%

On termination of service due to death, disability, retirement, or having attained age 65, a participant shall become fully vested. In the event of termination of the Plan, the entire amounts credited to participant accounts are payable to participants at 100%, regardless of years of service.

**Notes Receivable from Participants**

Participants may borrow from their fund account a minimum of \$1,000 for up to a maximum of \$50,000 or 50% of their total vested account balance. Loan transactions are treated as a transfer to (from) the respective investment fund from (to) the participant's loan fund. A participant must repay the loan within five years, unless he or she is terminated, retires, or becomes disabled, in which case the loan becomes immediately due and payable. Loans taken for the purpose of buying a primary residence must be repaid within 25 years. Loans bear a reasonable rate of interest as determined by Empower, the custodian of the Plan. Principal and interest are paid ratably through payroll deductions and credited to the participant's fund balance.

**Payment of Benefits**

Participants become entitled to payment of the total vested value of their accounts at the time of termination, retirement, permanent layoff, permanent disability, or death. If a participant's vested interest is \$1,000 or less, determined as of the valuation date following the termination of employment, such benefits will be distributed as a single lump sum. For balances greater than \$7,000, the participant may elect to receive a lump sum payment, roll the balance over to an individual retirement account, or leave the balance in the Plan. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59½, participants are allowed to withdraw portions of their funds from the Plan.

**Forfeited Accounts**

At December 31, 2024, there was \$27,445 of forfeited nonvested accounts. At December 31, 2023, there was \$70,569 of forfeited nonvested accounts. These accounts can normally be used to reduce future Employer contributions or Plan expenses. \$249,602 of forfeitures were used in 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). References to the ASC hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board (FASB) as the source of authoritative U.S. GAAP.

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements. The fair value of the Plan's investments in the stable value fund is measured using the net asset value (NAV) per share as a practical expedient. Each unit in the stable value fund invests directly in a unit of the underlying investment. Unit values are calculated based on the observable NAV of the underlying investment in the funds. See Note 7 for a discussion of NAV measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the period. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and included in administrative expenses when incurred. At December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Contribution Receivables**

Contribution receivables represent amounts that have been contributed prior to year-end, but not received by the Plan until subsequent to year-end.

**Administrative Expenses**

Certain administrative expenses are paid by the Plan, while other expenses incurred by maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Payment of Benefits**

Benefits are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15.

**Subsequent Events**

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

**NOTE 3 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 4 TAX STATUS**

The Plan adopted the Prototype Non-standardized Profit Sharing Plan with a cash or deferred arrangement sponsored by Great-West, the custodian of the Plan. The IRS has determined and informed Great-West by a letter, that the prototype Plan is designed in accordance with applicable sections of the IRC. The Plan administrator and the prototype Plan's tax counsel believe that the prototype Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator has analyzed the tax positions taken by the Plan; it has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 INVESTMENTS AND FAIR VALUE MEASUREMENTS**

FASB provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this FASB framework are described as follows:

*Level 1* – Defined as observable inputs such as quoted prices in active markets.

*Level 2* – Defined as inputs other than quoted prices in active markets that are either directly or indirectly observable.

*Level 3* – Defined as unobservable inputs in which little or no market data exists therefore requiring an entity to develop its own assumptions.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There were no Plan assets requiring use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair values of mutual funds and the money market fund are based on quoted net asset values of the shares held by the Plan at year-end. The fair value of common stock is based on the closing price reported on the active market where the individual securities are traded.
