### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Liberty Hill Equity Partners 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### Note 1. Description of Plan

On November 17, 2021, the Plan changed names from the River Trading Company, Ltd 401(k) Profit Sharing Plan to the Liberty Hill Equity Partners 401(k) Profit Sharing Plan. The following description of the Liberty Hill Equity Partners 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan established for the benefit of nonunion employees of River Trading Company, Ltd. (the Plan Sponsor and Company) and defined participating related employers. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). Effective August 15, 2023, the Plan was amended and restated to remove the trust agreement within the basic plan document to become a separate, independent trust agreement without altering the substance thereof. Effective January 1, 2024 the Plan was amended to update participating entities in the Plan. The Plan was also amended on April 1, 2024, to update the service requirements for eligibility.

The Plan Administrator is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance. Fidelity Management Trust Company (Fidelity) is trustee and recordkeeper of the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**Eligibility:** Employees of the Plan Sponsor who have reached 18 years of age and have completed 500 hours within 12 months of continuous service are eligible for employer matching, a discretionary match and salary deferral features of the Plan. The Plan was amended effective April 1, 2024, to update the service requirement to three months of continuous service for employer matching, a discretionary match and salary deferral features of the Plan.

**Contributions:** Each year, participants may contribute a flat dollar amount or a percentage of their annual pretax or Roth (after tax) compensation as determined by the Plan Administrator, up to the maximum dollar amount permissible under Section 402(g) of the IRC. For calendar year 2024, participants at least 50 years of age may contribute an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct their contributions into various investment options offered by the Plan. Participants may change their investment selections and increase or decrease contributions online at any time.

The Plan is a safe harbor 401(k) plan that utilizes a basic match formula. Under the basic match formula, the Plan Sponsor contributes fully vested matching contributions as follows: 100% of a participant's first 3% of deferrals plus 50% of the next 2% of a participant's deferrals. The Plan Sponsor may also make an additional discretionary match at the end of each Plan year. The Plan Sponsor elected to fund the additional discretionary match in the amount of \$535,407 for 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's matching contributions and discretionary match, and an allocation of Plan earnings. The contributions are allocated within each participant account based upon the participant's investment selections to the various fund options offered under the Plan. Participant accounts are charged with defined administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Description of Plan (Continued)

**Vesting:** Participants are vested immediately in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's additional discretionary match contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Payment of benefits:** On termination of service, a participant will receive installment payments or a lump-sum amount equal to the value of the participant's vested interest in their account. Participants may request in-service withdrawals of elective deferrals and discretionary matching contributions provided the participant has attained age 60, has completed five years of service and they are 100% vested in the source of the withdrawal. Participants may also request hardship withdrawals of elective deferrals.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$65 and \$14, respectively. These accounts are used to pay Plan expenses, reduce employer contributions or reinstate forfeited account balances of former participants as stated in the Plan document. Forfeitures used to pay Plan expenses for the year ended December 31, 2024, was \$78.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividend income.

**Contributions:** Participant contributions are recognized when earned. Employer safe harbor matching contributions are recognized concurrently with contributions, and employer discretionary match contribution is recognized on an annual basis.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by the Plan's Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

#### Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions in accordance with ERISA.

#### Note 5. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity, the servicing agent, or an affiliate of the servicing agent. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. Fees paid directly by the Plan to Fidelity for administrative services amounted to \$45,096 for the year ended December 31, 2024.

#### Note 6. Tax Status

The Plan operates under a preapproved plan sponsored by Fidelity. The preapproved plan has received an opinion letter, dated June 30, 2020, from the IRS as to the preapproved plan's qualified status. The opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### Note 7. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Self-directed brokerage accounts:** Accounts primarily consist of government bonds and money market funds. These investments use the valuation methodology of like investments within the Plan.

**Mutual funds:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common collective trust fund:** Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
