**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Goodwill of Southwestern Pennsylvania 403(b) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 - PLAN DESCRIPTION

The Goodwill of Southwestern Pennsylvania 403(b) Plan (Plan) is a defined contribution 403(b) plan covering substantially all employees of Goodwill of Southwestern Pennsylvania (Goodwill). The following description of the Plan provides only general information. Plan participants should refer to the Plan document for a complete description of the Plan.

Full-time employees and part-time employees become eligible to contribute to the Plan immediately upon reaching the age of 18 and become eligible to receive matching contributions upon completing 1,000 hours of service or having one year of service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective July 1, 2022, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a Principal Lifetime Fund based on the participant's current age and the Plan's normal retirement date until changed by the participant. Goodwill matches contributions to the Plan for participating employees of 25% of the employee's contribution up to 10%, for a maximum employer contribution of 2.5%. Participants may also contribute amounts that represent distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options deferred by the Plan.

Each participant's account is credited with the participant's contribution, Goodwill's matching contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, as defined in the Plan document, or account balances.

Amounts contributed by Plan participants and the earnings thereon are fully vested and nonforfeitable. Participants vest in the employer matching contributions in accordance with the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
2 but less than 3 years	25%
3 but less than 4 years	50%
4 but less than 5 years	75%
5 years or more	100%

At December 31, 2024 and 2023, forfeited nonvested accounts were not significant and are used to reduce future employer contributions to the Plan. The amount of forfeited nonvested accounts utilized to reduce employer contributions during the year ended December 31, 2024 was insignificant to the Plan.

Normal retirement age is 65. Upon termination of employment due to death, disability, retirement or other reasons, the entire balance of the employee's account may be paid to the employee or his or her beneficiary in a lump sum (with restrictions), lifetime annuity, partial payments and installment payments not to exceed the life expectancy of the participant. If the employee terminates employment for any reason other than retirement, disability or death, he or she may receive a lump-sum payment distribution of the full value of the vested percentage of the participant's contribution account. Hardship and in-service distributions may also be granted in accordance with the guidelines of the Employee Retirement Income Security Act of 1974 (ERISA) and the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, including contingent assets and liabilities at the date of the financial statements and changes therein. Actual results could differ from those estimates.

**Investments** - Investments in mutual funds are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

As described in the Financial Accounting Standards Board (FASB) Accounting Standards Codification (Codification), investment contracts that are fully benefit-responsive held by a defined contribution plan are required to be reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a guaranteed investment contract (GIC). The statements of net assets available for benefits present the contract value of the investment in the GIC at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance for a term not to exceed five years with the exception of a loan for the purchase of a principal residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time of the loan as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. The Plan allows participants to have two outstanding loans at any time.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments, and the Plan administrator deems the participant's loan balance to be in default, the participant loan is reduced, and a benefit payment is recorded.

**Excess Contributions Payable** - Amounts payable for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

**Payment of Benefits** - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by Goodwill and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Operating expenses, such as management and administrative fees, are charged directly to the participant's account and are included in administrative expenses. Additionally, fees related to the processing of distributions are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events - Management has evaluated subsequent events through October 1, 2025, the date on which the financial statements were issued, and did not identify any events or transactions requiring adjustment to or disclosure in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Codification topic Fair Value Measurement are described as follows:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 - FAIR VALUE MEASUREMENT (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN CUSTODIAN (UNAUDITED)

Certain information related to investments and notes receivable from participants that is disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Trust Company (Principal) (the custodian of the Plan).

NOTE 5 - GUARANTEED INVESTMENT CONTRACT

The Principal Life Insurance Company (PLIC) Fixed Income Option, Non-401(a) (PFIO) is a benefit-responsive group annuity contract issued by PLIC. The methodology for calculating the interest crediting rate is defined under the terms of the contract. Changes in future interest crediting rates will not affect the amount reported on the statements of net assets available for benefits representing the adjustment for the portion of net assets attributable to fully benefit-responsive investment contracts from fair value to contract value, because fair value is considered to be book value less early withdrawal charge.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT (Continued)

Because the PFIO is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investments options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the Plan to qualify for exemption under ERISA; or (5) premature termination of the contract. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.

The GIC does not permit PLIC to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - FEDERAL INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED-PARTY TRANSACTIONS

The Plan invests in mutual funds and a GIC managed by Principal or its affiliates. In addition, Goodwill may pay certain administrative expenses or perform administrative functions on behalf of the Plan, for which no fees are charged. These transactions qualify as party-in-interest transactions that are allowable under ERISA.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, Goodwill has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
