Independent Auditor's Report

To the Investment Committee

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Management Consulting, Inc. Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan

The following description of the Management Consulting, Inc. Profit Sharing 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan covering all eligible employees of Management Consulting, Inc. and Mancon, LLC (collectively “the Company”). The Plan is subject to the provisions of ERISA. The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

*Contributions:* Each year, participants may contribute between 1% and 100% of their annual compensation, up to the maximum allowed by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective January 1, 2025, there is an increased catch-up limit for participants ages 60 to 63. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may make matching contributions equal to a discretionary percentage of salary deferrals for eligible participants. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

*Participant accounts:* Each participant's account is credited with the participant’s contributions and Company matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting:* Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their account is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

*Notes receivable from participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant’s account. The loan interest rate is set by the Plan administrator at a reasonable rate of interest, which is comparable to fixed interest rates currently being charged by commercial lenders for loans of comparable risk on similar terms and for similar durations. Principal and interest is paid ratably through payroll deductions.

Effective November 1, 2024, participants impacted by a federally declared disaster have the option of borrowing the lesser of \$100,000 or 100% of their vested account balance. Repayments on these loans may be delayed for up to one year.

*Payment of benefits:* On termination of service, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or, effective May 1, 2024, substantially equal installments over a fixed period. Annuities may be purchased subject to certain limitations. In-service withdrawals are permitted for participants who have attained age 59 ½ or for a qualified financial hardship. Effective November 1, 2024, penalty-free withdrawals are also available for victims of domestic abuse and participants impacted by a federally declared disaster.

*Forfeited accounts:* As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$247,956 and \$76,933, respectively. These accounts will be used to reduce employer contributions or to pay administrative expenses of the Plan. In 2024, employer contributions were reduced by \$249,000 from forfeited nonvested accounts. Also, in 2024, \$548 from forfeited nonvested accounts was used to pay Plan administrative expenses.

## **2. Summary of Accounting Policies**

*Basis of accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment valuation and income recognition:* Investments are reported at fair value (except for the collective investment trust sponsored by Reliance Trust Company which is reported at contract value – see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the trustee of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Contributions:* Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

*Notes receivable from participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Excess contributions payable:* Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025, and March 15, 2024, respectively.

*Payment of benefits:* Benefits are recorded when paid.

*Expenses:* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping, the administration of notes receivable and benefits paid are included in administrative expenses. Fees paid directly by the Plan for investment advisory services are included in investment expenses. Investment-related expenses paid indirectly through revenue sharing arrangements are included in net appreciation of fair value of investments.

*Subsequent events:* The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trusts:* Valued at the net asset value (“NAV”) of the units held. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. The NAV is published daily and available to plan participants. The NAV is the basis for current transactions and units of the trusts can be redeemed at NAV as of the measurement date.

#### **4. Reliance Trust Company Stable Value Fund**

The Plan participates in a collective investment trust sponsored by Reliance Trust Company (“RTC”) totaling \$4,788,168 for 2024 and \$4,543,322 for 2023. The collective investment trust invests in a fully benefit-responsive group annuity contract issued by Metropolitan Life Insurance Company (“MetLife” or “issuer”). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MetLife is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by MetLife but may not be less than zero. The crediting rate is reviewed quarterly for resetting.

The group annuity contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include:

1. Plan Termination;
2. Offering of a "competing fund" by the Plan (e.g., a fixed income fund with a targeted duration of three years or less);
3. Establishment of a new plan covering Plan participants that offers a competing fund; or
4. Participant withdrawal requests on advice or direction from the Plan Sponsor, Plan administrator, Plan fiduciary, or agent of any of the foregoing to do so.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

1. The Plan ceasing to qualify as an eligible plan;
2. A withdrawal that is necessary to preserve the trust's legal or tax status;
3. The Plan is in any way not in compliance with the terms and conditions upon which it was admitted to the trust;
4. Failure by the Plan to timely submit compliance evidence; or
5. The Plan fails to execute a new participation agreement, or such other documents reasonably required by RTC after RTC requires that it do so as a condition to continuing participation in the trust.

## **5. Related Party Transactions and Party-in-Interest Transactions**

Principal and its affiliates execute all investment transactions within the participant-directed trust, maintain custody of all investments and perform participant recordkeeping. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity. These transactions qualify as exempt party-in-interest transactions.

## **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## 7. Tax Status

The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan has been amended since receiving the advisory opinion letter, the Plan administrator and the pre-approved plan sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

## 9. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal.
