INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of Crest Automotive Group Employees' Profit Sharing Plan 401(k)

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Crest Automotive Group Employees' Profit Sharing Plan 401(k) ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE A - Description of Plan:

The following brief description of the Crest Automotive Group Employees' Profit Sharing Plan 401(k) ("the Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

1. General - The Plan is a defined contribution Plan covering substantially all employees of Eastview, Inc. dba Crest Ford of Flat Rock, Crest Automotive, Inc. dba Crest Ford, Crest Lincoln, Inc. and Eastview Holdings, Inc. ("Company") who are age twenty-one or older and have one year of service. One year of service is defined as 1,000 hours of service. Entry dates into the Plan are on 1/1 and 7/1 only. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is provided as a pre-approved Plan by North American Pension Services, Inc.
2. Contributions - Eligible employee participants may authorize their employer to withhold from 1% to 100% of their compensation, as defined in the Plan, as a pre-tax, Roth or post-tax elective deferral contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from another retirement Plan. Segregated accounts are maintained for each participant. The participant directs the investment of those amounts among a selection of 24 mutual funds, one stable value fund collective investment trust and a money market account offered by John Hancock Trust Company, LLC. The Company matches 50 percent of a participant's elective deferrals maxed at 4 percent of the participant's compensation. Additional discretionary amounts may be contributed at the option of the Company. Contributions are subject to certain limitations.
3. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the portion of their accounts funded by employer's matching and discretionary contributions plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service or if at any time the participant dies or becomes totally and permanently disabled. The vesting schedule is as follows:

NOTE A - Description of Plan (continued):

5. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear an interest rate ranging between 4.25% and 9.50%, which is commensurate with local prevailing rates. As of December 31, 2024 and 2023, the balance of outstanding loans was \$266,992 and \$254,589, respectively. Principal and interest is paid ratably through monthly payroll deductions.
6. Forfeited Accounts - At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$17,599 and \$6,982, respectively. These accounts will be used to reduce future employer contributions. Also, for the year ended December 31, 2024, employer contributions were reduced by \$5,383 from forfeited nonvested accounts.
7. Payment of Benefits - On termination of service due to any reason, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over a certain period. In addition, hardship distributions are permitted if certain criteria are met.

NOTE B - Summary of Significant Accounting Policies:

1. Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.
2. Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.
3. Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

On each Statement Date, a proportionate share of the investment earnings (or losses, if any) of a participant's selected investment funds will be allocated to their account(s).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Excess contributions - Amounts payable to participants, including earnings, totaling \$55,428 and \$38,646 for contributions in excess of amounts allowed by the IRS are recorded as a liability as of December 31, 2024 and 2023, respectively. The amounts for December 31, 2024 and 2023 are included in benefits paid to participants. The Plan has distributed the 2024 and 2023 excess contributions, including earnings, to the applicable participants in 2025 and 2024, respectively.

NOTE B - Summary of Significant Accounting Policies (continued):

5. Administrative expenses - Certain administrative expenses of the Plan are paid directly by the Company and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.
6. Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
7. Payment of Benefits - Benefits are recorded when paid.
8. Subsequent Events - Subsequent events were evaluated through August 5, 2025, which is the date the financial statements were available to be issued.

NOTE C - Fair Value Measurements:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Mutual Funds/Money Market: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: The fair value of collective investment trusts for which quoted market prices are not available are based on the underlying securities less its liabilities. The investments are measured at fair value using net asset value per share (or its equivalent) as a practical expedient, and therefore; is not categorized in the fair value hierarchy.

The preceding methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA at any time. In the event of Plan termination, participants would become fully vested in their employer contributions.

NOTE E - Tax Status:

The Internal Revenue Service has determined and informed the custodian, North American Pension Services, Inc. in an opinion letter dated June 30, 2020, that the pre-approved Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE F - Unaudited Information Certified by the Plan's Custodian:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, John Hancock Trust, LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and December 31, 2023, and the Supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE G - Related-Party/Party-in-Interest Transactions:

Certain Plan investments are managed by John Hancock Trust Company, LLC. John Hancock Trust Company, LLC is the Plan custodian. North American Pension Services, Inc. is the third party administrator. LPL Financial Corporation, Inc. is the Plan investment advisor. Administrative fees were paid by the Plan to John Hancock Trust Company, LLC and LPL Financial Corporation for their respective services noted above, in the amount of \$92,419 for the year ended December 31, 2024. John Hancock Trust Company, LLC and LPL Financial Corporation are service providers to the Plan and, therefore, these transactions and the Plan's payment of fees to these service providers qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE H - Risks and Uncertainties:

The Plan invests in a variety of investment options. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
