### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

---

#### (1) DESCRIPTION OF THE PLAN

The following description of the Dolese Bros. Co. Profit Sharing Plan (the “Plan”) provides general information. Participants should refer to the plan agreement for a complete description of the Plan’s provisions.

##### General and Eligibility

The Plan is a defined contribution plan covering certain employees of Dolese Bros. Co. (the “Company”). All employees, with the exception of nonresident aliens, leased employees, and those with collective bargaining agreements, are eligible to participate in the Plan and receive a portion of the allocated contribution after completion of 1 year of service in which the employee completes 1,000 hours of service. Eligible employees must be employed on the last day of the plan year, unless the participant terminated during the plan year due to death, permanent disability, or reaching the normal retirement date, as defined in the plan agreement. A participant enters the Plan on the first day of the first pay period in the month following the month in which the participant meets the service eligibility requirement. The Plan is subject to the provisions of the Department of Labor’s Rules and Regulations under the Employee Retirement Income Security Act of 1974 (ERISA).

##### Administration

The Company serves as the plan administrator. The Plan’s Retirement Committee (the “Committee”) has the overall responsibility for the Plan. This includes the power to interpret the provisions of the Plan and to determine questions concerning eligibility, participation, and benefits and such other powers and duties as are necessary to the operation of the Plan. The Committee determines the appropriateness of the Plan’s investments and monitors investment performance.

During 2024 and 2023, Charles Schwab Trust Bank (“Charles Schwab”) was the investment custodian and trustee for the Plan’s certified investments.

##### Contributions and Investment Options

Contributions by the Company are at the discretion of the Board of Directors of the Company, and shall not exceed the maximum amount deductible by the Company for income tax purposes.

##### Participant Accounts

Company contributions are allocated to participants’ accounts based on the ratio in which each individual participant’s compensation bears to the total compensation of all participants. Earnings or losses are allocated to each participant based on the ratio of a participant’s account balance at the beginning of the plan year, less subsequent distributions, to the total account balances at the beginning of the plan year for all participants, less subsequent distributions. The benefit to which a participant is entitled is limited to that benefit that can be provided from the participant’s vested account balance.

See Independent Auditors’ Report.

(1) **DESCRIPTION OF THE PLAN, CONTINUED**

**Vesting**

For the Company's contributions, participants vest 20% after 2 years of service, 40% after 3 years, 60% after 4 years, becoming fully vested after 5 years of service. Upon termination due to death or disability, participants are immediately 100% vested in the Company's contributions.

**Payment of Benefits**

All distributions are based on the latest completed annual valuation of the Company. If the valuation for the latest plan year-end has not been completed at the time a participant requests a distribution, the participant can receive 70% of their vested account balance based on the last completed annual valuation. The remainder of their vested account balance will be issued after the completion of the valuation for the latest plan year-end. Upon death, permanent disability, or termination of service, participants may elect to receive a lump sum or installment amounts equal to the value of his or her vested account balance.

**Forfeitures**

Forfeited nonvested accounts are used to restore forfeitures, fund Company contributions, or to pay plan expenses. During 2024, the Plan used approximately \$271,000 of forfeitures to fund Company contributions and approximately \$152,000 to pay plan expenses. At December 31, 2024 and 2023, there was approximately \$464,000 and \$271,000, respectively, remaining in the forfeitures account to be used to fund or pay the aforementioned items.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Concentration of Investments**

Included in investments at December 31, 2024 and 2023, were shares of the Company's common stock valued at \$88,269,966 and \$69,372,060, respectively. This investment represents 69% and 65% of total investments at December 31, 2024 and 2023, respectively. A significant decline in the market value of the Company's common stock would significantly impact the net assets available for plan benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for plan benefits. In addition, certain investment-related expenses are included as a reduction in net appreciation or included in net depreciation in fair value of investments presented in the statement of changes in net assets available for plan benefits.

**Subsequent Events**

The Plan's trustee has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued, and determined that no subsequent events have occurred that require adjustment to or disclosure in the financial statements.

(3) **INFORMATION CERTIFIED BY THE TRUSTEE**

Effective January 3, 2023, the Plan's trustee and custodian changed from Bank of Oklahoma Financial, N.A. to Charles Schwab.

**Information Certified by Charles Schwab**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee and custodian have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate.

- Investments (money market fund, mutuals funds, collective trust funds, and government obligations) and non-interest-bearing cash as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Investment activity (net appreciation in fair value of investments, interest, and dividends) as shown in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.
- Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the supplemental schedule.
- Schedule H, line 4j—Schedule of Reportable Transactions for the year ended December 31, 2024, as shown on the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) **FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

(4) FAIR VALUE MEASUREMENTS, CONTINUED

Following are descriptions of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual and Money Market Funds

Mutual and money market funds are valued using quoted market prices, as all have active markets.

Government Obligations

The fair values of investments in government obligations are based on quoted market prices for active markets where available. If quoted market prices for active markets are not available, fair values are obtained from pricing services, based on quoted market prices of comparable instruments, bid/ask quotes, or the use of discounted cash flow models using observable inputs such as current yields, credit risks, and prepayment speeds.

Collective Trust Funds

Collective trust funds are valued based on the net asset value (NAV) of units held in the collective investment trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investments for amounts different than the reported NAV.

Dolese Bros. Co. Common Stock

Dolese Bros. Co. common stock (class B, nonvoting) is reported at fair value, based upon an independent appraisal. The appraisals for 2024 and 2023 were based upon a weighted average of various methods of the income and market approaches. The appraisers and the Plan’s management concluded that a market participant would also recognize a discount for lack of marketability and control. The unobservable inputs are described in the following table:

(4) FAIR VALUE MEASUREMENTS, CONTINUED

The valuation process involves the Committee's selection of an independent appraiser on an annual basis. The Committee and the Plan's management support the appraisal process by meeting with the appraiser and providing data as requested from the audited financial statements of the Company and other information. The appraiser prepares a preliminary report for management's review and discussion purposes.

The methods described above may produce fair values that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**(5) RISKS AND UNCERTAINTIES**

In general, the investments made by the Plan are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**(6) INCOME TAX STATUS**

Effective January 1, 2023, the Plan was amended and restated under a non-standardized, pre-approved plan sponsored by Milliman, Inc. Milliman, Inc. has received an advisory letter, dated June 30, 2020, as to the pre-approved plan's qualified status. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(7) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants would become 100% vested in their accounts.

**(8) RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments held were managed by Charles Schwab, who is also the trustee of the Plan's investments. Transactions relating to the investments managed by the trustee qualify as party-in-interest transactions.

During 2024 and 2023, the Plan invested in the Schwab Government Money Fund, which was managed by Schwab Asset Management, an affiliate of the Charles Schwab Corporation, and therefore the transactions in the fund qualified as party-in-interest transactions.

The Plan invests in the Company's Class B, non-voting common stock. Transactions with the Company are considered related-party and party-in-interest transactions. There were no contributions or distributions of Company stock to or from the Plan during 2024 or 2023. At both December 31, 2024 and 2023, the Plan held 119,607 shares of the Company's Class B, non-voting common stock.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The Plan also made direct payments to service providers.
