Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Watchpoint Logistics, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 – DESCRIPTION OF PLAN

The Watchpoint Logistics, Inc. 401(k) Profit Sharing Plan (the “Plan”) is designed to reward eligible employees for long and loyal service by providing them with retirement benefits.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established effective January 1, 1989 to provide retirement benefits for the employees of Watchpoint Logistics, Inc. (the “Plan Sponsor”). The Plan is a defined contribution plan covering employees of the Plan Sponsor and Watchpoint Transportation LLC who have attained the age of twenty-one (21) and have completed one month of service. The Plan is designed to comply with section 401(k) of the Internal Revenue Code (the “Code”) and is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). Two employees of the Plan Sponsor serve as the Plan’s trustees. Standard Insurance Company is the custodian of the Plan’s assets.

Plan Year

The Plan year begins January 1 and ends December 31.

Contributions to the Plan

The Plan allows for the following types of contributions:

Employee Salary Deferral 401(k) Contributions

The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Code. Employees may voluntarily contribute up to 100% of their eligible compensation, subject to various nondiscrimination tests and limitations prescribed by the IRS Code. Employee salary deferrals include both pre-tax elective deferrals and Roth after-tax elective deferrals.

Employer Safe Harbor Matching Contributions

The Plan Sponsor makes safe harbor matching contributions equal to 100% of a participant’s elective salary deferrals up to 4% of the participant’s compensation. The Plan Sponsor made safe harbor matching contributions of \$253,606 for the year ended December 31, 2024, which includes \$8,954 of prior years’ excess employer contributions.

Employer Discretionary Profit-Sharing Contributions

The Plan Sponsor may make profit sharing contributions equal to a discretionary amount. Profit sharing contributions are allocated to participants based on an integrated formula as defined by the Plan document. Participants must be employed with the Plan Sponsor on the last day of the Plan year and complete 1,000 hours of service during the Plan year to be eligible for an allocation of employer profit sharing contributions. The Plan Sponsor elected not to make a profit-sharing contribution for the year ended December 31, 2024.

Employee Rollover Contributions from Another Qualified Plan

Participants may make rollover contributions from another qualified plan. For the year ended December 31, 2024, rollover contributions were \$28,107.

Participant Accounts and Allocations

The Plan provides various investment fund options and allows participants to direct their investments. Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions, rollover contributions, and employer safe harbor matching contributions. Employer discretionary contributions are subject to a graded vesting schedule as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

For vesting purposes, a year of service is equivalent to 1,000 hours of service during the Plan year.

Forfeitures

Forfeitures may be used to pay reasonable Plan expenses and reduce the amount of employer discretionary contributions for the Plan year in which the forfeiture occurs. There were no forfeitures used to pay Plan expenses or reduce employer contributions for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeiture ending balances included in plan net assets were \$25,950 and \$25,416, respectively.

Excess Employer Contributions

Excess employer contributions may be used to reduce the amount of future employer discretionary contributions. At December 31, 2024 and 2023, excess employer contributions ending balances included in plan net assets were \$2,075 and \$10,768, respectively. During the year, \$8,954 was applied to the employer's safe harbor matching contributions.

Retirement

Normal retirement under the Plan is age 65.

Notes Receivable from Participants

The Plan allows participants to borrow against their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the participants' vested account balance. Loans are secured by the balance in the participant's account and bear interest charged at a commercially reasonable rate as determined by the Plan's administrator. Principal and interest are paid ratably through payroll deductions and loan periods shall not exceed five years, except for loans made for the purchase of a principal residence, which may not exceed 10 years. At December 31, 2024, interest rates on participant notes range from 4.25% to 9.5%, with maturities through April 2028.

Payment of Benefits

Payment of benefits may be made at the following times under the Plan:

1. Normal retirement
2. Termination of employment of the participant
3. Death or disability of the participant
4. Upon demonstration of financial hardship, or
5. Attainment of age 65

Benefit payments are made in installment or lump sum payments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Administrative Expenses

Fees and expenses incurred in the administration of the Plan, to the extent not paid by the Plan Sponsor, are charged to and paid from the Plan's assets. Expenses related to specific participant transactions are charged to the respective participant's account.

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Contributions Receivable

Employee and employer contributions receivable are recorded in the financial statements for amounts contributed but not received by the Plan as of year-end.

Investment Valuation and Income Recognition

Investments are reported at fair value which is based on underlying quoted market prices when available. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date and includes capital gain distributions. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Increases in the share values of investments are reflected in each participant's self-directed account. Investments are valued daily.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The Plan adopted a volume submitter plan which obtained a favorable opinion letter on March 31, 2014 in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter, however the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however, there are currently no examination for any tax periods in progress. The Plan's income tax returns remain subject to examination for the years 2021 through 2023 for federal purposes and the years 2020 through 2023 for state purposes.

Estimates and Assumptions

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Cash and Cash Equivalents

The Plan considers highly liquid investments with an original maturity of three months or less to be cash and cash equivalents.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

Pooled separate accounts: Pooled separate accounts invest mainly in mutual funds and stocks, both domestic and international. The majority of the underlying assets have Level 1 quoted pricing inputs and observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets.

Stable value fund: Composed primarily of fully benefit-responsive investment contracts and valued at net asset value (NAV) of units of insurance company stable value fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Standard Insurance Company. Standard Insurance Company is the custodian of the Plan's assets. Fees paid by the Plan for investment management and advisory services are recorded in net appreciation in fair value of investments. Fees for certain administrative expenses are paid to Standard Insurance Company, the record keeper and third-party administrator of the Plan. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 8 – SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 1, 2025, the date the financial statements were available to be issued. Management has determined that no additional subsequent events have occurred that should be disclosed in the financial statements.
