Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of West Ohio Community Action Partnership's 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of West Ohio Community Action Partnership Employee Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note A – Description of Plan

The following description of West Ohio Community Action Partnership's ("Organization") 403(b) Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General – The Plan is a defined contribution plan covering all full-time employees of the Organization who have one year of service and are 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A Fiduciary Committee oversees the governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

B. Contributions – Each year, participants may contribute up to the amount allowed by the Internal Revenue Code. Eligible employees can make deferrals beginning on their date of hire. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the IRS.

C. Rollover Contributions – The Plan permits rollover contributions subject to approval by the Plan Administrator.

D. Organization Contribution – The Organization is bound by a collective bargaining agreement with the Union to contribute 4 percent of an eligible participant's pay to the Plan. Eligible employees will start receiving the 4 percent employer contribution after 1 year of service at the beginning of the next Plan year quarter. The Organization contribution is invested directly in the mutual funds in the same ratio as what the participant contributions are.

E. Participant Accounts – Participants direct the investment of their contributions into various mutual funds as investment options offered by the Plan under their separate account. Each participant's account is credited with their individual contributions, the Organization's contributions, earnings, losses, and an allocation of expenses within their account activity.

F. Vesting – All participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion is done using a six-year graded schedule unless a participant incurs a severance from employment as a result of death or disability. If this occurs, a participant is considered 100% vested in the Organization's contribution. In addition, participants are considered 100% vested if they are employed on or after their normal retirement age.

Note A – Description of Plan (continued)

G. Notes Receivable from Participants – The Plan allows participant loans from their funds within the Plan with a minimum amount of \$1,000 and a maximum of 50% of the participant's account balance. The notes are secured by the balance in the participant's account. Principal and interest, at a rate of prime plus 1%, are paid ratably through payroll deductions. Loans outstanding at December 31, 2024 have interest rates ranging from 4.25% to 10.50%. As of December 31, 2024, no allowance for credit losses has been recorded.

H. Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments.

I. Forfeited Accounts – Forfeited accounts are used to reduce the Organization's future contributions to participant accounts. Available forfeitures at December 31, 2023 were \$59. Forfeitures totaled \$6,919 during 2024; \$5,600 was used to reduce employer contributions, and \$43 was net appreciation on the forfeitures during the year. Available forfeitures at December 31, 2024 were \$1,421.

Note B – Summary of Accounting Policies

Basis of Accounting

These financial statements have been prepared on an accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance companies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received and posted in the participant's accounts. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded as repayments are made by the participants.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All expenses of maintaining the plan are paid by the Organization and are excluded from these financial statements.

Note C – Investments

The Plan provides for investment in one guaranteed investment contract and several pooled separate accounts. These securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation/(depreciation) in fair value of investments.

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$459,820.

Note D – Fair Value Measurement

Generally accepted accounting principles include a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

Pooled Separate Accounts – Valued based on the net asset value of units as determined by the insurance company. Net asset value is a readily determinable fair value and is the basis for current transactions. The Plan had \$3,333,504 invested in pooled separate accounts at December 31, 2024.

Guaranteed Investment Account – The fair value for the fixed contract is equal to the book value less any market value adjustment. The Plan had \$194,911 in the guaranteed investment account which is included in Level 3 of the fair value hierarchy at December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has a guaranteed investment contract with Nationwide. Nationwide maintains the contributions in a general account. The account is credited with earnings on the underlying investments. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The fixed contract rate on the guaranteed investment contract was 1.95% for 2024. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note E – Trustee Certification

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Nationwide is the trustee for West Ohio Community Action Partnership 403(b) Retirement Plan. Accordingly, as permitted under such election, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate: investments including participant loans, interest, and dividend income, net appreciation/(depreciation) of investments, and the schedule of assets held for investment purposes.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing the information provided by the custodian to the related information included in the financial statements and supplemental schedule.

Note F – Transactions with Parties-in-Interest

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments were shares of mutual funds and a common trust fund managed by an affiliate of Nationwide throughout 2024. Nationwide is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Note G – Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, as amended. In the event of Plan termination, participants are 100 percent vested in their employer contributions.

Note H – Tax Status

The Plan was established using a prototype model which management and the administrator believe is in compliance with Internal Revenue Service regulations. The Organization contracts with Nationwide for third party administration services. Nationwide provides services to amend the Plan when necessary to keep the Plan in compliance with the regulations. Nationwide also provides services to test compliance and non-discrimination within the Plan.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note I – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note J – Subsequent Events

Subsequent events have been evaluated through September 11, 2025, which is the date the financial statements were available to be issued.
