### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1. Plan Description**

### General

The Murray Equipment, Inc. 401(k) Salary Reduction Plan & Trust (the "Plan") is a defined contribution plan sponsored by Murray Equipment, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

### Eligibility

To be eligible to participate in the Plan, employees must be 18 years of age or older and have completed three months of eligible service. Employees may enter the Plan on the first day of the quarter following the completion of all eligibility requirements.

### Participant Contributions

Participants may make voluntary pre-tax and Roth contributions up to the dollar limits set by the Internal Revenue Code. Participants who have attained age 50, before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

### Company Contributions

The Company provides a safe harbor contribution equal to 3% of the eligible participant's compensation. The Company also provides a matching contribution up to \$100 for each eligible participant. To be eligible for the matching contribution, participants must make contributions to the Plan. The Company may also make a discretionary profit sharing contribution, determined annually. To be eligible for the discretionary profit sharing contribution, participants must be employed on the last day of the Plan year and must meet a minimum service requirement of 1,000 hours during the Plan year.

### Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions and Plan earnings and is charged with distributions and an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants have the option of investing in various investment options offered through Lincoln Financial Group Trust Company, Inc. All amounts in participant accounts are participant-directed and allocations can be changed daily.

## **Note 1. Plan Description (Continued)**

### Vesting

Participants are immediately vested in their elective contributions and all Company contributions and any income or loss thereon.

### Forfeitures

Forfeitures may result from certain plan corrections. These funds can be used to reduce future Company contributions or pay Plan expenses. During 2024, forfeitures were not used to reduce Company contributions or pay Plan expenses. The amount of forfeitures held by the Plan at December 31, 2024 and 2023, was approximately \$6,699 and \$6,300, respectively.

### Benefit Payments

Participants who have satisfied the requirements for distributions through normal retirement, death or disability, or termination of employment may elect to receive a distribution from the Plan as a single lump-sum, installment or an annuity payment. A participant may remain in the Plan as an inactive participant if their account balance is greater than \$5,000. Hardship distributions are permitted up to the amount of immediate need, as defined in the Plan document.

### Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts and a lump sum distribution will be made to the participant.

## **Note 2. Significant Accounting Policies**

### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

## **Note 2. Significant Accounting Policies (Continued)**

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, custodian, and third party administrator. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Benefit Payments

Benefit payments to participants are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net realized and unrealized appreciation in fair value of investments.

### Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through September 24, 2025, the date the financial statements were available to be issued.

**Note 3. Financial Statement Information Certified by Lincoln Financial Group Trust Company, Inc**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Lincoln Financial Group Trust Company, Inc, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, including interest from guaranteed investment contract and net realized and unrealized appreciation in fair value of investments.
- c. Schedule of assets (held at end of year).

**Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## **Note 4. Fair Value Measurements (Continued)**

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts ("PSA"):* Valued at net asset value ("NAV") at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2024 and 2023, respectively.

*Stable value fund:* A stable fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values ("NAV") of shares held by the Plan at year end.

*Common/collective trust fund:* Valued at the NAV provided by the administrator of the fund. The NAV is based on underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The primary investment objective of the fund is the preservation of capital. The fund invests primarily in fixed income securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 6. Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype document adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **Note 7. Transactions with Parties-In-Interest**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments at December 31, 2024 are shares of an investment contract managed by Lincoln Financial Group Trust Company, Inc as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain administration expenses are paid by the Company on behalf of the Plan. The Company also provides certain administrative services at no cost to the Plan.

## **Note 8. Risks and Uncertainties**

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
