## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
the AFI 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AFI 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AFI 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of AFI 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AFI 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### 1. Description of Plan

The following description of the AFI 401(k) Savings Plan (the "Plan"), provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all full-time non-union employees of All-Fill, Inc., Auger Fabrication, Inc., and pursuant to a participation agreement effective January 1, 2024, Phlex Formulations and Packaging LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon attaining 18 years of age and completing three months of service. An employee will enter the Plan on the first day of the month following the date the eligibility conditions described above are satisfied.

**Contributions** – Participants can elect to defer up to 100% of eligible compensation, subject to applicable IRS limitations. A participant's compensation, for federal tax purposes, shall be reduced by the amount of the elected pre-tax deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions to the Plan subject to statutory limitations. A participant may designate all or a portion of their 401(k) elective deferral contributions, including catch ups, as Roth 401(k) contributions.

The Plan includes an automatic enrollment and an automatic deferral increase provision whereby all newly eligible employees are automatically enrolled in the Plan. Employees hired on or after June 1, 2017 are automatically enrolled into the Plan at a deferral rate of 3% of eligible compensation unless the employee specifies otherwise or opts out of the Plan. On an annual basis, the participant's deferral rate under the automatic increase provision will be increased by 1% up to a maximum of 10% of eligible compensation, although participants can affirmatively elect to defer more than 10% of eligible compensation into the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Discretionary employer matching contributions may be made to the Plan by the Company. The Company in its sole discretion will determine how much, if any, will be contributed as a matching contribution to the Plan. Such matching contribution amounts can be determined either as a uniform percentage of participant deferral contributions or as a flat dollar amount for each participant. For the year ended December 31, 2024, the Company contributed 10% of the participant's deferral contribution on a per payroll basis resulting in employer matching contributions to the Plan of \$131,739. The employer may elect to make a safe harbor 401(k) contribution for any plan year. If elected, this contribution will take the form of a safe harbor non-elective contribution, a safe harbor basic matching contribution, or a safe harbor enhanced matching contribution. Refer to the Plan document for the applicable formulas to calculate the safe harbor contributions. For the year ended December 31, 2024, the Company did not make any safe harbor contributions to the Plan.

The Company may also make discretionary profit-sharing contributions to the Plan. The discretionary profit-sharing contribution will be allocated on a pro rata basis based on a uniform percentage of eligible Plan compensation. During 2024, the Company made a discretionary profit-sharing contribution of \$177,840 to the Plan.

The Plan document also permits the Company to make Qualified Non-Elective Contributions (“QNEC”) to the Plan. For the year ended December 31, 2024, the Company made no QNEC contributions to the Plan.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are vested immediately in their contributions, Company Safe Harbor Contributions, and QNEC's, plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions of their accounts follows the six-year graded vesting schedule below:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

**Investment Options** – Upon enrollment in the Plan, a participant may direct participant contributions to any of the Plan's investment options. Participants may change their investment options at any time.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than two loans outstanding at one time. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest based on the prime interest rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** – The payment of benefits under this Plan to the participant shall begin as soon as administratively feasible. Distributions are allowed in the event of termination of employment, disability, death, and retirement. Also, in-service distributions are allowed in the event of financial hardship or upon attainment of age 59-1/2, and only from fully vested accounts.

A lump-sum distribution is paid to an individual retirement account if the participant's vested account balance is greater than \$1,000 but less than \$5,000 and the participant does not otherwise consent to a rollover or direct distribution in cash. If the participant's vested account balance exceeds \$5,000, the participant must consent to any distribution from their account. A mandatory single lump-sum direct distribution is paid in cash to the participant if the vested account balance is \$1,000 or less.

**Forfeited Accounts** – Forfeited non-vested accounts may be used to pay administrative expenses of the Plan or to reduce any employer contribution. No forfeitures were used to off-set the employer matching contribution or to pay administrative expenses for the year ended December 31, 2024. Forfeited non-vested accounts totaled \$39,997 and \$26,181 as of December 31, 2024 and 2023, respectively.

**Revenue Sharing** – The Plan has a revenue sharing agreement with Empower Annuity Insurance Company of America. The Plan received \$65,575 in revenue sharing credits during 2024, of which \$59,983 was used to pay Plan expenses.

**Excess Contributions Payable** – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

## 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the investment advisor, trustee, custodian, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

**Payment of Benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses directly associated with the administration of a participant's account may be charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### 3. Information Prepared and Certified by the Trustees

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including, but not limited to, investments and participant notes receivable, held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and investment expenses for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, the trustee of the Plan.

### 4. Investment Contract

The Plan invests in a Guaranteed Interest Account ("GIA") provided through a group annuity contract with Mass Mutual. The GIA contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mass Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value; however, the investment contract is subject to certain restrictions which may impact the Plan's ability to fully realize the investment contract's value under certain conditions.

Certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to, a participant termination of employment due to: 1) removal of a group of participants from Plan coverage as a result of temporary absence; 2) change in position or other occurrence qualifying as a temporary break in service under the Plan; 3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or 4) cessation of an employment relationship resulting from a reorganization, merger, layoff, or the sale or discontinuance of all or any part of the Plan sponsor's business. Such events also include: 1) removal from the Plan of one or more groups or classifications of participants; 2) partial or complete Plan termination; or 3) Plan disqualification. As of December 31, 2024, the occurrence of an event outside the normal operation of the investment contract which would cause a withdrawal from an investment contract was not considered probable.

## 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued using the NAV as a practical expedient to estimate fair value as determined by the issuer based on the fair value of the underlying assets within the fund and the present values of future cash flows using the current discount rate.

## 6. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are investment contracts with, or managed by, the trustee of the Plan, which qualified as party in interest transactions. Additionally, certain administrative fees paid to the custodian, trustee and the third party administrator, and loans to participants are also considered party in interest transactions. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

## 7. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## 8. Tax Status

The Plan received a prototype standardized plan determination letter dated June 30, 2020 from the IRS which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"), and will not be receiving a separate determination letter. The Plan has been amended since receiving the determination letter. However, the plan administrator and Plan's management believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan investments include a variety of investments that may directly or indirectly invest in securities with contractual cash flows. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.
