## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants of  
MBL Life Wrap Around Welfare Benefit Plan

### *Opinion*

We have audited the financial statements of MBL Life Wrap Around Welfare Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the financial statements).

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### *Responsibilities of Management for the Financial Statements*

Plan management (Management) is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the ability of the Plan to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the transactions of the Plan that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal controls of the Plan. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by Management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the ability of the Plan to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matter – Supplemental Schedules Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental information in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024, and Schedule of Reportable Transactions for the year then ended, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures

applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the supplemental schedules are fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1 - Plan Description

The following description of MBL Life Wrap Around Welfare Benefit Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

The Plan was established on July 1, 1999 for the purpose of providing the continuation of life insurance, dental, and health benefits to eligible retirees and covered dependents of Mutual Benefit Life Insurance Company (MBL or the "Company"). The Plan's assets are held in a voluntary employee beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Benefits**

The Plan provides health (medical and prescription drugs), dental, and death benefits to eligible retirees and covered dependents, as defined in the plan document. Health, dental, and death benefits are contracted to various insurance companies and service providers under fully-insured and self-insured arrangements. The costs of health, dental, and death benefits are funded by the VEBA and contributions from retired participants. Collection of contributions and the payment of insurance premiums or benefits are handled through the VEBA, the various insurance companies, or the service providers, as applicable.

#### **Contributions**

Pursuant to an agreement between MBL (former Plan Sponsor) and Bank of America (the "Trustee" and current Plan Sponsor), MBL contributed a set amount to fully fund its obligation to the Plan in July 1999, further supplemented by plan design changes and employee contributions in subsequent years. In addition to copays and deductibles, retirees make contributions to the Plan for health, dental, and supplemental death benefit coverage for themselves and their eligible dependents. Contribution amounts are determined periodically by the Plan's actuary based on the retiree's age and position within MBL prior to retirement.

#### **Termination**

While it has not expressed any intent to do so, Bank of America in its capacity as Trustee and Plan Sponsor may terminate, amend, modify, or suspend the Plan and VEBA at any time that it may deem advisable. No amendment shall divert plan funds from the exclusive purpose of paying for the benefits provided.

The Plan may only be terminated upon a determination that plan assets are not sufficient to provide benefits. Before taking any such action to terminate the Plan, the Trustee must obtain an opinion of counsel. Participants will not have any further rights (other than the right to the benefits accrued before the Plan is terminated).

#### **Party-in-interest Transactions**

Certain plan assets are in investment funds managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. These transactions qualify for ERISA statutory exemption 408(b)(4), which permits the investment in bank deposits as long as they pay a reasonable rate of interest.

### Note 2 - Summary of Significant Accounting Policies

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned.

Proceeds from the life insurance program are recorded when received. Proceeds represent the difference between the carrying amount of the life insurance policy and the amount paid to beneficiaries.

***Benefits***

Claims and premiums are recorded when paid.

***Cost of Insurance***

Cost of insurance represents payments to Talcott Resolution Life Insurance Company (Talcott) for premiums under the trust-owned life insurance (TOLI) contract, plus associated premiums taxes and a mortality experience adjustment. To the extent that the benefit obligations incurred are less than the cost of insurance paid, the Plan receives a positive mortality experience adjustment. To the extent that benefit obligations incurred are more than the cost of insurance paid, the Plan receives a negative mortality experience adjustment.

***Claims Incurred but Not Reported***

Claims payable and incurred but not reported as of December 31, 2024 and 2023 are estimated based on claims lags provided by claim administrators. Such amounts are reported in the accompanying statements of benefit obligations at their estimated value.

***Benefit Obligation***

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered through June 30, 1999 (reduced by the actuarial present value of contributions expected to be received in the future from current plan participants). Postretirement benefits include future benefits expected to be paid to or for currently retired employees and their beneficiaries and dependents. The postretirement benefit obligation represents the amount that is to be funded by contributions from participants and from existing plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following were other significant assumptions used in the valuations as of December 31, 2024 and 2023:

### Note 2 - Summary of Significant Accounting Policies (Continued)

For measurement purposes, the assumed annual rate of increase in the per capita cost of health care benefits due to factors other than changes in the composition of the population age and dependency status reflects the expectation of higher future short-term increases in health care costs recognized in 2024 and 2023.

Starting January 1, 2025, retiree medical contributions are expected to equal premiums as billed by the insurance provider as medical coverage is fully insured. There is no longer a liability associated with medical claims and therefore no assumption to value future premiums.

The annual rate of increase for 2024 and 2023 dental costs was assumed to be 3.00 percent per year.

The health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by 1 percentage point, it would increase the obligation as of December 31, 2024 and 2023 by approximately \$112,000 and \$124,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

#### ***Risks and Uncertainties***

The benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Trustee to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 29, 2025, which is the date the financial statements were available to be issued.

#### ***Plan Expenses***

Administrative expenses such as actuarial fees, other professional fees, and certain administrative fees are recorded when incurred and are paid by the Plan, except for certain professional fees that are absorbed by the Plan Sponsor.

### Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

### Note 3 - Fair Value Measurements (Continued)

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### Mutual Fund

The mutual fund is valued at quoted market price reported in active markets.

#### Trust-owned Life Insurance Contract

The TOLI contract is valued at cash surrender value, which approximates fair value, based upon the value of the underlying funds.

### Note 4 - Trust-owned Life Insurance

The Plan invests in a TOLI with Talcott with underlying investments that include mutual funds and separate accounts.

### Note 4 - Trust-owned Life Insurance (Continued)

Talcott imposed charges against the premiums originally paid prior to investing the funds, including a tax for acquisition costs whose deduction was deferred (deferred acquisition costs or DAC). Subsequently, Talcott returns to the Plan, in the form of expense credits, the economic benefit Talcott realizes in the form of a tax deduction on the amortization of the capitalized costs. Such amounts are reflected as a receivable on the statements of net assets available for benefits as Talcott Life DAC Reserve.

The policy involves a mortality-based experience credit. Expected claim costs are deducted from premiums received from retirees and are contributed to a contingency reserve (cost of insurance contributions to the mortality contingency reserve), which is included as an asset on the statements of net assets available for benefits as Talcott Life Mortality Reserve (Mortality Reserve). Mortality claims costs and other adjustments are deducted from this account on a monthly basis to determine whether an experience credit has been earned. Regardless of the mortality contingency reserve balance, death benefits continue to be paid to beneficiaries by Talcott, only a portion of which are funded by the investment balance (cash surrender value). At certain times, the Mortality Reserve could have a zero balance but never below.

As the payments made by Talcott from the mortality contingency reserve do not serve to reduce the net assets available for benefits beyond the mortality contingency reserve, any death benefits paid that exceed the current balance in the mortality contingency reserve are accounted for as other income. The Plan has obligations to ensure participants are paid the full plan amount. On an ongoing basis, the net assets available for benefits are reduced by the cost of insurance, as defined, and are based on sex, attained age, and underwriting class. The cost of insurance rate charged is adjusted based on anticipated experience and cannot exceed the guaranteed maximum cost of insurance rates, as defined.

The Plan has the ability to take a loan against the life insurance policies owned by the Plan to cover the cash flow shortfall during the year. During 2024, loans were made from the investment value of the certificates and decreased the cash surrender value. An amount equal to the loan was transferred from the underlying investments selected by the Plan to Talcott's General Account. General account values are credited with interest at a rate equal to the Adjustable Loan Interest Rate (determined annually), reduced by no more than 1.00 percent. When the value of the loan, including interest, exceeds the value of the insurance policy, the insurance policy is canceled.

In 2024, the Plan took a loan against 10 certificates for \$450,000 and in 2023, the Plan took a loan against 49 certificates for \$768,523. The Loan certificates include insurance policies that have a current investment value of over \$10,000 and excess face amounts (i.e., the insurance policy face value exceeds the retiree's benefit). The loan balance at December 31, 2024 and 2023 was approximately \$7,084,000 and \$6,968,000, respectively.

The value of the TOLI is reported net of the loans. The loans bear interest at a rate of 4.25 percent. As of December 31, 2024 and 2023, the cash surrender value of the insurance policies under loan are greater than the loan value, including interest.

### Note 5 - Tax Status

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the trust's net investment income is generally exempt from income taxes. The trust has obtained a favorable tax exemption letter, dated February 2, 2001, from the Internal Revenue Service, and the Plan Sponsor believes that the trust continues to qualify and to operate in accordance with applicable provisions of the Code.
