Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Amboy Bancorporation 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

(1) Plan Description

The Amboy Bancorporation 401(k) Plan and Trust (the Plan) was established as of January 1, 2003 by Amboy Bancorporation (the Corporation). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

(2) General

The Plan is a participant-directed, defined contribution plan. The Plan provides for growth in savings through contributions and income from investments. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Trust Department of Amboy Bank, a wholly owned subsidiary of the Corporation, has been appointed to act as the Plan's administrator (Plan Administrator). The Plan's recordkeeper, custodian and issuer of the investments is Voya Retirement Insurance and Annuity Company (Voya). The Plan's investments are provided through a group contract with Voya.

(a) Eligibility

An employee of the Corporation or its subsidiary (Amboy Bank) is eligible to participate in the Plan beginning on the first day of month following the date an employee has reached the age of 18 and has completed three months of service, as defined.

(b) Contributions

Participants may contribute up to the maximum allowed by Section 415 of the Internal Revenue Code (IRC). The maximum participant contribution was \$23,000 and \$22,500 in 2024 and 2023 respectively. Catch-up contributions, which are in accordance with IRC, are also permitted for participants who expect to reach or are over the age of 50 by the Plan year-end up to a maximum of \$7,500 for both 2024 and 2023 bringing those participants' statutory maximum contribution limitation to \$30,500 and \$30,000 for 2024 and 2023, respectively. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan has an automatic contribution election provision. The Corporation will automatically enroll the participants into the Vanguard Target Retirement Fund at 3% with annual increase of 1% up to a cap of 6%. Participants may opt out of the automatic election.

The Corporation contributes 50% of participant's contribution up to 6% of eligible compensation. The maximum matching contribution by the Corporation is \$1,000 per participant for 2024 and 2023.

(c) Funding

Employee contributions are funded through bi-weekly payroll deductions and the employer match is deposited bi-weekly.

(d) Plan Investment Options

Participants direct the manner in which contributions made on their behalf are invested in the Plan. Participants may change their investment election in accordance with procedures described in the Plan agreement.

In addition, participants are allowed to transfer amounts between the investment offerings, subject to the Plan's restrictions.

(e) Vesting

All employee and employer contributions are immediately vested.

(f) Payment of Benefits

Distributions of vested benefits normally are made upon a participant's retirement, death, or permanent disability. Distribution of vested benefits may be made to terminated employees prior to the date such amounts would normally be distributed (retirement, death or permanent disability); however, such earlier distribution is at the election of the terminated employee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

A participant who is still an employee may withdraw up to 100% of the employee elective deferral amount and matching contribution because of financial hardship as defined in the Plan agreement.

(g) Participants' Accounts

Each participant's account is credited with the participant's contribution, and allocations of (a) the Company's contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, employee deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

(h) Termination

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

(3) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements of the Plan have been prepared on an accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

(b) Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and charges therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(c) Administrative Expenses

The Plan's expenses are paid either by the Plan or the Corporation, as provided by the Plan document. Expenses that are paid directly by the Corporation are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statements of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation of fair

value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

(d) Valuation of Investments

Investments are reported at fair value, except for fully benefit-responsive contracts which are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see note 5).

(e) Investment Income Recognition

Interest income is recorded on the accrual basis, and dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments represents realized gains and losses and changes in unrealized gains and losses during the reporting period. Purchases and sales of investments are recorded on a trade-date basis.

(f) Distributions to Participants

Distributions to participants are recorded when paid.

(g) Notes Receivable from Participants

Participants may borrow from their vested interest in the Plan. The maximum participant loan is the lesser of \$50,000 (reduced by the excess of the highest balance outstanding during the 12-month period preceding the date of the new loan over the total outstanding balance of all other loans from the Plan to the participant on the date of the loan) or 50% of the participant's vested interest. The loans are secured by the balance in the participant's account. The interest rate for participant loans is equal to 1% above the prime rate, fixed for the duration of the loan. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Participant loans are repaid in equal installments through payroll deductions. Note terms range from one to five years, or greater for the purpose of acquiring a principal residence. Loans may be prepaid in whole at any time without penalty. All principal and interest repayments are re-credited to the participant's account.

(4) Income Tax Status

The Plan uses a non-standardized pre-approved profit sharing plan with CODA, sponsored by CCH Incorporated dba ftwilliam.com, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, stating that the written form of the underlying prototype plan document is qualified under Section 401 of the Code, and that any employer adopting the prototype non-standardized plan is considered to have a qualified plan under the Code and qualify as exempt from taxation. The Plan

administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or de-recognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Certified Investment Information

Certain information disclosed in the accompanying financial statements, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

(6) Fair Value Measurements

The Plan has categorized its financial instruments, based on the priority of inputs to the valuation technique, into a three level fair value hierarchy. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 – Quoted prices for instruments that are similar in active markets, identical or similar in markets that are not active and model-derived valuations for which all significant inputs are observable, either directly or indirectly in active markets; and
- Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and are unobservable.

The fair value hierarchy requires the use of observable market data when available. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurements. The valuation methodologies used for assets measured at fair value are as follows:

Pooled separate accounts: The investments seek maximum real return, consistent with preservation of capital and prudent investment management. Valued by the accumulated unit value (AUV) of the pooled separate accounts. The separate account is valued daily as the number of accumulation units multiplied by the AUV. The AUV is first established when a new fund starts (typically the beginning AUV is \$10.00) and is then determined daily, based on the net asset value (NAV) of shares of the underlying fund, the fund's dividends and the contract's separate account charges. The AUV is provided in the Voya annual audit package or the sponsor website. The pooled separate accounts provide for daily redemptions by the Plan at reported NAV with no advance notice. The fund NAV's are available from the custodian. The contract's daily asset charge (separate account charge) is communicated to plan management in the contract and applicable notice of

change. As of December 31, 2024 and 2023, there were no restriction on redemption and unfunded commitments related to the pooled separate accounts.

(7) Fully Benefit-Responsive Contract

The Plan entered into a fully benefit-responsive guaranteed-interest account contract with Voya. Voya maintains the contributions in a fixed account. The account is credited with earnings on the underlying interests and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed-interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed-interest contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), and (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed-interest contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

(8) Related Party Transactions (Parties-in-Interest)

The Trust Department of Amboy Bank, a wholly owned subsidiary of the Corporation, has been appointed to act as the Plan's administrator. The trustees of the Plan are selected by the Board of Directors of the Corporation and currently include three employees of Amboy Bank.

Certain administrative functions are performed by officers or employees of the Corporation. No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Corporation.

All of the Plan's investments are managed by Voya and therefore, the related investment transactions qualify as party-in-interest transactions.

Additionally, the Plan issues notes receivable to its participants which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Subsequent Events

The Corporation has evaluated all subsequent events through August 20, 2025, the date which these financial statements were available for issuance, and no additional disclosure items were required.
