## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ignite Fueling Innovation, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTE 1 - PLAN DESCRIPTION

The following description of the Ignite Fueling Innovation, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of the Plan Sponsor, Ignite Fueling Innovation, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2024, the Plan was amended to remove the auto-enrollment provision.

#### **Contributions**

*Participant Salary Deferrals* - Participants may contribute up to 100% of their before tax annual compensation, as defined by the Plan, up to a maximum amount established by the Internal Revenue Service (IRS). Participants 50 years or older during the Plan year are eligible for catch-up contributions, up to a maximum amount established by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

*Participant Roth Deferrals* - Participants may designate some or all of their Participant Salary Deferral as a Roth Deferral. Once made, this election is irrevocable (that is, a Participant Roth Deferral cannot later be re-characterized as a pre-tax Participant Salary Deferral). The amount of the Participant Roth Deferral is included in participants' income for tax purposes, and the income tax withholding amounts are deducted from the remainder of compensation, not from the Participant Roth Deferral amount.

*Employer Matching Contributions* - Each Plan year, the Company, at the discretion of the Company's Board of Directors, may make matching contributions as defined in the Plan document. Matching contributions, if made, shall be a percentage of the eligible contributions made by eligible participants and may be limited to a specified percentage of compensation or dollar amount. Participants must be employed at the end of the year and have earned at least 1,000 hours of service in that year to share in allocations of discretionary contributions.

### NOTE 1 - PLAN DESCRIPTION - Continued

#### Contributions - Continued

*Discretionary Nonelective Employer Contributions* - At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, may make discretionary contributions, as defined in the Plan document. Discretionary contributions, if made, are allocated to eligible participants and based upon the percentage of each participant's compensation to the total compensation of all eligible participants. Participants must be employed at the end of the year and have earned at least 1,000 hours of service in that year to share in allocations of discretionary contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their elective deferrals. The Company's discretionary contributions are 100% vested after two years of service, as defined by the Plan. All participants hired prior to January 1, 2012 are 100% vested in all Company contributions.

#### Investment Options

A participant may direct employee contributions in one percent increments or whole dollar amounts among a diversified mix of investment options available to the Plan. Participants invest in the trust fund, which is held by Fidelity Management Trust Company (the Trustee). Fidelity Workplace Services, LLC is the record keeper. Participants may make changes to their investment elections at any time.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of 4.25% to 9.50%, which is commensurate with local prevailing rates and determined by the plan administrator at the time of issuance. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### Payment of Benefits

Benefits commence upon one of several dates: normal retirement, late retirement, date of disability, death, or termination of employment. Benefits are distributed by means of either direct rollover, lump-sum distributions, or by one of various conventional annuity options.

#### **Forfeitures**

Forfeited non-vested accounts are used to reduce Plan expenses or to offset Company contributions. As of December 31, 2024 and 2023, there were forfeited, non-vested accounts totaling \$6,869 and \$2,566, respectively. During 2024, no participant forfeitures were incurred related to withdrawals from accounts that were not fully vested.

#### **Administrative Expenses**

The Sponsor absorbs significant costs of compliance and Plan administration. Certain expenses related to the administration of the Plan were paid directly by the assets of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Concentration of Market Risk**

As of December 31, 2024 and 2023, approximately 25% and 16% of the Plan's net assets were invested in two and one registered investments, respectively. The underlying value of the investments are dependent on the performance of the individual investment holdings and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the registered investments and their investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Fair Value

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Benefits are recorded when paid.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Fidelity Management Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments at fair value and notes receivable from participants, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, interest income on loans, and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, included in the supplemental information.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts would become 100 percent vested in their employer contributions.

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities may occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 - FAIR VALUES**

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 or 2023.

- *Money market funds*: Valued at amortized cost which approximates fair value.
- *Mutual funds*: Valued at the net asset value of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7 - INCOME TAX STATUS**

Effective January 1, 2005, the Plan adopted a non-standardized form of a volume submitter plan sponsored by Ignite Fueling Innovation, Inc. The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities.

The Company has concluded that as of December 31, 2024 and 2023, the Plan had no significant uncertain tax positions or material amounts of unrecognized tax benefits that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

Certain Plan assets are shares of mutual funds which are managed by the trustee, Fidelity Management Trust Company and, therefore, these investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee totaled \$819 for the year ended December 31, 2024. The Company performs all administrative duties for the Plan.
