Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about American United Life Insurance Company Welfare Benefits Plan for Home Office Employees' ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about American United Life Insurance Company Welfare Benefits Plan for Home Office Employees' ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of the Plan

The following description of the American United Life Insurance Company Welfare Benefits Plan for Home Office Employees (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description*, which are available from the Plan Administrator, for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2008 and provides health and other benefits covering all eligible employees of American United Life Insurance Company (Company) and its affiliates and pre-65 Emeritus Agents with a career contract with the Company. In connection with the Plan, the Company established the American United Life Insurance Company Welfare Benefits Trust Agreement for Home Office Employees (Trust). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. UMR, Inc. serves as the third-party administrator. Members of the Company's management serve as Plan trustees. Fifth Third Securities, Inc. serves as the Plan custodian.

Benefits

The Plan provides medical, dental, life, vision, voluntary term life, short-term disability, and long-term disability insurance benefits to eligible employees of the Company, as defined, as well as their eligible dependents. The Plan also provides an HRA benefit, a severance benefit, and the ability to defer in accordance with Section 125. Eligibility for benefits begins on the first day following one full calendar month of continuous employment. In addition, the Plan provides benefits to eligible retirees who have at least ten years of service immediately prior to retirement. Life insurance benefits are no longer available for participants who retire after January 1, 2018.

The Company contracts with a medical clinic to provide on-site medical and prescription services for any regular employee of the Company regardless of whether the regular employee has elected to participate in the Plan. Certain eligible participants of the Plan are also allowed to utilize the medical clinic. Medical expenses incurred by the clinic are included in benefits paid. Administrative fees are also paid to the clinic based upon the number of employees each month.

Contributions

Active and retired participants are required to make monthly contributions to the Plan based on established rates for elected coverages. Company contributions are made to the Plan as necessary to fund claims and expenses not covered by participant contributions. All benefits are administered by a third-party administrator.

Plan Termination

Although it has not expressed intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Method of Accounting

The accompanying financial statements were prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported (IBNR), claims payable and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Cash Equivalents

At December 31, 2024, the Plan's cash accounts exceeded federally insured limits by approximately \$2,800,000.

Benefit Obligations

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to participants' service rendered to December 31, 2024 and 2023, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money and the probability of payment between the valuation date and the expected date of payment.

For measurement purposes, a 7.00% and 6.25% annual rate of increase in the per capita cost of covered health care benefits was assumed for the 2024 and 2023 valuation, respectively. For 2024 and 2023, the rates are assumed to decrease gradually to 5.00% through 2033 and 2029, respectively, and remain at that level thereafter.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

Other Plan Benefits

Plan obligations for accumulated eligibility of participants and for future disability payments to members considered permanently disabled are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statements of plan's benefit obligations at present value, based on a 5.62% and 5.20% discount rate for December 31, 2024 and 2023, respectively. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

Plan liabilities for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

Reinsurance Agreement

Under a reinsurance agreement, health claims in excess of \$300,000 for 2024 and 2023 per participant, including dependents, for the Plan year, as defined are the responsibility of the insurance carrier. Certain participants could have higher limits as established by the policy.

Reinsurance reimbursements from the insurance carrier have been netted against benefits paid on behalf of participants.

Plan Tax Status

The Trust is intended to constitute a voluntary employees' beneficiary association under Section 501(c)(9) of the Internal Revenue Code of 1986. The Plan obtained its latest determination letter on July 13, 2009, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and the related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Benefit Obligations

The Plan's deficiency of net assets compared to benefit obligations at December 31, 2024 and 2023, relates primarily to the postretirement benefit obligation, the funding of which is not covered by the current contribution rate. It is expected that the deficiency will be funded through future increases in the contribution rates for the Company, participants and retirees.

The weighted-average health care cost-trend rate assumption (see Note 2) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point, it would increase the obligations as of December 31, 2024 and 2023, by \$38,653 and \$47,164, respectively. Any future cost increase will be borne by the covered retirees.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan incurs expenses related to general administration and recordkeeping. Life and disability benefits are fully insured by the Company. Dental, vision and certain health benefits are fully insured by other providers. For the years ended December 31, 2024 and 2023, the Plan paid expenses as follows:

Note 6. Risks and Uncertainties

The postretirement benefit obligation and claims payable and incurred but not paid or reported are reported based on certain assumptions pertaining to interest rates, inflation rates, demographics and historical claims-cost data. It is at least reasonably possible that changes in risks in the near term could materially affect amounts reported in the statements of benefit obligations and changes therein.

Note 7. Subsequent Events

Effective January 1, 2025, VOYA acquired OneAmerica's recordkeeping business. This transaction impacted more than 20% of the Plan participants, therefore, this constituted a partial plan termination. Impacted employees are considered terminated from the Company as of this date, and are no longer eligible to participate in the Plan.

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.
