Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aid to the Developmentally Disabled, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

General

The following description of Aid to the Developmentally Disabled, Inc. Retirement Plan's (the Plan) information set forth herein is provided for general information purposes only. Participants should refer to the plan document for more complete information.

The Plan has been amended and restated effective October 1, 2024. The Plan is a 401(k) profit-sharing plan covering substantially all the employees of Aid to the Developmentally Disabled, Inc. dba Rise Life Services (the Sponsor). Employees become eligible to participate on the first day of the following month after completion of six months of service and attainment of age 20 and 1/2. Employees are eligible to participate upon completion of one year of service, or, if earlier, employees work three consecutive 12-month periods, during each of which they work at least 500 hours.

Employees are able to contribute to the Plan up to a maximum amount of the compensation per Internal Revenue Code limits. Once an employee reaches the age of 50 before the end of any calendar year, they may defer extra catch-up contributions into the Plan as a pre-tax and/or Roth contribution once they meet certain plan limits. These catch-up contributions will be eligible for matching contributions by the Sponsor.

Ascensus, LLC (Ascensus) serves as the Plan's record-keeper. Ascensus Trust Company and Newport Trust Company serve as the plan custodians.

Contributions

Employer contributions are a discretionary percentage of participants' compensation. The maximum compensation for any participant is limited to \$345,000 of annual compensation in compliance with 2024 Internal Revenue Service regulations. As of December 31, 2024, there were \$858,450 of employer contributions receivable, which were deposited subsequent to year end. There were no employer contributions receivable of December 31, 2023.

Employees may defer a percentage of eligible compensation as 401(k) elective deferral contributions.

Participant rollover contributions represent transfer of retirement assets from other qualified plans into the Plan.

Participant Accounts

Each participant's account is credited with participant contributions and the employer contributions, if any, and an allocation of net Plan earnings. Such accounts are invested in available investment options in accordance with the Plan provisions. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in employer's contribution portion of their accounts plus earnings is based on years of participation.

Vesting begins in the second year of participation and increases 20% each year until a participant is fully vested after the sixth year. As per the plan document, vesting of all contributions occurs upon an employee's death, total and permanent disability, retirement after age 65, or upon the termination of the Plan by the Sponsor.

Notes Receivable from Participants

Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Payment of Benefits

Under the terms of the Plan, In-service withdrawals are permitted once a participant has attained age 59 ½. Payments of benefits shall be in the form of a lump-sum distribution or a non-recurring partial payment. The distribution method is selected by the participant upon reaching normal retirement age. The amount of benefits is based upon the employee's vested amount included in his/her employer contribution account. Under certain circumstances (hardship), a participant can elect at any time to receive a portion of his or her vested account balance subject to the provisions of the Plan. Participants who take a hardship distribution of deferrals are temporarily restricted from making new deferrals and nondeductible contributions for six months, unless the distribution occurs on or after January 1, 2020.

Forfeited Accounts

If a participant's employment terminates for reasons other than retirement, disability, or death, the unvested portion of his/her account is forfeited either when the vested portion of his/her account is distributed or in other limited circumstances. Forfeitures shall be placed in a suspense account and will be applied to reduce employer contributions or pay for expenses. There were \$7,335 forfeitures including investment earnings for the year ended December 31, 2024. There were \$17,220 of forfeitures used during the year ended December 31, 2024. The unused balance was \$1,196 and \$10,798 as of December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not have any investments which are considered fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis and dividend income is accrued on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expense may be paid by the employer or the Plan, at the Sponsor's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, an agent on behalf of the qualified institutions, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Administrative expenses in the amount of \$14,649 consist of investment management services fees paid to Merrill Lynch Retirement & Benefit and \$20,723 of contract administrator fees paid to Ascensus LLC.

The Sponsor provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. The Plan held no investments classified in Levels 2 or 3 at December 31, 2024 and 2023.

Note 6. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype nonstandardized profit sharing plan with Cash or Deferred Arrangement (CODA) sponsored by Ascensus LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
