### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hilltop Energy, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of

December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hilltop Energy, Inc. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

### Basis for Opinion

### NOTE A - DESCRIPTION OF PLAN

The following brief description of Hilltop Energy, Inc. 401(K) Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan, which began January 1, 2018, is a defined contribution 401(k) profit sharing plan covering substantially all employees of Hilltop Energy, Inc. who have reached 20½ years of age. Employees become eligible to participate upon completion of six (6) months of service. Eligible employees can enter the Plan on the first day of the Plan year or six months later than the first day of the Plan year date. The Plan includes an automatic deferral provision. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

The Plan permits eligible employees to voluntarily contribute up to 60% of annual compensation to the plan through pre-tax salary deferrals subject to annual limits set by law. Participants may contribute up to \$23,000 for 2024 and \$22,500 for 2023 with participants over age 50 eligible to contribute an additional \$7,500 in 2024 and 2023 of deferred compensation earned while a participant under the Plan. In addition, the Company, at its discretion, may contribute a share of its net profits to the Plan as determined by the Company's board of directors.

Rollover contributions from other Plans are accepted, providing certain specified conditions are met.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's discretionary contribution, the Plan earnings and losses and administrative expenses. Allocations of the Plan's earnings and losses are based on the proportion that each participant's account bears to the total of all participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Company's discretionary contributions are allocated based on a percentage of wages to participants who were actively employed on the last day of the plan year and who have at least 501 hours of service during the Plan year. Discretionary contributions made by the Company for the years ended December 31, 2024 and 2023, were \$293,559 and \$265,377 respectively.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Graduated vesting in the employer's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participant profit sharing contributions are 100% vested after three (3) years of credited service.

**Forfeitures**

If a participant is not vested upon termination, the non-vested portion of their account balance contributed by the employer and the earnings thereon are forfeited. Forfeited amounts are first used to reduce administrative expenses with the remaining amounts used to reduce future employer contributions. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$-0-. Plan expenses were reduced by forfeited non-vested accounts for the years ended December 31, 2024 and 2023, in the amounts of \$4,534 and \$12,073, respectively.

**Payment of Benefits**

Upon termination of service, termination of the Plan, termination of employer's business, or upon attainment of age 65 by the participant, a participant may receive a lump sum, partial withdrawals or installments permitted for required minimum distributions under Code Section 401(a)(9). The participant may take an early retirement distribution of all or a portion of their entire vested account at age 59 ½ while they are still employed with the Company. A participant may withdraw all or a portion of any rollover contributions in their account without limit.

**Plan Termination**

Although it has not expressed any intention to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation**

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value by Reliance Trust Company. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. See note E for discussion of contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and 2023 and net change in investment income and expenses for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Plan's trustee, Reliance Trust Company.

**NOTE D - FAIR VALUE MEASUREMENTS**

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 fair value inputs are based on inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs include quoted market prices in active markets for similar assets, quoted prices in markets that are not active for identical or similar assets and other market observable inputs such as interest rate, credit spread and foreign currency exchange rates observable in the marketplace or derived from market transactions.

Level 3 fair values are based on at least one significant unobservable input for the asset. Level 3 securities contain unobservable market inputs and as a result considerable judgment may be used in determining the fair values.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices on the last business day of the Plan year.

In 2022, the Plan entered into a benefit-responsive investment contract with Transamerica Life Insurance Company (TLIC). TLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note B, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 were \$776,556 and \$757,760, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **NOTE F - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

## **NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

Certain parties provide services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. These services are parties-in-interest transactions. The Plan also invested in certain mutual funds which are owned and managed by the Trustee. These transactions also qualify as party-in-interest transactions.

## **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **NOTE I - SUBSEQUENT EVENTS**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through April 15, 2025, which is the date the financial statements were available to be issued.
