We have performed audits of the financial statements of Kasasa, LTD 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. Plan Description

The following brief description of the Kasasa, LTD 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to all of the employees of Kasasa, LTD. (the Company), except for union employees, non-resident aliens, and certain temporary employees that are not eligible to participate in the Plan.

Employees are eligible to make pre-tax and Roth after-tax salary deferral contributions on the first day of the quarter after having attained age 21 and having completed one month of service. Participants are also eligible to receive discretionary matching and discretionary non-elective contributions upon attaining eligibility requirements to participate in the Plan.

Contributions

Participants may elect to defer up to 100% of their annual compensation as defined by the Plan, up to the maximum dollar amounts allowable by law. Participants may also contribute amounts representing distributions for other qualified plans. All employees are automatically enrolled with a 3% deferral contribution once they become eligible for the Plan. At any time, a participant may elect not to contribute or may increase or decrease his or her deferral rate. The Plan may make a discretionary matching contribution for each participant. The Company provided a discretionary matching contribution of 50% of the first 6% of annual eligible compensation for the years ended December 31, 2024 and 2023. The Plan also may make a discretionary non-elective contribution. There were no discretionary non-elective contributions for the years ended December 31, 2024 and 2023. Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's discretionary matching, profit-sharing and non-elective contributions, b) Plan earnings and losses and c) an allocation of administrative expenses paid by the Plan. The Company's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary non-elective contributions are allocated among participants based on eligible compensation. Investments are maintained in individual member accounts managed by Voya Retirement Insurance and Annuity Company (Voya).

Vesting

Participants are immediately vested in their participant contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary non-elective contributions credited to participants' accounts is based on years of continuous service. For participants hired prior to January 1, 2018, a participant vests 25% each year until a participant is 100% vested upon completion of four years of credited service. For participants hired on or after January 1, 2018, a participant is 100% vested upon completion of three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance during the previous twelve months or 50% of their vested account balances, subject to Plan provisions. Notes receivable terms range from one to five years or up to thirty years for the purchase of a primary residence. Notes receivable are secured by the vested balance in the participants' accounts and bear interest at the prime rate plus 1%. Interest rates on notes receivable ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

Payment of Benefits

Upon retirement, termination, disability, death, normal retirement at age 65, or attainment of age 59.5 (for certain in-service distributions), the participant or beneficiary, may elect to receive a lump sum amount equal to the value of the vested funds allocated to the participant's account, or in the case of retirement, periodic installments, as defined by the Plan. Upon termination of employment, the Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 before January 1, 2024) be directly rolled over to an individual retirement designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants may also receive in-service and hardship distributions, as permitted in the plan document. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Company's contributions not then vested shall be forfeited. Forfeitures may be applied to reduce Company contributions, pay administrative expenses, or may be reallocated to participants. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$84,134 and \$87,170, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$212,606 and \$43,006, respectively, were used to reduce Company contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in investment contracts through a guaranteed interest account.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments on the accompanying statements of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 5, 2025, noting no items requiring disclosure.

3. Information Certified by Voya

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Voya, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Valued at the Net Asset Value (NAV) of its underlying investments. The pooled separate accounts include underlying investments in mutual funds which have observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these accounts meet those requirements. The participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis, the accounts are properly categorized as a Level 2 fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Insurance Company

The Plan has entered into an investment contract with Voya. Voya maintains the contributions in pooled separate accounts and a guaranteed interest account. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Voya.

The pooled separate accounts, as reported to the Plan by Voya, are included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Partial Plan Termination

During the year ended December 31, 2024, the Plan sponsor experienced a significant reduction in workforce, which was determined to qualify as a partial plan termination. As a result, affected participants who were involuntarily terminated during the applicable period are deemed to be 100% vested in their account balances, including employer contributions.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.

9. Related-Party Transactions

Certain Plan investments are pooled separate accounts with underlying shares in mutual funds and a guaranteed interest account managed by Voya. Voya is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.
