As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements
December 31, 2024 and 2023

1. Plan Description

The following description of the Lindsay Corporation 401(k) Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan, currently known as the Lindsay Corporation 401(k) Plan and Trust, which was established December 30, 1969, is a defined contribution plan covering the employees of Lindsay Corporation (“the Company”) and the following subsidiaries of the Company: Lindsay Irrigation Solutions, LLC, Lindsay Transportation Solutions, Inc., Elecsys Corporation, Safe Technologies, Inc., and FieldWise LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The 401(k) Committee is responsible for oversight of the Plan, which includes determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Employees hired for short-term or seasonal purposes are excluded from the Plan. However, if an employee is hired for short-term or seasonal purposes, is over age 21, and reaches 1,000 hours of service during the eligibility computation period, the employee becomes eligible. The eligibility computation period is the 12-consecutive-month period beginning on the date of hire and each subsequent 12-consecutive-month period beginning on the anniversary of the date of hire. Effective January 22, 2024, the Plan was amended to extend eligibility to all employees of the employer, with the exception of leased employees. The Plan was also amended to eliminate age requirements, allowing employees to participate immediately upon meeting eligibility criteria.

(b) Contributions

Each year, participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan, not to exceed certain Internal Revenue Service (“IRS”) limitations. Participants can elect to designate some or all of their contributions as after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their account into various investment options offered by the Plan. The Company matched 50% of the first 6% of eligible wages that a participant contributed to the Plan during 2024. The Company may make additional discretionary contributions to the Plan. No discretionary contributions were made during 2024. Contributions are subject to certain IRS limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated target retirement fund until changed by the participant.

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest in the Company's matching and discretionary contributions over a five-year period in accordance with the following schedule:

5 years	100%

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 less the highest outstanding loan balance in the preceding 12 months. The loans are secured by the balance in the participant's account and bear interest at rates that range from 2.00% to 10.50%, which are commensurate with local prevailing interest rates as determined by the plan administrator at the time of issuance. The normal repayment period of a participant loan is 5 years unless such loan is for the purchase of a participant's primary residence, in which case, the loan can be up to 10 years. Principal and interest are paid ratably through monthly payroll deductions. Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(f) Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum distribution or installment payments equal to the value of the participant's vested interest in the participant's account. For termination of service for other reasons or upon reaching age 59 ½, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution. Plan participants are eligible for retirement at age 64 but may elect to retire at a later date. Upon attainment of 64 years of age, death, or determination of disability, a participant becomes 100% vested regardless of the number of credited years of service completed.

(g) Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$95,587 and \$52,695, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. For the year ended December 31, 2024, the amount used to fund employer matching contributions and pay Plan expenses totaled \$218,736.

2. Summary of Significant Accounting Policies

(a) Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses in investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis.

The Plan invests in investment contracts through a common collective trust fund, which is solely invested in the Putnam Stable Value ("the Fund"). Shares of the Fund are valued at the net asset value ("NAV") of shares held by the Plan at year end, which is considered a readily determinable fair value.

There are no reserves against NAV for credit risk of the contract issuer or otherwise. The average yield was approximately 4.22% for 2024.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Administrative Expenses

Plan expenses, including investment advisory fees, audit fees, and legal fees, are paid by the Plan. All administrative expenses paid by the Plan are reflected in the Plan's financial statements.

(f) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Trustee Certification

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA guidelines. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Fidelity Management Trust Company (“Fidelity”), the trustee of the Plan, that information is complete and accurate. Information included in the accompanying financial statements as to investments, notes receivable from participants, dividends, net appreciation in fair value of investments, interest income on notes receivable from participants, and all information in the supplemental schedule are presented in reliance solely upon those certifications.

4. Fair Value Measurements

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability; and
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks and corporate bonds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trusts: Valued at the NAV of units of a collective trust as reported by the investment manager of the trust. The NAV is marked to market daily based on the fair value of the underlying investments held by the fund, minus its liabilities, and then divided by the number of shares outstanding. The Plan has concluded that the NAV as adjusted and reported by the investment manager of the trust denotes readily determinable fair value. The NAV is classified as Level 1 in the fair value hierarchy as the NAV is determined daily and the fund allows units to be sold back to the fund at the end of day NAV. There were no unfunded commitments or redemption restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan has adopted a pre-approved plan document sponsored by Fidelity Management & Research Company that obtained its latest opinion letter on June 30th, 2020, in which the IRS stated that the prototype document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

7. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

8. Subsequent Events

The Plan has evaluated all subsequent events through September 16, 2025, the date the financial statements were available to be issued.
