## Independent Auditor's Report

To the Board of Directors of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Louisiana Organ Procurement Agency Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or within one year after the date that the financial statements are available to be issued when applicable.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters - Supplemental Schedules Required by ERISA**

The supplemental schedule of assets (held at end of year) and schedule of delinquent participant contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1. Description of Plan

The following description of the Louisiana Organ Procurement Agency Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Louisiana Organ Procurement Agency Retirement Savings Plan and Trust is a defined contribution plan and is intended to be a safe harbor 401(k) plan. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

The Plan covers all eligible employees of the Louisiana Organ Procurement Agency (the Company) who have twelve (12) months of service and at least 1,000 hours of service during the 12-month period, subject to break in service rules. An eligible employee may enter the Plan on the first day of each calendar quarter following the date eligibility requirements are met. Effective, July 1, 2024, an employee is eligible to make contributions to the Plan on the first day of each calendar month following two (2) months of service.

#### **Contributions**

Each year, participants may elect to have eligible compensation deferred up to the maximum allowable by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan also allows for Roth elective deferrals. A participant's Roth elective deferral is treated in the same manner as elective deferrals for all plan purposes, except that Roth elective deferrals are separately accounted for, as are gains and losses attributed to those Roth elective deferrals.

The Company will make a safe harbor non-elective contribution on behalf of each eligible participant for the Plan year equal to 3% of the participants' eligible compensation. In addition, the Company may also make discretionary profit sharing contributions determined each plan year. For the year ended December 31, 2024, the Company made a discretionary profit sharing contribution of 2% of eligible compensation.

**Note 1. Description of Plan (Continued)**

**Participant Accounts**

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's safe harbor contribution and discretionary profit sharing contribution, (b) plan earnings (losses), and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, rollovers, and safe harbor contributions, plus actual earnings thereon. Participants automatically become 100% vested in the Company's discretionary profit-sharing contributions and earnings thereon after five years of credited service, at normal retirement age, death, disability, or termination of the Plan.

**Notes Receivable from Participants**

Under the provisions of the Plan Document, participants are not allowed to borrow from their individual accounts.

**Payment of Benefits**

Generally, participants are entitled to receive a benefit upon retirement, disability, death, or upon termination of service. When a participant receives a distribution, the value of the participant's vested account will be determined as of the valuation date that immediately precedes the distribution date. After attainment of 59½, withdrawals can be made from any of the participant's accounts under the Plan.

Upon termination, a participant whose vested account balance does not exceed \$5,000 valued at the time of distribution, will receive an immediate lump sum payment. If no election is made, the Plan Administrator will pay the distribution in a direct rollover to an individual retirement account.

**Forfeitures**

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeited non-vested accounts may be used to reduce employer contributions or to pay for plan administration expenses, as outlined in the Plan Document. During the year ended December 31, 2024, no forfeitures were used to pay plan expenses or to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$54,826 and \$45,836, respectively.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination or partial termination of the Plan, or the complete discontinuance of contributions, the rights of all affected participants to their accrued benefits shall be fully vested and non-forfeitable.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Contributions**

Contributions from plan participants and the contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Tax Status**

The Plan adopted a preapproved plan that received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America provide accounting and disclosure guidance about positions taken by a plan in its tax returns that might be uncertain. The Plan Administrator believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses of the Plan may be paid by the Company or the Plan as provided in the Plan Document. Investment-related expenses are included in net appreciation or depreciation in fair value of investments.

**Note 4. Fair Value Measurements**

The *Fair Value Measurement* Topic of the Financial Accounting Standard Board (FASB) Accounting Standards Codification (ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the market value of the underlying investments as adjusted for the Plan's units of participation in the pooled account. Units are established for each investment division (sub-account) of the pooled separate account. The value of these units is determined at the close of the stock exchange each day and the exchange is open for regular trading. The values increase or decrease based on the investment performance of the corresponding underlying portfolios.

The method described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Risks and Uncertainties**

The Plan invests in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6. Related-Party Transactions and Party-in-Interest Transactions**

The Plan's investments are managed by Standard Insurance Company, the custodian, third-party administrator and investment manager, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**Note 7. Prohibited Transactions**

During 2024, the Plan Sponsor failed to deposit \$186,281 of participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor calculated lost earnings of \$3,167 for these late remittances and will deposit these lost earnings into affected participants' accounts to compensate those participants for potential lost income due to the delays.

**Note 8. Subsequent Events**

The Plan Administrator has evaluated subsequent events through the date that the financial statements were available to be issued, September 26, 2025, and determined that the following event occurred that requires disclosure:

Effective January 1, 2025, the Plan was amended to remove the service requirement for deferrals and safe harbor contributions, and update Plan entry dates. The amendment also added automatic deferral provisions for new hires of 3% of compensation, a last day requirement to receive the profit sharing contribution, hardship distributions, and a participant loan program. Additionally, the safe harbor contribution updated to a match of 4% of participant compensation.

No further subsequent events occurring after September 26, 2025 have been evaluated for inclusion in these financial statements.
