INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MM Packaging Product Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of the MM Packaging Product, Inc. 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed defined contribution plan, under which participants may direct their contributions into various investment options (generally mutual funds) offered by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”). Matrix Trust Company (“Matrix”) serves as the Plan custodian, and Retirement Plan Consultants, LLC (“RPC”) serves as the Plan recordkeeper. The Board of Trustees (composed of sponsor management) is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Eligibility

An eligible employee may participate on the first day of the Plan quarter after their hire date and after reaching age 18. The Plan has no service requirement.

Contributions

Participants may generally defer 100% of annual compensation to a specified limit (\$23,000 per year in 2024 and \$22,500 per year in 2023), as defined in the Plan and by statute. Annual additions to the Plan are also limited to the lesser of annual compensation or a statutory limit (\$69,000 in 2024 and \$66,000 in 2023). Contributions are also subject to other statutory limitations, with certain “catch-up” adjustments also permitted for participants age 50 or older. Participant deferrals of up to 100% of eligible Compensation are permitted, as defined in the Plan document.

The Plan is a Safe-Harbor plan, with a 3% non-elective employer contribution. The Company may also make discretionary Profit Sharing contributions, which are made at the end of the Plan year for eligible participants employed at the last day of the Plan year.

Participants may designate all or a portion of their elective deferrals as Roth elective deferrals.

Rollovers from other qualified plans are permitted.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company Safe Harbor contributions, as well as allocations of the Company discretionary contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, Safe Harbor contributions, and earnings thereon. Vesting in non-Safe Harbor Company contributions and earnings thereon is based on total years of vesting service.

Notes Receivable from Participants

The Plan does not allow for participant loans.

Payment of Benefits

On termination of service due to termination, death, disability, military active deployment, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a continuous right of withdrawal. Participants may also request an in-service rollover withdrawal at any time.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the Plan document. Certain other in-service distributions are allowed upon attainment of age 55.

Forfeited Accounts

Forfeited Profit Sharing contributions may be used to reduce Company contributions or to offset reasonable Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are generally reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determine the Plan's valuation policies based on input from the custodian and recordkeeper. See Note 8 for a discussion of fair value measurements.

2. Summary of Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is reported on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Company paid for certain direct Plan administrative and other expenses, which are excluded from these financial statements. Additionally, Company employees provide certain administrative duties at no charge to the Plan. Certain fees are paid through the Plan for recordkeeping services provided by RPC, for custodian fees assessed by Matrix through RPC, and investment management.

3. Tax Status

The Plan has not obtained a determination letter, but the volume-submitter plan document has received a letter dated June 30, 2020, from the IRC that its form is acceptable under section 401 of the Internal Revenue Code. The Plan has since been amended, but the Plan management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable tax authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Because Plan management believes that the Plan had no taxable income, no income tax returns have been filed for 2024 or prior years.

4. Information Prepared and Certified by Custodian

Plan management has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by the Trustees and was not subjected to any auditing procedures performed by the independent public accountants:

- Investments, cash and cash equivalents
- Net appreciation in investments, and other investment income
- Information presented in the accompanying supplemental schedule

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions (i.e. any non-Safe Harbor contributions).

6. Party in Interest Transactions

Certain Plan investments are managed by Matrix Trust Co, and Plan records are managed by Retirement Plan Consultants, LLC. Matrix generally acts as the Plan custodian and RPC Services is the recordkeeper for the Plan. The Plan pays Plan-related fees to RPC, and RPC handles all necessary Plan-related fee payments to Matrix. The amounts paid to RPC by MM Packaging Product, Inc. qualify as party in interest transactions.

Matrix, RPC, and affiliates thereof can receive 12(b)(1) fees or similar fees from Plan investments for Plan advisory services.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Section 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 from those used in the prior year.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
