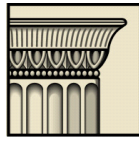

## Independent Auditor's Report

The Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Priority Life Care 401(k) Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in *Note 4* to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting**

As discussed in *Note 1* to the financial statements, the governing body of the Plan approved a plan of liquidation on April 15, 2024, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from going concern basis to liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4i —Schedule of Assets (Held at End of Year) and as of December 31, 2024 for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that

agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following description of the Priority Life Care 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

Effective May 1, 2020, the name of the Plan was changed from National Health Management, Inc. Facilities 401(k) Savings Plan to the Priority Life Care 401(k) Savings Plan.

#### General

The Plan is a defined contribution plan which provides retirement benefits for substantially all employees of the following adopting employers (collectively, the Company):

- Independence Court Associates
- Independence Court of Hyattsville Associates
- Independence Court of Monroeville Associates
- Liberty Court Associates
- National Health Management, Inc.
- Priority Life Care, LLC

An employee becomes eligible to enter the Plan following the attainment of age 18 and completion of one year of service, defined by the Plan as 1,000 or more hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In May 2024, the Plan was partially merged into the Adams Keegan Retirement Savings Plan, excluding participants holding the common collective trust fund due to a one year liquidation holding period. Accordingly, the Plan assets and account balances of participants in mutual funds and pooled separate accounts were transferred into the Adams Keegan Retirement Savings Plan through May 2024. The Plan will liquidate the common collective trust fund in May 2025 and transfer to the Adams Keegan Retirement Savings Plan.

#### Contributions

Participants may contribute up to 100 percent of their annual compensation, as defined by the Plan, or a maximum amount set by law (as periodically adjusted by the Internal Revenue Service) as a pre-tax contribution. Participants age 50 or older are able to make additional catch-

up contributions to the Plan up to the maximum amount permitted by law. The Plan allows for rollover contributions and for eligible participants to make catch-up contributions in accordance with Internal Revenue Service (IRS) regulations. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides a matching contribution in an amount equal to 50 percent of the first 4 percent of the participants' elective salary deferral contributions. The Company may also make an additional matching contribution to eligible participants at the end of the Plan year and/or discretionary contribution during each Plan year. Participants are eligible for a share of the additional matching and/or discretionary contributions if they were an active participant at any time during the Plan year and have 1,000 or more hours of service in the Plan year. There were no additional matching or discretionary contributions made in 2024 or 2023.

In certain circumstances, participants were able to elect to have benefits earned under another eligible retirement plan transferred or rolled over to their account pursuant to this Plan. Additionally, the Plan allows participants to change the amount of their contribution on a quarterly basis or elect to stop contributing on any date.

##### **Investment Options**

Participants can direct that their pre-tax and Company contributions, plus earnings or losses thereon, be invested in any of the participant directed investment options offered pursuant to the Plan. The Plan allows participants to change their investment elections on a periodic basis.

The investments of the Plan consist of diverse portfolios with no significant concentration of risk by issuer, industry, or geographic location.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses), and is charged with his or her withdrawals and certain participant specific administrative expenses and an allocation of other administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Vesting**

Participants are immediately vested in their contributions, including rollovers, and Company contributions, plus actual investment earnings or losses thereon.

##### **Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 but not more than 50 percent of their vested account or \$50,000, reduced by any outstanding loan balance, if any during the one-year period ending on the day before their loan is made, if less. A loan is secured by the balance in the participant's account and bears interest commensurate with rates available for similar loans from commercial lending institutions as determined by the Loan Administrator. Principal and interest are paid ratably through payroll deductions, if available. Each loan shall be repaid over a period not to exceed five years.

##### **Payment of Benefits**

Upon retirement or other termination of employment, distribution of a participant's vested account balance will be made as soon as administratively practicable following their request for distribution. If a participant's vested account balance does not exceed \$1,000, a participant's entire vested account balance shall be normally distributed to the participant (or in the event of the participant's death, his beneficiary) in a lump-sum payment as soon as administratively practicable following the date the participant retires or otherwise terminates from employment.

However, in the event of a mandatory distribution to a participant whose vested account balance exceeds \$1,000 but is equal to or less than \$5,000, if the participant does not elect to have such automatic distribution paid directly to an eligible IRA or other eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the plan administrator shall pay the distribution in a direct rollover to an individual retirement account.

Distributions are normally made in a single lump-sum cash payment. However, a participant with a vested account balance exceeding \$5,000 may elect to receive their distribution in the form of an annuity or installment payments over a period as permitted under the Plan. Other Plan distribution provisions apply in the event of death or disability.

##### **Payment of Benefits (continued)**

The Plan also provides for participant loans as described above and hardship withdrawals. Distributions of benefits are recorded as withdrawals from the Plan and reduction of net assets available for benefits in the period paid to the participant.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and excluded from these financial statements. Plan recordkeeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants and withdrawal and distribution processing fees are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

##### **Plan Termination**

Effective May 2024, the Plan was frozen to further contributions and the decision was made to terminate the Plan. The Plan was amended at that time to be in compliance with the most recent statutory and regulatory changes. All participant accounts were 100% vested as of the date of Plan termination.

#### **2. Significant Accounting Policies**

##### **Basis of Accounting**

As a result of the decision to terminate the Plan, the Plan changed its basis of accounting from the going concern basis of accounting used in presenting the financial statements for the Plan year ended December 31, 2023 to the liquidation basis of accounting used in presenting the financial statements for the year ended December 31, 2024. Under the liquidation basis of accounting, assets are stated at their estimated net realizable values and liabilities are stated at their settlement amounts. There were no changes to assets available to benefits as of December 31, 2023 as a result of the adoption of the liquidation basis of accounting.

##### **Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 5* for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains distributions are included in dividend income.

The Plan includes in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments. Unrealized appreciation or depreciation in the aggregate fair value of investments represents the change in the difference between aggregate fair value and the cost of investments, including reinvestment of earnings. The realized gain or loss on sale of investments is the difference between the proceeds received and the average cost of investments sold.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan origination and annual administration fees are recorded as administrative expenses and are expensed when they are incurred. An allowance for doubtful accounts of \$16,491 was recorded as of December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of

investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### **Use of Estimates**

Preparation of the Plan's financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

##### **Reclassifications**

Certain 2023 amounts have been reclassified to conform with the 2024 presentation.

#### **3. Income Tax Status**

The Plan has received an opinion letter from the Internal Revenue Service stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (Code), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code, and, therefore, believes that the Plan is qualified and the related trust is tax exempt and the Plan has no income subject to unrelated business income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or

asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2021.

#### 4. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments and interest and dividend income for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, the trustees of the Plan.

#### 5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

#### 5. Fair Value Measurements (continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* The fair value of units held in pooled separate accounts are valued at the net assets value NAV as reported by Principal Life Insurance Company. The NAV is based on the value of the underlying investments, minus its liabilities, and then divided by the number of units outstanding. The NAV is quoted on a private market that is not active; however, the unit price of the underlying investments is traded on an active market. The pooled separate accounts have no unfunded commitments as of December 31, 2024.

*Common collective trust fund:* The fair values of participation units in the Principal Stable Value Fund (Fund), a stable value collective trust, are based upon the NAV of units held by the Plan at year-end. The fund provides for daily redemptions by the Plan at reported NAV per unit. The Fund is maintained by Principal Global Investors Trust Company (the Trust Company) and its investment advisor, Morley Capital Management, is an indirect wholly owned subsidiary of Principal Financial Group.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
