## Notes to Financial Statements

### NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Kona Ice, Inc. 401(k) PSP Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan, established on January 1, 2014 and restated on January 1, 2022, is a defined contribution plan covering substantially all employees of Kona Ice, Inc. and Kreations Flavoring, LLC (the "Company"). Employees become eligible upon reaching age 18 and 90 days of service to participate in the Plan. Employees become eligible in non-elective contributions upon reaching age 20 and require completion of one year of eligibility service. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was amended and restated on January 1, 2022.

#### **Contributions**

A participant may contribute up to 100% of eligible compensation on either a pre-tax or Roth after-tax basis. Contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500 for employees aged 50 and over. During 2024, the Company made a safe harbor non-elective contribution of 3% of their eligible salary. The Company may also, in its discretion, elect to make a profit-sharing contribution. Safe harbor contributions totaled \$255,138 for the year ended December 31, 2024. There was a \$50,000 non-elective profit-sharing contribution for the year ended December 31, 2024.

The participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds on a pre-tax basis or Roth after-tax basis. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. A participant may change the amount of his or her elective deferred contributions anytime.

#### **Rollover Contributions**

Participants may rollover to the Plan a distribution they receive from an eligible retirement plan if the distribution qualifies as a rollover amount under the Internal Revenue Service.

#### **Participant Accounts**

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is calculated daily based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

#### ***Vesting***

Participants are vested immediately in their rollover contributions, pre-tax contributions, Roth after-tax contributions and qualified safe harbor contributions made on their behalf, plus actual earnings thereon. Participants vest in Company contributions in accordance with the terms of the Plan. Non-Elective Contributions have a 2 to 6 Year graded vesting condition. Participants are fully vested in Company contributions after 6 years of completing at least 1,000 hours annually. Forfeitures are used to reduce future employer contributions, or to pay the Plan's administrative expenses. During 2024, the Company did not use the forfeiture balance to offset employer match or to offset plan expenses. Forfeited balances remaining in the Plan totaled \$33,676 and \$24,748 at December 31, 2024 and 2023, respectively.

#### ***Payment of Benefits***

Upon a participant's retirement, death, disability, termination of employment with the Company, or termination of the Plan, the participant's account is eligible for distribution in a lump sum or periodic installment payments. If a participant's vested interest is \$1,000 or less, distributions are paid in the form of a lump sum and the payment can be involuntarily distributed, payable as soon as administratively feasible.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

#### ***Administrative Expenses***

Certain plan expenses are paid by the Company and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

#### ***Related Party Transactions***

Certain Plan investments are invested in accounts managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee as defined by the Plan and therefore these transactions qualify as party-in-interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services provided by the employees to the Plan.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Presentation***

The financial statements of the Plan are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the guaranteed investment contract, which is reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and market risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

##### ***Benefit Payments***

Benefit payments are recorded when paid.

##### ***Estimates***

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Subsequent Events***

The Company has evaluated subsequent events through October 1, 2025 which is the date these financial statements were available to be issued.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued using quoted net asset values of the shares as reported by the fund. The funds must publish their daily net asset value and transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 TAX STATUS

The Plan has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020. The letter states the providers' prototype, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2014, the Plan entered into a benefit-responsive investment contract with Empower Trust Company, LLC. Empower Trust Company, LLC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive, and because of this the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan termination and contract termination prior to Empower Trust Company, LLC recovering all start-up costs. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Either party may terminate the contract with at least 60 days advance written notice to the other party.
