### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements the Akron Children's Hospital Retirement Security Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, stating that the certified investment information, as described in Note 8 to the financial statements, which was certified by the Trustees of the Plan, Variable Annuity Life Insurance Company and AIG Federal Savings Bank for the period January 1, 2023 to May 23, 2023, and Fidelity Management Trust Company as of December 31, 2024 and 2023, and for the period May 23, 2023 to December 31, 2024, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Akron Children's Hospital Retirement Security Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**1. Description of the Plan**

The Akron Children's Hospital Retirement Security Plan (the "Plan") is a defined contribution plan that covers substantially all Children's Hospital Medical Center of Akron ("Children's" and "Plan Administrator") employees hired after December 31, 2006. The Plan was established January 1, 2007. Participants become fully vested in the Plan after three years of credited service. Children's has agreed to make discretionary contributions for any participant at least 21 years old, employed on the last day of the year, working a minimum of 1,000 hours and not part of a defined excluded classification of employees. The Plan is 100% funded by Children's. Children's will contribute a percentage of pay based on a combination of age and years of eligible service for every year that the eligible employee remains employed through December 31. The contributions are placed in participant-directed investment accounts. Each participant's account is credited with allocations of (1) the company's contribution and (2) plan earnings, and charged with an allocation of administrative expenses. Children's has the right under the Plan to discontinue such contributions at any time and to terminate the Plan.

The Plan utilizes a third-party vendor (Trustee) to manage the ongoing Plan activities.

The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 ("ERISA").

Should the Plan terminate at some future time, all amounts credited to the participant's accounts shall become 100% vested and shall not be subject to forfeiture. Distribution of the assets will be directed by the Plan Administrator based on provisions in the Plan documents.

Information about the Plan agreement, the vesting and benefit provisions are contained in the *Summary Plan Description* ("SPD"). Copies of the SPD are available from the Human Resources Department at Children's.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Administrative Fees**

Investment management expenses, trustee fees, and other administrative expenses are paid by the Plan. Certain other costs are paid by Children's.

**Investment Valuation and Investment Income**

Investments in mutual funds and money market funds have readily determinable fair values and are measured at fair value in the December 31, 2024 and 2023 Statements of Net Assets Available for Benefits. Fair values of investments in mutual funds and money market funds are based on quoted market prices.

Fully benefit-responsive investment contracts held by a defined-contribution plan are required to be reported at contract value. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses.

Investment income or loss and net realized and unrealized gains and losses are reflected in the Statements of Changes in Net Assets Available for Benefits.

Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported based on historical cost.

**Fair Value of Financial Assets and Liabilities**

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

The framework for measuring fair value is comprised of a three-level hierarchy based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

- Level 1 – inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 – inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Children’s believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

**Payment of Benefits**

Benefits are recorded when paid.

On termination of service due to death, disability, or retirement, or upon reaching the age where minimum distribution rules apply (currently age 73), a participant may elect to receive distributions on their account. For termination of service for other reasons, a participant may receive the value of the vested balance in his or her account as a lump-sum distribution or may leave their account with the Trustee.

**Change of Trustee**

In May 2023 the Plan changed its Trustee from Variable Annuity Life Insurance Company / AIG Federal Savings Bank (“AIG”), to Fidelity Management Trust Company (“Fidelity”). All assets previously held at AIG were moved at that time.

**Subsequent Events**

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

**3. Assets and Liabilities Measured at Fair Value (continued)**

Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Mutual funds: Securities and mutual funds listed or traded on securities exchanges are valued at the closing price on the exchange where the security is principally traded. These securities are classified as Level 1 because quoted prices in active markets are available.
- Money market funds: Money market funds are valued at net asset value ("NAV"). NAV is equal to the market value of each money market fund's investments and other assets, less liabilities, divided by the number of fund shares. These funds are valued at a daily close price as reported by the fund. The funds are required to publish their daily NAV and transact at that price. Money market funds are actively traded and are classified as Level 1.

**4. Guaranteed Investment Contracts**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with AIG and New York Life. The account is maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issued is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issue or otherwise. The crediting interest rates are based on a formula agreed upon with the issuers.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**5. Income Tax Status**

The Internal Revenue Service has determined on March 31, 2008 that the Prototype Non-Standardized 401(a) Profit Sharing Plan, which was adopted by the Plan, is a qualified plan under Section 401 of the Internal Revenue Code ("IRC") and is exempt from tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving this determination. However, the Plan Administrator believes the Plan still complies with the Internal Revenue Service Code Section above.

**5. Income Tax Status (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, and for the years then ended, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Transactions with Parties in Interest**

Fidelity Management Trust Company (“Fidelity”) as current Trustee effective May 2023 and Variable Annuity Life Insurance Company / AIG Federal Savings Bank (“AIG”), former Trustee, receive investment management fees. There are also fees deducted directly from investment earnings of the Plan.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**8. Trustee Certification of Investments**

The following is a summary of unaudited information regarding the Plan, furnished to the Plan and included in the Plan’s financial statements, which was prepared by AIG for the period from January 1, 2023 to May 23, 2023 and Fidelity for the period from May 23, 2023 to December 31, 2024 (the “Trustees”). The plan has obtained certifications from the Trustees as of and for the years ended December 31, 2024 and 2023, that such information is complete and accurate.
