Note 1 - Description of Plan

The following description of Del Zotto Products of Florida 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan, established on January 1, 2020, and most recently amended November 5, 2024, is a defined contribution plan covering all eligible employees, as defined, of Del Zotto Products of Florida, LLC. (the Company or Employer). Effective November 5, 2024, the Plan was amended to change the name of the Company formally known as Del Zotto Products of Florida, Inc. Employees must complete two consecutive months of service to participate in the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute either pre-tax or after-tax Roth deferrals up to 100% of their eligible annual compensation, as defined in the Plan agreement, up to a certain statutory maximum, which is set by law each year. The Plan provides for the automatic enrollment of eligible participants at a deferral rate of 3% of eligible compensation, unless the participant elects a contrary salary deferral rate. Thereafter, employee contributions will automatically increase every year by 1% until the deferral rate equals 6%. Participants may also elect a permissive withdrawal of amounts that are automatically contributed to the Plan, provided the participant requests the withdrawal no later than 90 days following the participant's initial automatic deferral. The Plan allows for certain additional catch-up contributions for employees who have attained age 50 before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company provides a Qualified Automatic Contribution Arrangement (QACA) safe harbor matching contribution equal to 100% of participant salary deferrals that do not exceed 3% of eligible compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation. The Company may also, at its discretion, elect to make a profit-sharing contribution to the Plan each year. A participant must be employed on the last day of the Plan year to be eligible to receive an allocation of the Company's discretionary profit-sharing contribution. A participant may also be eligible for discretionary profit-sharing contributions if, during any time of the Plan year, the participant dies, becomes disabled, or terminates employment as a result of attainment of normal retirement age, as defined. Allocation of the discretionary profit-sharing contribution is based on a participant's eligible compensation at a rate determined by the Employer. For the year ended December 31, 2024, the Employer allocated its contribution at a rate of 1.5% of eligible compensation.

Participant Accounts

Participant accounts are completely self-directed. Each participant's account is credited with the participant's contributions, Company QACA safe harbor matching contributions, and allocations of the Company's discretionary profit-sharing contributions and Plan's earnings and charged with benefit payments and an allocation of the Plan's losses and expenses. Allocations are based on participant earnings or account balances, as defined. Participant transaction fees are charged directly to the accounts of the participants who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their accounts into various options offered by the Plan. Participants may change their investments periodically, as permitted by the Plan sponsor.

Vesting

Participants are immediately vested in their elective deferral and rollover contributions, plus actual earnings thereon. Company QACA safe harbor matching contributions, plus actual earnings thereon, vest 100% after two years of service. Company discretionary profit-sharing contributions plus actual earnings thereon vest over a period of six years as follows:

1 Year	0%
2 Years	20%
3 Years	40%
4 Years	60%
5 Years	80%
6 Years	100%

A participant will also be 100% vested in QACA safe harbor and discretionary profit-sharing contributions upon death, disability, or attainment of normal retirement age, as defined.

Forfeitures

Any non-vested amounts remaining after the distribution of a terminated participant's vested account balance are forfeited. Amounts forfeited by participants may be used to pay Plan expenses or to reduce Company contributions. During the year ended December 31, 2024, forfeitures of \$39,004 and \$17,862 were used to reduce Company contributions and pay Plan expenses, respectively. At December 31, 2024 and 2023, unallocated forfeitures totaled \$26,511 and \$39,476, respectively.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant with a vested balance greater than \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or non-recurring partial payments. If the amount of the participants' vested balance is \$5,000 or less, the Plan will automatically roll the vested account to an individual retirement account (IRA) in a direct rollover if the vested account is more than \$1,000 and the participant did not elect a lump-sum payment or rollover into another qualified plan or IRA. If the amount of the participant's vested balance is \$1,000 or less, it will be distributed in a lump-sum. Hardship withdrawals may be requested and are paid in one lump-sum upon approval. In-service distributions from a participant's vested account balance may be made provided the participant has reached the age of 59 ½.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company. Expenses paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan are included in administrative expenses and certain investment-related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. Transaction fees for distributions are charged directly to the accounts of the participants who incur those fees. Any costs associated with the investment of a participant's account are charged to that participant.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Company has evaluated events and transactions occurring subsequent to December 31, 2024, as of September 30, 2025, which is the date the financial statements were available to be issued. No material events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.

Note 3 - Information Certified by Ascensus, LLC

The following is a summary of the Plan's financial information and data included in the Plan's financial statements and supplemental schedule of assets (held at end of year), which was certified by Ascensus, LLC, an authorized representative of Ascensus Trust Company, the Plan's trustee, as of December 31, 2024, as complete and accurate, as permitted by 29 CFR 2520.103 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 - Fair Value Measurements

The Plan measures and reports its financial assets and liabilities using a three-tier hierarchy, which prioritizes the inputs used in measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies at December 31, 2024 and 2023.

Money Market Fund and Mutual Funds: Valued as determined by quoted market price, which represents the net asset value of shares held by the Plan at year-end. The funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to permanently discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 - Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - Tax Status

The Plan adopted a non-standardized defined contribution pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The opinion letter stated that the Plan was designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the ruling. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Party-In-Interest Transactions

Certain investments held by the Plan are issued by an affiliate of the Plan’s trustee. Transactions related to these investments qualify as party-in-interest transactions. Administrative fees paid to the Plan’s trustee and investment advisor totaled \$21,201 for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.
