(1) Description of Plan

The following description of The J. Reckner Associates, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of J. Reckner Associates, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The 401(k) Committee is responsible for oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Company become eligible to participate in the Plan after the attainment of age 21 and completion of six consecutive calendar months of employment from the employee's employment commencement date and completion of at least 600 hours of service. If an employee does not complete the stated hours of service during the specified time period, an employee becomes eligible to participate upon the completion of one year of service from the employee's commencement date and having completed at least 1,000 hours of service. A participant's entry date into the Plan will be the first day of the Plan year quarter coinciding with or next calendar quarter following the date on which the eligibility requirements are satisfied.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-escalation provision whereby all participants will have their deferral percentage increased by 1% each plan year, to a maximum of 15%, unless they affirmatively elect their deferral percentage at the beginning of each plan year.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 4% of eligible compensation unless they elect an alternate deferral rate or they affirmatively elect not to participate in the Plan.

The Plan includes a discretionary matching contribution. The discretionary matching contribution for 2024 was 25% of eligible compensation up to 6% of participant deferrals. A profit sharing contribution may be made at the discretion of the Company's management. No profit sharing contribution was made for the year ended December 31, 2024.

Contributions, Continued

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations contained in the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution is based on years of continuous service. A participant is 25% vested after 2 years of service, 50% vested after 3 years of service, 75% vested after 4 years of service, and 100% vested after 5 years of service. Regardless of the vesting schedule a participant will become fully vested upon death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from 1-5 years unless the loan qualifies for the purchase of a principal residence. The term of loans for the purchase of a principal residence is a period mutually agreeable to the participant and the plan administrator. The loans are secured by the balance in the participants' account and bear interest at 1% over the prime interest rate. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan may make a distribution of a participant's account balance following severance from employment for participants with balances up to a maximum of \$5,000.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$913 and \$3, respectively. These accounts may be used to pay administrative fees. During 2024, forfeitures in the amount of \$4,258 were used to pay administrative fees.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan and participant level expenses are paid by the Plan and recorded as deductions in the accompanying statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants, distributions and certain investment management fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies and money market fund: Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered investment companies that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective investment trusts: Valued at the NAV of units of a trust company investment trust. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Related Party Transactions and Party-In-Interest Transactions

Peter Reckner is the Plan's trustee and is also a co-owner of the Company.

The Plan invests in a cash account and a money market fund managed by Charles Schwab. Charles Schwab is the custodian as defined by the Plan. CAPTRUST Financial Advisors is a subadvisor on the Great Gray Trust common collective trusts held by the Plan and performs advisory services for the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

The Plan made direct payments to the third-party administrators and other service providers of \$65,646 for the year ended December 31, 2024.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

(7) Tax Status

The Plan uses a plan document and adoption agreement sponsored by Milliman, Inc. The Internal Revenue Service (IRS) has determined and informed Milliman, Inc. by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the plan document has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statement of net assets available for benefits.

(9) Non-Exempt Transactions

During 2024, the Company remitted participant contributions to the Plan's custodian outside of the time period prescribed by the Department of Labor's Rules and Regulations. Required earnings to be allocated to participants on the delinquent contributions will be remitted to the Plan in 2025.
