### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Akron Children's Hospital Retirement Income Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, which was certified by the Custodians of the Plan, Variable Annuity Life Insurance Company and AIG Federal Savings Bank for the period January 1, 2023 to May 23, 2023, and Fidelity Management Trust Company as of December 31, 2024 and 2023 and for the period May 23, 2023 to December 31, 2024 and Talcott Resolution Life Insurance Company, Empower Trust Company LLC; Empower Life & Annuity Insurance Company; and American United Life Insurance Company as of and for the periods ended December 31, 2024 and 2023 is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. **1. Description of the Plan**

The Children's Retirement Income Benefit Plan (the "Plan") is a defined contribution 403(b) plan that covers substantially all Children's Hospital Medical Center of Akron ("Children's" and "Plan Administrator") employees. The current contract through Fidelity Management Trust Company ("Fidelity") was established May 2023. Prior to May 2023 the contract was through Variable Annuity Life Insurance Company / AIG Federal Savings Bank ("AIG") and was established March 3, 1996 and was restated effective January 1, 2006. All prior 403(b) contracts with other vendors (collectively referred to as the "Custodians"), which date back to 1969, are included in the Plan's financial statements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions**

Each year, participants may contribute up to the maximum allowed by current law, which was \$23.0 and \$22.5 in 2024 and 2023, respectively, with additional amounts of \$7.5 in 2024 and 2023, allowed for participants age 50 and older. In addition, there is an additional maximum contribution that is available for employees who have 15 or more years of service of \$3.0 in 2024 and 2023, subject to a lifetime limit of \$15.0. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. Upon reaching one year of service, if in the prior year a minimum of 1,000 hours has been worked, Children's matches participant contributions as follows: Children's contributes 50 percent of the first 4% of base compensation. The Plan allows for Roth contributions. Children's has the right under the Plan to discontinue such contributions at any time and to terminate the Plan.

An employee shall become eligible to participate in the Plan as of the first day of the first full pay period after the date all other eligibility requirements are satisfied.

For employees hired on or after July 1, 2014, new employees automatically contribute 6% into the Plan unless they opt of the Plan or adjust the amount contributed.

**Participant Accounts**

Each participant's account is credited with the participant's contribution of (a) Children's contribution and (b) plan earnings, and charged with an allocation of fund and specific administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

The Plan allows for participants to take loans from their individual vested account balances. The maximum loan amount a participant may take from the plan is the lesser of one-half of vested balance or \$50 reduced by highest outstanding loan balance, if any, during prior twelve-month period with a minimum loan amount of \$1. Participants are only allowed to have one loan outstanding at a time. Notes receivable from participants have repayment terms of 5 years (10 years for principal residence loans) with a fixed interest rate determined by Plan Administrator based on prevailing interest rates at time of loan issuance.

**Vesting**

Participants are vested immediately in their contributions and Children's contributions plus actual earnings thereon.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, or upon reaching the age where minimum distribution rules apply (currently age 73), a participant may elect to receive distributions on both the elective deferral portion and Children's contribution portion of their account. In accordance with Internal Revenue Service ("IRS") regulations, a participant may elect to receive distributions on the elective deferral portion of their account at age 59 ½. For termination of service for other reasons, a participant may receive the value of the vested balance in his or her account as a lump-sum distribution or may leave their account with the Custodians.

Information about the Plan agreement, the vesting and benefit provisions is contained in the *Summary Plan Description*. Copies of the *Summary Plan Description* are available from the Human Resources Department at Children's.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Administrative Fees**

Investment management expenses, custodian fees, and other administrative expenses are paid by the Plan. Certain other costs are paid by Children's.

**Investment Valuation and Income Recognition**

Investments in mutual funds and money market funds have readily determinable fair values and are measured at fair value in the Statements of Net Assets Available for Benefits. Fair values of investments in mutual funds are based on quoted market prices.

Fully benefit-responsive investment contracts held by a defined-contribution plan are required to be reported at contract value. Contract value, as reported to the Plan by the Custodians, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses.

Investment income or loss and net realized, and unrealized gains and losses are reflected in the Statements of Changes in Net Assets Available for Benefits.

Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported based on historical cost.

**Fair Value of Financial Assets and Liabilities**

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

The framework for measuring fair value is comprised of a three-level hierarchy based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

- Level 1 – inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 – inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Children's believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

**Notes Receivable**

Notes receivable from Plan participants are measured at their unpaid principal balance.

Allowances for credit losses are recorded for active participants whose loans have been deemed to be in default by the Plan Administrator, if the Plan Administrator believes the loan balance to be uncollectible. For deemed inactive participant loan balances, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Change of Trustee**

In May 2023 the Plan changed its Trustee from Variable Annuity Life Insurance Company / AIG Federal Savings Bank ("AIG"), to Fidelity Management Trust Company ("Fidelity"). All assets previously held at AIG were moved at that time.

**Subsequent Events**

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Mutual funds: Securities and mutual funds listed or traded on securities exchanges are valued at the closing price on the exchange where the security is principally traded. These securities are classified as Level 1 because quoted prices in active markets are available.
- Money market funds: Money market funds are valued at net asset value ("NAV"). NAV is equal to the market value of each money market fund's investments and other assets, less liabilities, divided by the number of fund shares. These funds are valued at a daily close price as reported by the fund. The funds are required to publish their daily NAV and transact at that price. Additionally, money market funds are actively traded, and are classified as Level 1.
- Pooled separate accounts: Pooled separate accounts are valued at the NAV of shares held by the Plan at year-end.
- Fixed interest accounts: These fixed income accounts are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer and are classified as Level 2.

**4. Guaranteed Investment Contracts**

The Plan has entered into traditional benefit-responsive guaranteed investment contracts with New York Life, AIG, TRLIC, and Empower. The accounts are maintained in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contracts issued are contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

**5. Income Tax Status**

It is the Plan's intention to be organized and operated as tax-exempt under the appropriate sections of the Internal Revenue Code ("IRC"). The IRS does not yet have a determination letter program for 403(b) plans and therefore the Plan has not yet applied for a determination. The Plan Administrator does intend to file for determination once a program has been established. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of and for the years then ended December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
