**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Eye Surgeons of Richmond, Inc. Profit-Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

DECEMBER 31, 2024 AND 2023

### NOTE A - DESCRIPTION OF PLAN

The following description of Eye Surgeons of Richmond, Inc. Profit-Sharing Plan & Trust (the “Plan”) is provided for general information purposes only. For a more complete description of the Plan’s provisions, refer to the document governing the Plan (plan agreement).

#### General

The Plan is a defined contribution plan established effective September 1, 2012. The Plan covers all employees, excluding union members, nonresident aliens, leased employees, employees of any affiliated service group employer who does not adopt this Plan, and employees misclassified as independent contractors of Eye Surgeons of Richmond, Inc. and Virginia Eye Institute, Inc. (collectively the “Company”) who have completed one year of service and are age 21 or older. The Plan requires a participant to be employed as of year end to be eligible to receive employer contributions. The Finance Committee is responsible for oversight of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Finance Committee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### Controlled Group

Under the Internal Revenue Code and ERISA regulations, Eye Surgeons of Richmond Inc. and certain affiliated entities may be treated as a “Controlled Group” for purposes of employee benefit plan compliance. A Controlled Group exists when two or more corporations, trades, or businesses are under common control as defined under IRC §§ 414(b), (c), (m), and (o). These rules require aggregation of employees across related entities for various purposes, including nondiscrimination testing, coverage, and contribution limits.

For purposes of the Plan:

- Employees of any entity that is a member of the Controlled Group will be treated as employees of a single employer.
- Service with any Controlled Group member will be counted for determining eligibility, vesting, and other applicable service-based benefits under the Plan.
- Participation and benefits under the Plan may be affected by this aggregation if an employee has worked for, or is currently working for, any other entity affiliated with Eye Surgeons of Richmond Inc. through common ownership or control.

A list of Controlled Group members, to the extent applicable, is maintained by Management and is available upon request.

#### Contributions

*Employee Contributions:* Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in Vanguard Wellington Admiral Fund Shares until changed by the participant.

*Employer Contributions:* The Company contributes 100% of the first 4% of compensation that a participant contributes to the Plan. As of December 31, 2024 and 2023, the safe harbor match represented \$115,089 and \$95,621, respectively, of the employer contribution receivable.

*Employer Profit Sharing Contributions:* Additional profit-sharing amounts may be contributed at the option of the Finance Committee. For the years ended December 31, 2024 and 2023, the Company approved profit sharing contributions to the Plan of \$936,848 and \$871,704, respectively. Additional discretionary amounts may be contributed by the Company at the option of the Finance Committee. For the years ended December 31, 2024 and 2023, the Company approved discretionary contributions to the Plan of \$405,478 and \$379,669, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, and allocations of (a) Company matching contributions, Company's profit-sharing contributions (when applicable), Company's discretionary contributions (when applicable), and (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20 percent vested after two years of credited service and continues to vest in increments of 20 percent until 100 percent vested after six years of credited service.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The loan interest rate, determined daily, is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through bi-weekly or monthly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments as provided in the Plan document. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of a lump sum cash payment or installments, depending on the balance. In addition, the Plan allows for hardship distributions if certain criteria are met. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

#### Forfeited Accounts

For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,277 and \$12,002, respectively. These accounts will be used to reduce future employer contributions or to pay Plan administrative expenses. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$28,575 and \$17,050, respectively, from forfeited nonvested accounts, in accordance with Plan provisions.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company, as applicable.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) ASC 820 are described as follows:

- Level 2 - Inputs to the valuation methodology include the following:
- Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Cash and money funds:* These investments are stated at cost, which approximates fair value.

*Mutual funds* - Valued at daily closing prices as reported by the Fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds* - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### Payment of Benefits

Benefits paid to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

### NOTE D - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee, State Street Bank & Trust; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. State Street Bank & Trust receives revenue from investment fund service providers for services State Street Bank & Trust provides to the funds. This revenue is used to offset certain amounts owed to State Street Bank & Trust for its administrative services to the Plan.

If the revenue received by State Street Bank & Trust from such investment fund service providers exceeds the amount owed for its services, State Street Bank & Trust remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to State Street Bank & Trust for administrative expenses not covered by revenue sharing. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. Additionally, the Plan pays fees to an outside investment advisor. These transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain fund fees are deducted from investment return.

### NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### NOTE F - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for Plan benefits.

### NOTE H - UNALLOCATED ASSETS

As of December 31, 2024 and 2023, the plan held unallocated assets in the amount of \$36,771 and \$43,165, respectively. These amounts are held in an expense budget account.

### NOTE I - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, State Street Bank & Trust, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### NOTE J - SUBSEQUENT EVENTS

In the preparation of its financial statements, Eye Surgeons of Richmond, Inc. Profit-Sharing Plan & Trust considered subsequent events through September 22, 2025, which was the date the financial statements were available to be issued.
