## Notes to Financial Statements

### NOTE 1 SUMMARY OF ACCOUNTING POLICIES

#### ***Basis of Accounting***

The financial statements of the Applied Mechanical Systems, Inc. 401(k) Profit Sharing Plan (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, pandemic, global conflict and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results may differ from those estimates.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the plan document.

#### ***Expenses***

All fees and expenses of the Plan, to the extent not paid by Applied Mechanical Systems, Inc. and Accuracy in Motion, LLC (the "Plan Sponsors" and "Companies"), are paid by the Plan. Certain investment related expenses are included in the net appreciation (depreciation) of fair value of investments. Fees for the administration of notes receivable from participants and benefits paid to participants are included in administrative expenses and are charged directly to the participant's account.

#### *Related Party Transactions*

Certain administrative functions are performed by the officers or employees of the Companies. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees to the Plan.

#### *Subsequent Events*

The Plan has evaluated events subsequent to the balance sheet date through August 7, 2025 which is the date the financial statements were available to be issued.

### NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a single-employer defined contribution savings plan established by Applied Mechanical Systems, Inc. and Accuracy in Motion, LLC (additional Plan Sponsor and related party company of Applied Mechanical Systems, Inc.). The Plan trustees oversee the governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's trustees. Matrix Trust Company serves as the custodian of Plan assets and Dynamic Pension Services serves as the record keeper. An eligible employee is any person employed by the Sponsors who completed one hour of continuous service, is age 18 or older, and is employed on the next entry date. Eligibility to receive employer matching contributions coincides with the participation eligibility requirements. An eligible employee for non-elective contributions is any person who has completed at least 1,000 hours of service during the Plan year and is employed by the Sponsors on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### *Contributions*

Each year, participants may contribute up to 100% of pretax compensation, as defined in the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. The Plan also includes an auto-escalation provision whereby employees who have been auto-enrolled will have their deferral rate increase by 1% each year up to a maximum of 10%.

#### NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

##### ***Contributions (continued)***

The Sponsors may, but are not required to, make discretionary matching contributions to the Plan. The Sponsors contributed 25% of the first 4% of eligible compensation that Applied Mechanical Systems, Inc. and Accuracy in Motion, LLC participants contribute to the Plan during 2024. Sponsor matching contributions for the year ended December 31, 2024 were \$125,806. The Sponsors may, but are not required to, make discretionary non-elective contributions to the Plan. Sponsor non-elective contributions for the year ended December 31, 2024 were \$1,774.

##### ***Rollover Contributions***

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

##### ***Participant's Accounts***

Each participant's account is credited with the participant's and Sponsor's contributions and a pro-rata allocation of the Plan's earnings and administrative expenses. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Sponsors' discretionary matching and non-elective contributions portion of their accounts plus earnings thereon is based on years of service. Participants' vested interests in Sponsor discretionary contributions increase from 20% after the second year of service to 100% after the sixth year.

##### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by their highest outstanding note balance during the preceding twelve months. Notes receivable must be repaid within five years unless the purpose is to acquire, construct, or reconstruct a principal residence. Each note is secured by the balance in the participant's account and bears a fixed rate of interest of prime plus one percent. Interest rates ranged from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid ratably through weekly automatic payroll deductions.

##### ***Payment of Benefits***

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Companies, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in a lump sum, equal installments, or partial withdrawals.

In-service distributions are permissible for participants that have attained the age of 59½. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits. Participants may also take an in-service distribution from their matching account if they have attained age 55 and have four years of service.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of their account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

##### ***Forfeiture Accounts***

Forfeitures of the Plan are first used to reduce the amount of any legally permitted expenses incurred in connection with the administration of the Plan which are not otherwise paid by the Sponsors. Forfeitures are then used to reduce the Sponsors' future matching contributions. Forfeitures used to reduce the Sponsors' administrative expenses were \$14,281 in 2024. Forfeited nonvested accounts were \$1,451 and \$5,462 at December 31, 2024 and 2023, respectively.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

*Mutual funds and cash equivalents:* Valued using quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Common collective trust:* Valued based on the net asset value (NAV) of units of a collective trust as published by the trustee.

The Plan invests in the Wilmington Trust Collective Investment Trust III for MetLife which is a common collective trust. Common collective trusts are investment funds formed by the pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Common collective trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the SEC (unlike mutual funds, which are registered) and participation is not open to the public. As described above, the fair value of the common collective trust is based on the trust's NAV. The NAV is measured by the custodian or investment manager as of the close of regular daily trading. These investments are classified within Level 2 of the fair value hierarchy. In certain instances, NAV's may require adjustments to reflect the fair value more appropriately. No adjustments to NAV's were required.

The existence of certain conditions can limit the ability of the Plan to transact with participants at fair value of the common collective trust. Specifically, any event outside normal operation of the trust which causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to:

- The Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code.
- The establishment of a defined contribution plan that competes with the plan for employee contributions.
- Any substantive modifications of the Portfolio or the administration of the Portfolio that is not consented by the wrap issuer.
- Any change in law, regulation or administrative ruling applicable to the plan that could have a material adverse effect on the Portfolio's cash flow.

- Any communication given to unitholders by the plan sponsor, any other plan fiduciary or Matrix Trust Company that is designed to induce or influence unitholders not to invest in the Portfolio or to transfer assets out of the Portfolio.
- Any transfer of assets from the Portfolio directly to a competing investment option.

As of December 31, 2024 and 2023, the occurrence of an event outside the normal operation of the fund which would cause a withdrawal from an investment contract is not considered to be probable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
