## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of SouthCoast Medical Group, LLC Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The following description of SouthCoast Medical Group, LLC Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the SouthCoast Medical Group, LLC (the "Company"). Employees who worked at least 1,000 hours within a 12-month period following their hire date and are 18 years or older are eligible to participate on the entry date following completion of one year of continuous service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum percentage allowable of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes an annual non-elective contribution in accordance with the 401(k) safe harbor provisions, and the Company has the option of making a discretionary profit sharing contribution. A participant may direct their elective deferrals and employer contributions into various investment options offered by the Plan.

Participant accounts

An individual account is maintained for each Plan participant. Each participant's account is credited with the participant's deferral contribution, Company's contribution, allocations of Plan earnings and losses based upon individual participant investment elections and charged with an allocation of administrative expenses. Participants direct the investment of their contributions and the employer contributions credited to their account into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contribution plus actual earnings thereon. Participants are also vested in rollover contributions to the Plan. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Payment of benefits

On termination of service due to death, disability, retirement, or other reasons, the Plan provides for a lump-sum distribution equal to the value of the participant's vested interest in his or her account.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account. A participant may not have more than two loans outstanding at any time. The loan interest rate, determined by the plan administrator, is currently set at 2 percent above the prime rate, as defined. Interest rates on outstanding loans ranged from 5.25% to 10.5% at December 31, 2024. Principal and interest are paid ratably over the term of the loan.

Forfeitures

Upon a participant's termination, the unvested portion of the participant's account is forfeited. Forfeitures may be used to reduce the Company's contribution to the Plan or pay Plan administrative expenses. At December 31, 2024 and 2023, unallocated forfeitures totaled \$3,631 and \$3,722 respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$6,826 and \$25,790, respectively, were used to reduce employer contributions. During the years ended December 31 2024 and 2023, no forfeitures were used to pay Plan administrative expenses.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("GAAP").

Investment Valuation and Income Recognition

Investments held by the Plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded based on the ex-dividend date. Net appreciation in the fair value of investments, as reported in the statement of changes in net assets available for benefits, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 3 - Investments

FASB ASC Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3) and distinguishes between observable inputs and unobservable inputs.

The term inputs refer to the assumptions that market participants use in pricing the asset or liability. Observable inputs reflect the assumptions market participants would use in pricing the asset or liability based on market data obtained from independent sources. Unobservable inputs reflect an entity's own assumptions about the assumptions market participants would use in pricing the asset or liability. ASC Topic 820 indicates that valuation techniques should maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value hierarchy prioritizes the inputs used in valuation techniques and creates the following three broad levels, with Level 1 being the highest priority:

Level 1 - Inputs are based upon unadjusted quoted prices in active markets for identical assets or liabilities that are accessible at the measurement date.

Level 2 - Inputs are other than quoted prices included in level 1 that are observable for the asset or liability, either directly or indirectly through corroboration with observable market data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts are based on the quoted market prices of the underlying investments converted into as unit value of the pooled separate accounts.

Common/collective trusts are reported at net asset value (NAV) or alternative fair value methods by the custodian when NAV is not available.

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include the following types of investments:

Interest Bearing Accounts - Interest bearing deposit accounts are stated at fair value, which approximates cost plus accumulated interest earnings to date.

Common – Common stocks are valued at the closing market price reported on the active market where the individual securities are traded.

Corporate Bonds – Corporate bonds are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual Funds - Mutual funds are valued at the quoted net assets value of the shares held by the Plan at year-end. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Terminated Participants with Account Balances

At December 31, 2024 and 2023, accounts for the benefit of persons who have withdrawn from the plan but have not been paid amounted to \$12,973,243 and \$12,095,974, respectively.

Note 5 - Fully Benefit-Response Investment Contracts

The Plan holds an investment in Voya Fixed Account, a traditional investment contract that meets the fully benefit-response investment contract criteria and therefore reported at contract value.

The Voya Fixed Account is a guaranteed investment contract with a fixed account minimum guaranteed interest rate. Voya Retirement Insurance and Annuity Company (VRIAC) makes this guarantee, and although VRIAC may credit a higher interest rate, the credit amount will never fall below the lifetime

VRIAC's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

The underlying contract has no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company (Voya). Voya is also an investment custodian, and, therefore, these transactions qualify as party-in-interest transactions.

Note 6 - Related Party Transactions

Voya has entered into a fee recapture agreement with the Plan which is accounted for through an EASE Account (expense account for service expenditures). The fee recapture agreement provides that Voya will remit to the Plan fees received from investment funds to the extent such fees exceed the amount Voya is due under its service agreement. Under this agreement, during 2024 Voya remitted \$59,200 to the Plan, of which \$22,310 was used to pay Plan operating expenses. During 2023 Voya remitted \$48,584 to the Plan, of which \$20,482 was used to pay Plan operating expenses. At December 31, 2024 and 2023, the balance remaining to be allocated to participant accounts was \$39,239 and \$33,395, respectively.

Note 7 - Plan Termination

The Plan sponsor has initiated plans to terminate the Plan and roll it into the 401(k) plan of the Plan sponsor's support services company. As part of this process, all participant account balances will be distributed or transferred, with assets rolling into the successor qualified retirement plan. The plan termination and asset transfer will be carried out in accordance with applicable ERISA and IRS requirements and are expected to be complete during the year ending December 31, 2025.

Note 8 - Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

As noted in Note 7 - Plan Termination above, the Plan sponsor intends to terminate the Plan and roll all Plan assets into a successor qualified retirement plan during the year ending December 31, 2025.
