Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Doug Smith Autoplex, Inc. 401(K) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following description of Doug Smith Autoplex, Inc. 401(K) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Doug Smith Autoplex, Inc. and its subsidiaries, Doug Smith Spanish Fork, LLC and Doug Smith Kia, LLC (collectively, the Company), who have completed one year of service with at least 1,000 hours and are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

The Plan is a defined contribution plan. Participants may elect to contribute up to 100 percent of annual compensation, not to exceed \$23,000, in 2024, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for the year ended December 31, 2024. Participants may elect whether their contributions are treated as traditional salary deferral contributions deducted from before-tax compensation or as Roth after-tax contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans.

The Company contributes a matching contribution to each participant equal to 50 percent of the participant's elective deferral contribution. Elective deferrals are matched up to 4 percent of the participant's included compensation, limited to a maximum of \$4,500 per participant for the year ended December 31, 2024.

The Company may make discretionary additional contributions each plan year.

Participants direct the investment of their contributions and the Company's matching contributions into various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution and (b) Plan earnings or losses (including appreciation/depreciation in fair value of investments). Each account is also charged with an allocation of administrative expenses. Earnings by the Plan are allocated to each participant based on each participant's balance in the respective funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investment options are participant directed.

Vesting

Participants are immediately vested in their elective deferral and rollover contributions plus actual earnings or losses thereon. Participants vest in the Company's matching and discretionary contributions at the rate of 20 percent per year starting after one year of service, with 100 percent vesting occurring after five years of service.

NOTE A – DESCRIPTION OF PLAN - CONTINUED

Payment of benefits

On termination of service due to death or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, a specified dollar amount each year necessary to satisfy the minimum payment required by law, or a variety of installment options. For termination of service due to other reasons, a participant with a vested account balance of \$5,000 or less will receive the value of the vested interest in his or her account as a direct IRA rollover, unless another election is made. A participant with a vested account balance in excess of \$5,000 may also elect to remain in the Plan without making further contributions. Vested account balances of less than \$500 are distributed directly to participants.

Tax status

Effective January 1, 2022, the Plan entered into an adoption agreement to adopt the Principal Financial Group Prototype for Savings Plans, Amendment No. 4, which amended and restated the former Principal Financial Group Prototype for Savings Plans, which the Plan adopted in 2017. The purpose for entering into this adoption agreement was to amend and restate the Plan to adjust limits on the employer match contribution under the plan. The adoption agreement did not result in any other significant changes to the Plan's provisions.

The Principal Financial Prototype for Savings Plans is a Volume Submitter Profit Sharing Plan with CODA, which has received a favorable opinion letter from the Internal Revenue Service that the plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator believes that no such tax positions have been taken by the Plan. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to examination for years prior to 2021.

Forfeitures

Upon termination of a participant's employment, the non-vested portion of a participant's account shall be forfeited. Any forfeitures occurring during a Plan year may be used to pay Plan expenses and then to reduce employer contributions. At December 31, 2024 and 2023, the balance of net assets included in forfeited nonvested accounts totaled \$0 and \$371, respectively. Employer contributions for the year ended December 31, 2024 were reduced by \$12,483 from forfeited nonvested accounts. Administrative expenses were reduced by \$1,884 from forfeited nonvested accounts for the year ended December 31, 2024.

Administrative expense

All participant transaction and maintenance fees are allocated to participant accounts and are reflected as administrative expense in the accompanying Statement of Changes in Net Assets Available for Benefits. Any other administrative fees are paid for by the Plan sponsor.

NOTE A – DESCRIPTION OF PLAN - CONTINUED

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared on the accrual basis of accounting.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Investments in the pooled separate accounts are valued at the net unit value of the net asset value shares held by the insurance company in a separate account at year end. Net appreciation or depreciation caused by fluctuations in the market value of the investments is reflected in the Statement of Changes in Net Assets Available for Plan Benefits. Transactions are recorded on a trade-date basis. Amounts invested earn interest, capital gains or losses and dividends, which are in turn reinvested.

Fees and administrative expenses

The fees of the Plan administrator are charged against the income of the Plan. The majority of administrative costs required to maintain the Plan are paid by the Employer.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as excess contributions payable at year end, with a corresponding reduction in participant contributions for that year. The Plan distributes the excess contributions prior to March 15th of the following year. The Plan had no excess contributions for the year ended December 31, 2024 or 2023.

The Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, the accompanying notes to the financial statements, and the Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 were prepared in part or entirely from information certified by The Principal Financial Group (Principal), the trustee of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$18,464,456 and \$17,530,709 at December 31, 2024 and 2023, respectively, and related dividend and interest income of \$11,784 and net appreciation in fair value of investments of \$1,966,240 for the year ended December 31, 2024.

NOTE D – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to level 1 measurements and the lowest priority to level 3 measurements. The three levels of the fair value hierarchy are described as follows:

Level 1 inputs include unadjusted quoted prices in active markets for identical assets.

Level 2 inputs include quoted prices for similar assets in inactive markets; quoted prices for identical or similar assets in inactive markets; observable inputs other than quoted prices for identical assets; inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

Level 3 inputs consist of unobservable inputs developed using estimates and assumptions.
