**Note 1 - Plan Description**

The following description of the John I. Haas, Inc. Non-Union 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan that was established effective January 1, 1984, for the benefit of employees of John I. Haas, Inc. and later BetaTec Hop Products, Inc. (collectively "the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2008, the Plan's assets were combined with the assets of the John I. Haas, Inc. Union 401(k) Retirement Plan (the Union Plan) to form the John I. Haas, Inc. Master Trust (the Master Trust).

**Eligibility** - All employees except for non-resident aliens, leased employees, and employees under a collective bargaining agreement are eligible to participate in the Plan upon reaching age 18.

**Contributions** - Participants may elect to defer up to 85% of their compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other eligible plans.

The Plan adopted a Section 401(k) safe-harbor design which means that the Plan automatically complies with certain nondiscrimination requirements of the Internal Revenue Code (IRC). The Company makes safe harbor matching contributions equal to 200% of the participant's elective deferrals up to the first 2% of a participant's eligible compensation, plus 100% of participant's elective deferrals up to the next 1% and 50% of the participant's elective deferrals up to the next 2% of a participant's eligible compensation.

Effective February 1, 2025 the Plan was amended and restated. In connection with the restatement, the safe harbor matching contribution was changed to equal 200% of the participant's elective deferrals up to the first 2% of the participant's eligible compensation, plus, 100% of the participants elective deferrals up to the next 2% of the participant's eligible compensation.

**Change in Asset Custodian and Recordkeeper** - On February 1, 2025, the Plan's changed its recordkeeper from OneAmerica Retirement Services LLC to ADP Retirement Services and changed its asset custodian from Matrix Trust Company to ADP Trust.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are fully vested in their contributions and safe harbor contributions at all times, plus actual earnings thereon. Vesting in employer matching and discretionary contributions accrued prior to January 1, 2018 occurs after the completion of three years of service from the employees' hire date; however, a participant will become fully vested upon death or disability.

**Forfeited Accounts** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$0 and \$2,132, respectively. During 2024, approximately \$2,100 in forfeited accounts were used in accordance with the provisions specified in the Plan document.

**Payment of Benefits** - Upon termination of service, death, retirement, disability, or upon reaching age 59.5, a participant may elect to receive a lump-sum or installment distribution equal to the value of the participant's vested interest in his or her account. The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

**Notes Receivable From Participants** - Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments, including those investments held in the master trust, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses on investments.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Subsequent Events** - The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

**Note 3 - Interest in Master Trust**

The Plan has a divided interest in the Master Trust. The Master Trust records are maintained by each investment fund option. Funds are allocated to the participating plans in accordance with plan provisions and participant allocation elections. The allocation of net assets is based on the respective number of shares or units held by the plans' participants as of year end. The allocation of investment income is calculated daily based on the shares or units held by the plans' participants as of that day's end.

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund - The fund is valued at the NAV of units of the collective trust fund. The NAV is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

**Note 4 - Certified Information**

Certain information in the accompanying financial statements related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

The certification provided by Matrix Trust Company was for the Master Trust rather than a separate certification for the Plan. Therefore, procedures were performed by the auditor related to the allocation of assets and income between the two plans participating in the Master Trust.

**Note 5 - Party-in-Interest Transactions**

One of the Plan's investments is managed by an affiliate of the recordkeeper and, therefore, transactions with this investment are party-in-interest transactions.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 7 - Tax Status**

The Company adopted a OneAmerica Financial Partners, Inc. non-standardized plan document. OneAmerica received an approval letter from the IRS dated August 19, 2020, which states that the form of the plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

**Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 - Delinquent Contributions**

The Company determined there were instances during 2024 in which participant deferral contributions and loan repayments were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$57,650 of deferral contributions and loan repayments were identified as delinquent in 2024. During 2024, the Company restored lost earnings associated with all delinquent contributions.
