We have performed an audit of the accompanying financial statements of Square One Concepts, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Square One Concepts, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan and Trust Agreement (Plan Document) for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan established January 1, 2023, and covers all eligible employees of Square One Concepts, Inc., Bourbon & Bones LLC, Bourbon & Bones San Tan LLC, CB&CB 67DR LLC, CB&CB 7th Street LLC, CB&CB Chandler 50 LLC, CBCB Arcadia LLC, CBCB Ballpark LLC, CBCB Crossroads LLC, CB&CB Higley LLC, 4222 Oldtown LLC, CB & CB Cactus LLC, CB&CB Park West LLC, CBCB Pecos LLC, CB&CB Shea 101 LLC, Shea 116 LLC, F48 Gainey LLC, 7295 Stetson LLC, B&B 83rd LLC, CB&CB Maricopa LLC, CB&CB Tucson LLC, CB&CB Verrado LLC, F48 Gilbert LLC, CB&CB Prasada LLC, B&B Old Town North Annex LLC, CB&CB Euless LLC (collectively, the Company). Employees are eligible to participate in the Plan once they have completed twelve months of service. Plan entry date is January or July 1st following satisfaction of eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Participants may make voluntary salary reductions (participant contributions) up to the maximum amount allowed by the IRS. For 2024 this deferral limit was \$23,000. Participants may also rollover amounts from other qualified plans. Participants over the age of 50 are eligible for catch up contributions. The Plan includes automatic enrollment for newly eligible participants and will start deferring at 6% ROTH of eligible compensation.

The Company may make discretionary matching contributions to the Plan, an amount determined by the resolution of the owner or other governing authority of the Company. During 2024, the Company matched 20% up to the first 5% of salary deferred from its participants. Total matching contributions during 2024 were approximately \$129,000.

*Participant Accounts*

Individual accounts are maintained to record participant contributions, rollover contributions, discretionary matching contributions and earnings thereon for each participant. The benefit to which a participant is entitled is the total benefit, which can be provided from the vested portion of these individual accounts.

*Vesting*

Upon entry into the Plan, participants are 100 percent vested in their salary deferral contributions, rollover contributions and earnings thereon. Vesting for the discretionary matching and earnings thereon is based on years of service as follows:

*Notes Receivable from Participants*

Loans are not permitted by the Plan.

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may request a distribution of their vested account balance from the Plan Administrator. Furthermore, upon approval of the Plan Administrator, participants may be entitled to take hardship distributions. Participants may elect to withdraw all, or a portion of their account while still employed, upon attainment of age 59 ½.

Participants who have terminated employment and have a vested account balance of less than \$5,000 will receive an automatic lump-sum distribution as soon as administratively feasible. These force-out provisions are made in accordance with applicable IRS and DOL regulations. Benefits are recorded when paid.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$19,000 and \$1,000, respectively. These accounts will be used to reduce the employer contributions or pay administrative expenses. During 2024, no forfeitures were used to pay Plan expenses or to reduce employer contributions.

*Amendments*

Effective January 1, 2024, the Plan was amended and restated to add two Participating Employers: F48 Gilbert LLC and CB&CB Prasada LLC.

During 2024, the Plan was further amended to include B&B Old Town North Annex LLC and CB&CB Eules LLC as Participating Employers. Additionally, B&B Lounge LLC ceased participation in the Plan during the year.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Subsequent Event*

Management has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

*Basis of Accounting*

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Fair Value Measurements*

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Administrative Fees*

All expenses of maintaining the Plan are paid out of the Plan assets or by the Plan Sponsor. Investment-related expenses are included in net appreciation of fair value of investments.

*Market Risk*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 – CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), a qualified institution.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**NOTE 4 – FAIR VALUE MEASUREMENTS, CONTINUED**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Cash and equivalents:* Cash consists of cash on deposit with banks. Cash equivalents represent money market funds or short-term investments with original maturities of three months or less from the date of purchase, except for those amounts that are held in the investment portfolio which are invested for long-term purposes. Cash and cash equivalent are valued at fair value, which approximates cost basis.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the preapproved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

John Hancock held the Plan's assets and performed the record-keeping. Hunnex & Shoemaker performed Plan administration. Investment advising is performed by Phocus Retirement Services. Therefore, any investment or administrative fees paid during the year to these parties qualify as party-in-interest transactions.

**NOTE 8 - DELINQUENT CONTRIBUTIONS**

During 2024, the Company remitted employee contributions for several pay periods after the date required during the year by the Department of Labor. The Company will calculate and contribute lost earnings in 2025.

**NOTE 9 – SECURE 2.0**

The SECURE 2.0 Act of 2022 introduces several changes to qualified retirement plans, with various implementation dates ranging from 2023 to future years. Key provisions include enhanced catch-up contribution limits for participants ages 60-63 (effective 2025), requirements for higher income participants to direct catch-up contributions to Roth accounts (effective 2026), increases to required minimum distribution ages (phasing up to age 75), and the option to increase the automatic rollover threshold for force-out distributions from \$5,000 to \$7,000.

The Plan Administrator is currently evaluating these changes to determine which optional provisions may benefit plan participants. Any required amendments will be implemented by their respective deadlines, and participants will be notified of adopted changes that affect their accounts or options under the Plan.
