Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Creek Enterprise 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Creek Enterprise 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE:

1. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Creek Enterprise 401(k) Plan (the Plan) are prepared under the accrual method of accounting.

Investments – Investments are reported at fair value, except for the fully benefit-responsive annuity contract, which is reported at contract value (see Note 10). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions – Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – Administrative expenses in the amount of \$15,177 are shown on the Statement of Changes in Net Assets Available for Benefits. This amount represents administrative costs paid to third party service providers for financial advisory, legal consultation, and recordkeeping services.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statement of net assets available for benefits.

Subsequent Events – The Company has evaluated events and transactions that occurred through August 29, 2025, which is the date the financial statements were available for issue.

2. Plan Description

The following description of the Creek Enterprise 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – Effective January 1, 2013, Creek Enterprise (the Company), adopted the Plan which is a defined contribution Plan covering substantially all employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees of the Company who have attained the age of nineteen, have completed three months of service, and are not union, leased, or non-resident aliens are eligible to participate in the Plan. Entry dates are the first day of the month following the attainment of the age and service requirements.

NOTE:**2. Plan Description (Continued)**

Contributions – Contributions to participants' accounts may be made through voluntary reductions in their compensation, rollover contributions from other qualified plans, as well as safe harbor and discretionary employer matching. Employees participating in the Plan may contribute up to 100% of their before-tax compensation up to the limit in effect for the year (\$23,000 in 2024). Participants aged fifty or older may make an additional "catch-up" contribution (\$7,500 for 2024). The Company matched 100% of employee deferrals up to 4% of their pay. Additional amounts may be contributed at the option of the Plan's Board of Trustees. All employer contributions are invested in the investment options as directed by the participants.

The Plan includes an automatic salary deferral feature, which enrolls newly eligible employees at a set pretax deferral contribution rate of 3% on their entry date, unless they elect otherwise. The automatic deferral provisions apply to all participants who become a participant in the Plan after the effective date of the automatic deferral provisions.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the (a) employer's contribution, (b) plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions are invested based on participant-directed investment programs.

Investment Options – Participants' accounts are self-directed within a limited number of investment options offered by the Plan. Participants may change their investment elections at their discretion.

Vesting – Participants are immediately 100% vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. Vesting in the portion of the accounts funded by discretionary matching contributions and profit sharing contributions plus earnings thereon is based on years of continuous service according to the following schedule:

1 year	25%
2 years	50%
3 years	75%
4 or more years	100%

Forfeitures – As of December 31, 2024 and 2023 forfeited non-vested amounts totaled \$22,975 and \$22,876, respectively. These amounts will be used to offset future administrative expenses or employer contributions. For the year ended December 31, 2024, employer contributions were reduced by \$9,635 from forfeited accounts.

Payments of Benefits – Participants or their beneficiaries may receive distributions of their account balances in a lump sum upon the earlier of reaching age 59 1/2, permanent disability, death, or termination of service, as defined in the Plan. If a participant's vested balance is less than \$5,000, the balance will be distributed in a lump-sum amount, regardless of consent to receive it. Further, the Trustee may permit a participant who experiences a qualified financial hardship, as defined by the Plan, to receive a distribution of all or a portion of the participant's elective account balance.

Notes Receivable from Participants – Participants may borrow from their fund accounts in an amount equal to the lesser of \$50,000 or 50% of their vested account balance. No loans will be issued for less than \$1,000. The loans are secured by the balance in the participant's account and bear interest at a rate determined to be reasonable based upon similar loans offered by other lenders. Principal and interest are paid through payroll deductions.

3. Parties in Interest and Related Parties

Certain Plan investments are managed by United of Omaha Life Insurance Company and Ascensus, LLC, and therefore, these transactions are considered to be party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative costs incurred by the Plan are paid by the plan sponsor. The Plan uses the staff, resources, and facilities of the plan sponsor to perform certain administrative activities related to the Plan. These transactions qualify as party-in-interest transactions. Participant notes receivable are classified as both related party and party-in-interest transactions.

4. Tax Status

The underlying standardized volume submitter plan has received an opinion letter from the Internal Revenue Service dated September 21, 2020, stating that the form of the document is acceptable under Section 401(a) of the Internal Revenue Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

5. Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Certification of Financial Information

The following information included in the accompanying financial statements and supplementary schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company: cash and cash equivalents, investments, notes receivable from participants, interest and dividends, and net appreciation in fair value of investments.

7. Non-Participating Participant Account Balances

Included in the net assets available for benefits at December 31, 2024 and 2023 are balances due to participants who had terminated employment with the employer and, therefore, are no longer participating. These accounts are payable on request.

8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable input (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are op-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: The fair value of participation units held in common/collective trust funds are based upon their net asset values as reported by the managers of the common/collective trust funds and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date.

Pooled Separate Accounts: Investments in shares of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value of shares held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Fully Benefit-Responsive Annuity Contract

The Plan entered into a fully benefit-responsive investment contract with Mutual of Omaha. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. As of December 31, 2024, and 2023, the contract value of the fully benefit-responsive investment contract was \$0 and \$163,083, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or a merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the contract issuers and with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

10. Subsequent Events

Effective July 18, 2025, the Plan entered into a custodial agreement with Ascensus Trust Company. A blackout period occurred from July 16, 2025 to July 21, 2025 in order to transfer assets to the new custodian.
