NOTE TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of The Everglades Club, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan, which was originally adopted in January 1, 1998, and restated January 11, 2021, is a defined contribution plan covering all eligible employees of The Everglades Club, Inc. (“the Company”) who have six months of service and are twenty-one years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan amendment – In November 2024 a change to the Plan’s Trustees was made.

Contributions- For 2024, participants could contribute up to \$23,000, with an additional \$7,500 for participants who reach age 50 during the calendar year, for a total of \$30,500 of their pretax annual compensation as defined by the Plan. Participants can also elect a direct rollover of an existing balance from a tax qualified retirement or savings plan into the Plan.

The Company has elected to make safe harbor matching contributions to the Plan equal to 100% on the first 6% of the participant’s compensation. Participants must have made elective deferrals to the Plan in order to receive the matching contributions, which will be remitted each pay period. The annual contribution from all sources to a participant’s account may not exceed the lesser of \$69,000 (\$76,500 including catch-up contributions), or the participant’s annual compensation during the plan year.

Employer matching contributions for 2024 were \$717,587 which includes a qualified non elective contribution of \$178,171.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s matching contributions, (b) Plan earnings and losses, and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options -A participant may direct the Trustee on how to invest any portion of his or her elective deferrals, rollover contributions and employer contributions. Available investment options may change at any time. Participant investment options at December 31, 2024 and 2023 include funds with a variety of mutual funds, common-collective trust funds and a stable value fund. Participants may change their elections at any time at the option level. One of the mutual fund options includes a Guaranteed Minimum Withdrawal Benefit (GMWB), also known as a Guaranteed Lifetime Withdrawal Benefit (GLWB) via a variable annuity. The investment is structured as either a portfolio of lifetime asset allocation funds target date or a balanced fund and the participant can elect a target date fund that mostly closely corresponds to their retirement age based on their birth year.

Vesting - Participants are fully vested for all contributions from both the employee and employer, regardless of years of service.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are only allowed to have a maximum of two loans outstanding at any time. Upon a second loan, the \$50,000 amount is reduced by the highest outstanding loan balance during the past twelve months, or any existing loan balance on the date a new loan is made, whichever is greater. Notes are secured by the balance in the participant’s account. The interest rate is fixed for the life of the loan at a rate of 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Notes are generally required to be repaid within five years unless the purpose of the note is to acquire a primary residence, in which case it is required to be repaid within 15 years.

NOTE TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits – Upon termination from the Company, a participant's account balance of \$5,000 or less will immediately be distributed. The Plan also allows for in-service distributions for those who reach age 59 1/2, experience hardship, or for deemed severance distribution. For participants whose vested account balance exceeds \$5,000, he or she can have a payment in lump-sum or in installments.

Forfeited Accounts - Forfeited nonvested accounts are used to reduce the employer contributions and Plan expenses. During 2024, \$8 of forfeited funds were used to pay administrative expenses. Forfeited nonvested accounts totaled \$49 and \$57 at December 31, 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the stable value fund, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for the investment in the guaranteed interest account because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as deemed distributions based on the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common - Collection Trust: Stated at fair value as determined by the issuers of the funds on the fair market value of the underlying investments, which is valued at net asset value ("NAV") as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Mutual Funds: Also known as registered investment companies, which are valued at quoted market prices on the last business day of the Plan year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the years ended December 31, 2024 and 2023, there were no transfers of financial instruments into or out of Level 1 or 2. The Plan had no Level 2 or 3 measurements during the years ended December 31, 2024 and 2023.

The Investment strategy of the International Equity Fund Fee Class R1 is to generate long-term growth.

NOTE 5 – INVESTMENTS AT CONTRACT VALUE

Investments at contract value consist of the Stable Value Fund Fee Class R1, an investment option, which is a guaranteed interest account that offers a guaranteed minimum interest rate and a return on principal. Participant account balances are credited daily with interest and participants have daily liquidity at full book value (principal and interest) for all participant initiated events. Interest rates averaged approximately 3.84% and 3.6% for 2024 and 2023, respectively. At December 31, 2024 and 2023 the balance in the Stable Value Separate Account was \$1,090,357 and \$782,022, respectively.

NOTE 6 – RELATED PARTY TRANSACTIONS

The Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC provide recordkeeping, Plan management, and day-to-day support to the Plan, therefore these transactions qualify as party-in-interest.

Contract administrator fees paid by the Plan amounted to \$57,564 for the year ending December 31, 2024. These fees are included in administrative expenses for the year ended December 31, 2024.

The Everglades Club, Inc. is the Plan Administrator and Sponsor of The Everglades Club Inc. 401(k) Plan. These transactions qualify as party-in-interest transactions. Certain key personnel are also considered parties-in-interest due to ownership and administrative rights over the Plan. The Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 – TAX STATUS

The Plan is structured and follows a volume submitter profit sharing plan, pre-approved by the IRS. The IRS issued an opinion letter dated November 14, 2022, that the volume submitter plan is acceptable in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and related trust is tax-exempt.

NOTE TO FINANCIAL STATEMENTS

NOTE 8 – TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to examinations for three years.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
