Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sugar Cane Growers Cooperative of Florida 401(k) Plan (formerly the Sugar Cane Growers Cooperative of Florida Retirement Savings Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

December 31, 2024 and 2023

(1) Description of Plan

The following description of the Sugar Cane Growers Cooperative of Florida 401(k) Plan (formerly the Sugar Cane Growers Cooperative of Florida Retirement Savings Plan) (the Plan) is provided for general informational purposes only. Plan documents should be referred to for a complete description of the Plan's provisions.

(a) General Information

The Plan is a defined contribution plan covering all eligible employees of Sugar Cane Growers Cooperative of Florida (Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective August 1, 2023, the Plan was amended and restated as the Sugar Cane Growers Cooperative of Florida 401(k) Plan under a prototype plan provided by Fidelity Management and Research Company with substantially the same provisions as the previous plan document, except as described in the following notes. The Plan's Trustee is Fidelity Management Trust Company (Fidelity). Fidelity also serves as recordkeeper for the Plan. Prior to August 1, 2023, the Plan's trustee was Reliance Trust Company and the recordkeeper was Ingham Retirement Group.

(b) Eligibility

All employees age 20 and over (20-1/2 and over prior to August 1, 2023) with 6 months of service are eligible to participate in the Plan. Employees are eligible to enter the Plan on the first day of the month (quarter prior to August 1, 2023) after meeting these requirements.

Effective August 9, 2024, the Plan was amended to provide for auto enrollment of participants with a 4% pre-tax deferral.

(c) Contributions

Employees may make pretax voluntary contributions of up to 100% of their eligible annual compensation, as defined in the Plan Agreement, subject to certain IRS limitations. Effective August 1, 2023, the Plan also allows employees to elect Roth after-tax contributions. For 2024 and 2023, individual participant contributions were limited to \$23,000 and \$22,500, respectively. Participants who are age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions for other qualified defined benefit or defined contribution plans (rollovers).

The Employer made Safe Harbor Non Elective contributions for all eligible participants equal to 3% of qualified compensation for 2024 and 2023.

In addition, the Employer may make discretionary contributions to the Plan. For 2024 and 2023, the Employer has matched 50% of the first 6% of such participant's contribution based on the annual qualified compensation, except the Employer set matching contributions for employees hired before January 1, 2006 and in the following age groups on December 31, 2005 as follows:

<u>Age Group</u>	<u>Employer Matching</u>
50 – 54	66.75% of the first 6% of annual compensation
Over 55	100.00% of the first 6% of annual compensation

(d) *Participant Accounts*

Each participant's account is credited with the employee's contributions, the Employer's contributions and the employee's pro rata share of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Participants elect to invest their contributions and the Employer's contributions in a variety of investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) *Vesting*

Participants are immediately vested in their voluntary contributions and the Employer Safe Harbor Non Elective contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested at the normal retirement age of 65, death, disability and after three years of credited service.

(f) *Notes Receivable from Participants*

Effective August 1, 2023, participants may borrow from their fund accounts in an amount of not less than \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at any given time. All loans have a definite repayment period, not to exceed 5 years, or 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest rates at 8.75% to 9.5% during 2024 and 9.5% during 2023, which was commensurate with rates charged for similar types of loans by other lenders as determined by the plan administrator. Loan repayments are made by direct participant payments and as loans are repaid, the repayments are re-invested in the participant's investment accounts.

(g) *Payment of Benefits*

Upon termination of employment a participant is eligible to be paid a lump sum benefit equal to the vested portion of the participant's account. Participants may also withdraw certain amounts from the Plan under in-service withdrawal (upon attaining age 59 1/2), disability, and under hardship withdrawal provisions.

(h) Forfeitures

Forfeitures of nonvested employer contributions may be used to reduce the contributions by the Employer or other Plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$90,739 and \$42,060, respectively. During the year ended December 31, 2024, employer contributions were reduced by \$17,478 from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies**(a) Basis of Accounting**

The Plan's financial statements are prepared using the accrual basis of accounting. Employee and employer contributions are recorded in the period in which contributions are withheld from salaries and wages by the Employer.

(b) Investments

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation includes realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on investments held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(c) Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Administrative Expense

Certain expenses of Plan administration have been paid by the Employer and are not reflected on the accompanying financial statements.

(f) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(3) Certified Investments (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and interest and dividends, and net appreciation (depreciation) in fair value of investments for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity as of December 31, 2024 and 2023, for the year ended December 31, 2024, and for the period of July 31, 2023 through December 31, 2023, and by Reliance Trust Company as of and for the eleven months ended November 30, 2023.

Investments, which are participant-directed, amounted to \$40,020,519 and \$37,005,813 as of December 31, 2024 and 2023, respectively. See note 4.

(4) Fair Value of Investments

The Plan adopted the provisions of the Fair Value Measurements and Disclosures Topic of the FASB ASC, which established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts – Valued based on observable inputs, viewed as having a Readily Determinable Fair Value (“RDFV”) since they have published prices from the investment firms.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) *Party-in-Interest Transactions*

Certain Plan investments are shares of mutual funds managed by Fidelity, Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan paid administrative expenses to Fidelity for investment management services.

Prior to August 1, 2023, Reliance Trust Company, as the Plan's trustee, used the clearing firm, National Financial Services, a subsidiary of Fidelity Investments Institutional Group (Fidelity), to process all of its transactions. Fidelity provides custodian and brokerage services to the Plan, and therefore, these transactions qualify as party-in-interest transactions. In addition, the Ingham Group was the Plan's third party administrator and registered investment advisor. As such, they were a fiduciary of the Plan and all investment transactions were considered to be transactions with a party-in-interest.

(6) Federal Income Tax Status

Effective August 1, 2023, the Plan has adopted a prototype plan provided by Fidelity Management and Research Company (previously a prototype plan provided by Ingham Retirement Group), which was established pursuant to provisions of the Internal Revenue Code (IRC) and ERISA. A favorable tax determination letter dated June 30, 2020 has been received from the Internal Revenue Service indicating the Plan qualifies under Section 401(a) of the IRC and the trust is exempt from income taxes under Section 501(a) of the IRC. Accordingly, no provision for income taxes has been recorded in the accompanying financial statements. The Plan administrator believes the Plan has operated under the terms of the Plan document and therefore the Plan remains qualified.

The Plan is subject to routine audits by various taxing jurisdictions. The Plan's open audit periods are 2021 through 2024.

(7) Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to discontinue contributions at any time and to terminate the Plan subject to provision set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

(8) Risks and Uncertainties

The Plan invests in various investment funds that are subject to various risks that determine the value of the fund. Due to the level of risk associated with certain financial instruments and the level of uncertainty related to changes in the value of these investments, it is reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

(9) Subsequent Events

In preparing these financial statements, management has evaluated subsequent events and transactions for potential disclosure through October 1, 2025, the date the financial statements were available to be issued, and has determined that there are no such significant events or transactions.
