Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of The Capital Tire Group Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Note 1 - Plan Description

The following description of The Capital Tire Group Profit Sharing and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. Copies of the agreement are available from the plan administrator.

General

The Plan is a defined contribution plan adopted on December 31, 1971 for Capital Tire Group (the "Employer") and was restated as of January 1, 2019. As of January 1, 2019, the Plan covers all employees who are 19 years of age or older and have achieved 60 days of service. The Plan covers employees of Capital Tire, Inc. and Pro Tire, Inc. (collectively, the "Companies"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Contributions to the Plan by the Companies are determined solely by their boards of directors and may be in the form of discretionary or matching contributions. No discretionary profit-sharing contributions were made for the 2024 and 2023 plan years.

Beginning on January 1, 2023, Capital Tire, Inc. contributed an employer matching contribution equal to 50 percent of deferrals, not to exceed 6 percent of employees' compensation. To be eligible for the employer matching contribution, employees must be 19 years of age or older and have achieved 60 days of service.

Also in 2023, the Plan added an automatic enrollment feature in which eligible employees are automatically enrolled in the Plan with a deferral rate of 6 percent. Employees have 30 days to opt out of this automatic enrollment feature.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the profit sharing portion and employer matching portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Companies 20 percent after two years of service and an additional 20 percent per year thereafter until they become fully vested after six years of service. Participants are also fully vested upon reaching the normal retirement age of 65 while employed.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Note 1 - Plan Description (Continued)

Benefit Payments

At the time a participant is entitled to receive a distribution under the Plan, the participant can elect to receive a lump-sum distribution equal to the value of his or her account or elect to receive installments over a period of time specified in the plan agreement. Participants are also permitted to take in-service distributions of all contributions upon the attainment of age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Allocations of forfeitures may be used to pay plan expenses or may be considered additional company contributions and are subject to the vesting provisions of company contributions. If the Companies allocate forfeitures to participants, they are based on the participant's compensation, as defined.

Party-in-interest Transactions

The Employer paid certain administrative expenses of the Plan during the years ended December 31, 2024 and 2023, which qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. Additionally, the Plan allows participants to invest in a self-directed brokerage account. The self-directed brokerage account is primarily made of various investments in publicly traded securities valued at quoted market prices. The self-directed brokerage account also allows for participants to hold interest-bearing cash valued at fair value based on outstanding balance. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative costs are paid by the Companies and the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Empower Trust Company, LLC (the "Trustee") holds the Plan's investments, other than the self-directed brokerage account, and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year, except for those noted below, are based solely on information certified by the Trustee.

The Plan's investments in the self-directed brokerage account totaled \$590,275 and \$564,115 at December 31, 2024 and 2023, respectively, and related investment income of \$27,619 and \$104,636 for the years ended December 31, 2024 and 2023, respectively, were not certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
